### Report on the Audit of the Financial Statements



**NOTE 1 DESCRIPTION OF PLAN**

The following description of DecoPac, Inc. (Company) Employee Retirement and Trust (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of DecoPac, Inc. and participating employers (the Company) on the later of their date of the first of the month following their employment or upon turning 21 years of age. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Effective January 1, 2024, the Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants can also contribute amounts representing distributions from other qualified plans into the Plan (rollover contributions). The Plan provides for an automatic deferral contribution election of 6% when a participant first becomes eligible and annually thereafter if the participant is not active in the Plan. The participant may affirmatively elect a different percentage or may elect not to make this elective deferral contribution at this time.

The Company may make a discretionary matching contribution equal to a percentage of the amount of the employees elected deferral, not to exceed 8%. For the year ended December 31, 2024, the Company's discretionary matching contribution was 50% of the first 8% of each participant's eligible compensation.

The Company may also elect to make additional discretionary profit sharing contributions during the year at the discretion of the Company's Board of Directors. For the year ended December 31, 2024, the profit sharing contribution was 3.5% of each participant's eligible compensation.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Vesting**

Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary profit sharing, plus earnings thereon, is based on a graded vesting schedule. A participant is 100% vested after five years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

The Plan allows participants to borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, or longer if the proceeds are used to acquire a principal residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate of prime plus 1%, as published in The Wall Street Journal.

**Benefit Payments**

Upon termination of service due to death, disability or retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested account balance in either a lump-sum amount or, with the exception of termination of employment, in annual installments over a certain period which may not exceed the life expectancy of the individual.

Vested account balances of terminated employees of \$1,000 or less may be subject to a mandatory lump-sum cash distribution provision. In addition, vested account balances of terminated employees of greater than \$1,000 but less than \$5,000 may be subject to mandatory direct rollover provisions.

The Plan allows in-service distributions on all Plan accounts after the participant attains age 59½. The Plan allows for hardship withdrawals, subject to Plan provisions.

**Forfeited Accounts**

Forfeitures of unvested Company contributions are used to reduce discretionary contributions or to pay any Plan expenses not reimbursed by the Company. Forfeitures of \$74,234 were used to reduce Company contributions for the year ended December 31, 2024. There were no forfeitures used to pay Plan expenses during the year ended December 31, 2023. Balances of forfeited unvested accounts totaled \$10,951 and \$30 as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Investment Committee determines the Plan's valuation policies utilizing information provided by the insurance company and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. In accordance with IRS rules, participant loan defaults by participants who are not eligible to receive actual distributions from the Plan, such as participants who are active employees, are treated as "deemed" distributions under the Plan. In these circumstances, although the outstanding loan balance is reported as taxable income to the participants, the loan balance remains on the participants' Plan accounts until the participants are eligible to receive a distribution from the Plan. Defaulted participant loans of participants who are eligible to receive distributions from the Plan are reclassified as distributions (i.e., offset deemed distributions) and offset from their Plan account balances.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

The Company pays certain internal and external administrative costs incurred on behalf of the Plan. External administrative costs incurred by the Plan include trustee fees, external accounting fees, recordkeeping fees, and investment management expenses.

**Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the insurance company and trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Pooled Separate Accounts:* Valued daily at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Guaranteed Investment Contract:* Valued at the amount Plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination, or retirement. Fair value represents contract value adjusted to reflect current rates of interest available in the market place (market value adjustment). The interest rate used in the market value adjustment is computed utilizing a combination of the current market interest rate based on remaining investment term at the reporting date as well as the composite interest rate guaranteed on the account by Principal.

If the market interest rate is equal to or less than the composite interest rate on the account, the fair market value of the investment is equal to the contract value. If the market interest rate is greater than the composite interest rate on the investment, the fair market value is the contract value, reduced by a percentage. This percentage is equal to the difference between the market rate and the composite interest rate on the account, multiplied by the number of years (including fractional parts of a year) until the maturity date.

**NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan provides an investment option to invest in a nonbenefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account with contractual guarantee periods ranging from one to five years. A separate guaranteed interest investment is established for each deposit year for each guarantee period used to hold contributions directed to the investments. The guaranteed investment contracts are contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan by Principal. The guaranteed interest account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date of the guarantee period.

Principal guarantees that all qualified participant withdrawals will occur at contract value. The contract value of a guaranteed interest investment at any time during its guarantee period will be equal to the sum of all contributions and transfers to it, plus interest, less any payments or transfers. Interest is credited to the investment daily and compounded annually on the last day of each deposit year. The rate of interest credited is the composite guaranteed rate (composite rate) which is the rate guaranteed and determined by Principal for each investment when the contribution or transfer occurs during the deposit year.

When funds are withdrawn prior to their maturity, or for a nonbenefit event such as a withdrawal from the account for a change in investment option, there is a market value adjustment, which is called a surrender charge, when funds are withdrawn. As the contract is not fully benefit-responsive, the guaranteed investment contracts are recorded at estimated fair value in the statements of net assets available for benefits. As of December 31, 2024, all accounts in the investment had reached maturity and the balance was zero.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the pre-approved plan indicating that the pre-approved plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are held and managed by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the insurance company and trustee of the Plan. Abbey Street is an investment adviser for the Plan. These transactions qualify as party-in-interest transactions.
