INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of
The New Foundations Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The New Foundations Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institutions in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of The New Foundations Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) tax sheltered annuity plan covering substantially all employees of Robert W. Woodruff Foundation, Inc., Lettie Pate Whitehead Foundation, Inc., Lettie Pate Evans Foundation, Inc., Joseph B. Whitehead Foundation, and Robert W. Woodruff Health Sciences Center Fund, Inc. (collectively, the Foundations) and Ichauway, Inc. (Ichauway). These entities are part of a controlled group. Robert W. Woodruff Foundation, Inc. is the Sponsor of the Plan (Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All employees are eligible to participate in the Plan upon the first day of employment. Employer contributions will only be given to those employees who have reached age 21 and have completed 1,000 hours of service.

The Plan's recordkeeper is Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal). Plan assets held in mutual fund accounts are at Principal. Plan assets held in separate accounts and annuity contracts are at The Variable Annuity Life Insurance Company (VALIC) and the Teacher's Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA-CREF) and may be transferred or withdrawn by participants subject to certain restrictions.

Contributions

Participants may elect to contribute up to 100% of eligible compensation, as defined by the Plan document, not to exceed \$23,000 in 2024. Additionally, participants over the age of 50 may contribute an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Foundations contribute 15% of eligible compensation for each employee who is not considered a highly compensated employee. Highly compensated employees of the Foundations and employees of Ichauway receive an 8.33% contribution based on eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, employer contributions, and earnings and losses on the investments in their account, and is charged with certain administrative expenses. Participants direct the investment of their account into various investment options offered by the Plan. Participants may transfer between the various investment

options on a daily basis but are subject to restrictions as to the timing and amounts, as defined by their contracts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

TIAA-CREF investments are subject to various restrictions. The TIAA Traditional Annuity (TIAA Traditional), TIAA Real Estate Account, and three CREF separate accounts are not eligible to receive current contributions but transfers among the investments are allowed by the participants. Participants' investment balances, or accumulations, may be transferred among the CREF separate accounts and TIAA Real Estate Account without restrictions. Transfers may be made into the TIAA Traditional if the minimum transfer amount of \$1,000 is met. Inter-fund transfers from any fund have a minimum transfer amount of \$1,000 or 100% if the accumulation being transferred is less than \$1,000. If the participant's TIAA Traditional balance is \$2,000 or less, the participant may freely transfer a single sum to any CREF account. If the participant's balance is greater than \$2,000, the participant may transfer TIAA Traditional accumulations in ten approximately equal annual payments over a period of nine years.

Vesting

Participants are vested immediately in their contributions and the employer contributions and actual earnings thereon.

Notes Receivable from Participants and Plan Loans

Active participants in the Plan offered by Principal may borrow from the portion of their mutual fund account resulting from elective deferrals. Participants may borrow a minimum of \$1,000 up to the lesser of 50% of the vested balance of their account or \$50,000 for a period not to exceed five years. Notes are secured by the participant's account and must bear a reasonable fixed rate of interest as defined in the Plan document. Interest rates during 2024 ranged from 4.25% to 10.50%. Principal and interest are paid through payroll deductions.

Participants with balances resulting from elective deferrals in separate accounts and annuity contracts at VALIC may also take loans. Those loans, however, are made from VALIC rather than from the participant's account, and an amount equal to the loan balance must be invested in a VALIC fixed annuity contract and held as collateral. Loans from VALIC are made under similar terms as those from participant accounts. Interest rates on VALIC loans during 2024 ranged from 3.50% to 5.00%. The outstanding VALIC loan balances as of December 31, 2024 and 2023 totaled \$11,800 and \$15,209, respectively. All loan repayments and interest are paid directly to VALIC. Management believes these loans comply with ERISA regulations.

Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may elect to receive either a lump-sum amount of the vested interest in the account or annual installments. At age 59½, participants may elect a partial or lump-sum distribution of

their vested account balance. The participant may also receive a distribution for certain hardship situations.

After termination, participants may withdraw vested accumulations as a cash withdrawal for all investments, excluding the TIAA Traditional. All withdrawals and transfers from the TIAA Traditional must be spread out over ten annual installments. Under the Interest Payment Retirement Option (IPRO), participants between the ages of 55 and 69½ with balances of at least \$10,000 in the TIAA Traditional may elect to receive monthly payments equal to the guaranteed interest rate plus dividends that would otherwise be credited to their TIAA Traditional accumulations. Participants who select the IPRO are required to receive monthly payments for a minimum of 12 months and to continue such monthly payments until they request a distribution from the TIAA Traditional.

Administrative Expenses

Participants are charged various administrative fees based on their investment balances that are typically deducted quarterly. All loan fees, investment transaction fees, and recordkeeping fees are paid by participants in the Plan. Additionally, when a participant withdraws money from certain annuity contracts, a surrender charge is incurred as defined in the contract. These expenses are paid to a service provider of the Plan and, therefore, qualify as party-in-interest transactions. The Plan Sponsor pays other administrative fees of the Plan and provides certain accounting and administrative services to the Plan for which it is not compensated. Investment related expenses are included in net change in fair value or contract value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for the TIAA Traditional, the fixed annuity contracts, and the guaranteed interest account, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value and contract value of investments includes realized and unrealized gains and losses on investments, interest and dividends. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balances. Interest income is recorded when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institutions

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value and contract value of investments, and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by VALIC, Principal, and TIAA-CREF.

4. Investments

Certain Plan investments are managed by TIAA-CREF, Principal, and VALIC, which are service providers of the Plan. Accordingly, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in

net change in fair value or contract value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, or similar events. It is at least reasonably possible that changes in their fair value will occur in the near term, and such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

Investments in the separate accounts are valued daily using their net asset value (NAV) (Level 1). The NAV's are based on fair value of the mutual funds, stocks, debt instruments, and other securities in the accounts. The separate accounts may be traded daily at their NAV.

Investments in the TIAA Real Estate Account include real property, real estate joint ventures, and marketable securities. The real properties are appraised and mortgage loans are valued at least once every calendar quarter. The TIAA Real Estate Account obtains appraisals of its real estate properties throughout the quarter, which is intended to result in valuation adjustments that happen regularly throughout each quarter and not on one specific day in each period. In addition, an estimated daily equivalent of net operating income is taken into consideration and is adjusted for actual transactional activity. The remaining assets in the TIAA Real Estate Account are primarily marketable securities that are valued on a daily basis. Participants can trade the TIAA Real Estate Account daily at the published net asset value but because of the valuation methodologies the investment is considered to be Level 2.

The TIAA Traditional Annuity is an unallocated insurance contract with a guaranteed rate of return, which is the general obligation of TIAA-CREF. TIAA-CREF is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the participants. The contract is not considered to be fully benefit-responsive, and therefore, generally accepted accounting principles requires the fund to be reported at fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Management of the Plan has not made a determination of the fair value of the investment but does not believe the difference in fair value and contract value is material to the financial statements. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The stated guaranteed rate on the TIAA Traditional is 3%. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period.

The Plan has investments in fixed annuity contracts with VALIC and a guaranteed interest account (GIA) with Principal, which are both fully benefit-responsive investment contracts and stated at contract value. Contract value represents the aggregation of contributions, plus interest, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, which approximates fair value. For the GIA, Principal is contractually obligated to pay interest at a guaranteed rate based on the agreement with the Plan. The GIA has restrictions on withdrawals up to one year in the event the Plan Sponsor eliminated the investment option.

5. Income Tax Status

The Plan is a volume submitter 403(b) plan created by Principal Life Insurance Company (Principal Life Insurance), an affiliate of Principal. The Internal Revenue Service has determined and informed Principal Life Insurance by a letter dated March 31, 2017, that the volume submitter 403(b) plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since Principal Life Insurance received the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has a right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA.
