1. Plan description:

General:

The American Musical Supply 401(k) Profit Sharing Plan & Trust (the "Plan") is a defined contribution plan covering all full-time employees of American Musical Supply and its affiliates, MetroMinn, LLC and Retail Solutions, LLC (collectively referred to as the "Company"), who have completed one year of service and are age 18 or older. The Plan is subject to the provisions of ERISA. The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of investment offerings and monitoring investment performance. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

Contributions:

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan. Participant contributions cannot exceed the maximum amount allowable by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a default investment fund selected by the Plan Administrator, which will be identified to the participant prior to the first automatic contribution. The Company contributes 50% of participant contributions up to 5% of eligible compensation. The Company may also contribute a discretionary amount of its annual net earnings (profit sharing) as determined by its Board of Directors. The Company made no profit sharing contributions for the year ended December 31, 2024.

The Plan includes an automatic escalation for participants whose affirmative election is less than the maximum automatic deferral percentage unless the participant opts out. Unless a participant makes an affirmative election, the employer will withhold 5% of compensation each payroll period. The automatic deferral amount will increase by 1% of compensation up to a maximum of 10% of compensation.

Participant accounts:

Each participant's account is credited with the participant's contributions, Company contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately 100% vested in both their contributions and Company contributions.

1. **Plan description (continued):**

Notes receivable - participants:

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear interest at the prime rate (as printed in the Wall Street Journal) plus 2% at the inception of the loan and provide for periodic repayment over a period of 1 to 30 years, based on the type of loan. Principal and interest is paid ratably through monthly payroll deductions. The entire unpaid principal balance of the loan is due upon the participant's termination of employment with the Company. The interest rate on loans outstanding at December 31, 2024 ranged from 5.25% to 10.50%.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to 100% of the value of his or her account or annual installments. For termination of service for other reasons, a participant would receive the value of his or her account as a lump-sum distribution.

2. **Summary of significant accounting policies:**

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or to transfer a liability in an orderly transaction between market participants at the measurement date. The investment in the pooled separate account at December 31, 2024 and 2023 relate to units of participation in mutual funds held by Voya Retirement Insurance and Annuity Company ("Voya"). The unit price is based on the Net Asset Value ("NAV") of the underlying mutual fund or collective trust shares, which is determined daily. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held at the end of the year.

2. Summary of significant accounting policies (continued):

Notes receivable - participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded at December 31, 2024 or 2023.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Expenses related to maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan's management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. Fair value measurements:

Accounting Standards Codification 820 – *Fair Value Measurement* (“ASC 820”) defines fair value and establishes a framework for measuring fair value under generally accepted accounting principles. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: Valued at the daily closing price which is based on the Fund's NAV as reported by Voya who holds the Plan's units of participation in the mutual funds. The units in mutual funds held by the Plan are deemed to be actively traded.

4. Fully Benefit-Responsive Investment Contracts:

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made, plus earnings, less participant withdrawals, and administrative expenses. The following represents the contract value of the investment contract held by the Plan.

For traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

4. Fully Benefit-Responsive Investment Contracts (continued):

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

5. Investments:

Unaudited information certified by Voya:

The December 31, 2024 and 2023 statements of net assets available for benefits, the investment activities included on the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified as complete and accurate by Voya (the "Trustee") in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$22,942,072 and \$19,688,894 at December 31, 2024 and 2023, respectively, and the related net investment gain of \$2,660,032 for the year ended December 31, 2024.

6. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Income tax status:

The Internal Revenue Service has determined and informed the Company by letter dated December 6, 2001, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue

7. Income tax status (continued):

Code. Although the plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and uncertainties:

The Plan invests in various mutual funds which are exposed to various risks such as stock market fluctuations, interest rates, economic conditions and world affairs. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of changes in net assets available for benefits.

Significant market disruptions, such as those caused by pandemics, natural disasters or environmental disasters, war, instability in the banking and financial services sectors, including bank failures, or other events, can adversely affect local and global markets and normal market operations. Any such disruptions could have an adverse impact on both the Plan's investments and the Plan's sponsor.
