Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of AvAirPros Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AvAirPros Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

The accompanying financial statements of AvAirPros Services, Inc. 401(k) Plan (the Plan) have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

2. Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date.

Purchases and sales are recorded on the trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

4. Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investment of the balance in their accounts in the specific investment funds made available by the Plan administrator. At December 31, 2024 and 2023 all investments are participant directed.

NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

5. Payments of Benefits

Benefits are recorded when paid.

6. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B – DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of AvAirPros Services, Inc. (the Employer). The Plan provides that an employee is eligible for participation upon attaining 21 years of age and completion of 6 months of service. An eligible employee may become a participant on the next entrance date, which is the first day of the month following the date the eligibility requirements are satisfied.

The Employer is responsible for appointing an administrator and trustees for the Plan. The trustees have discretionary powers in executing investment transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is responsible for investment management fees and costs of the Plan administration to the extent not paid by the Employer.

2. Contributions

The Plan allows participants to contribute up to 100% of their eligible compensation, as defined in the Plan, subject to limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

NOTE B - DESCRIPTION OF THE PLAN - CONTINUED

2. Contributions - Continued

The Plan provides that the Employer makes a Safe Harbor Matching Contribution equal to 100% of employee deferrals that does not exceed 4% of gross compensation. The Safe Harbor Matching Contribution is paid each payroll. All other matching contributions are determined at the discretion of the Employer. There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

3. Participant Accounts

Each participant account is credited with the participant's contribution and an allocation of (a) the Employer's safe harbor and discretionary matching contribution and (b) investment income or loss on investments less an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined.

Changes in a participant's deferral percentage for future contributions may be made monthly during the Plan year. Reallocation of participant investment accounts among the investment options may be made at any time during the Plan year.

4. Vesting

Participants immediately vest in their contributions and safe harbor matching contributions plus earnings thereon. Participants vest in discretionary Employer matching contributions plus earnings thereon at a rate of 20% after two years of service, plus an additional 20% for each additional year of service, becoming 100% vested after 6 years of service. A participant is 100% vested due to reaching normal retirement age, death or disability.

5. Payment of Benefits

Upon termination of service due to death, disability, or retirement, or termination of employment, a participant may receive a lump sum distribution or installment payments equal to the participant's vested account balance. In service distributions are allowed for participants at attainment of age 59 ½. Participants with balances of \$5,000 or less are subject to involuntary lump sum distributions.

NOTE B - DESCRIPTION OF THE PLAN - CONTINUED

6. Notes Receivable from Participants

Notes receivable to participants are permitted up to the lesser of one-half of their vested balance or a maximum of \$50,000 for each participant. The minimum loan amount is \$1,000. The maximum number of outstanding loans is one. The interest rate on the loans is the prime rate plus 2%. Loans must be repaid within 5 years unless the loan is used for the purchase of the participant's primary residence. Loans used for the purchase of a participant's primary residence must be repaid within a period of no more than 30 years. The loans are secured by the participant's account. Principal and interest are paid ratably through payroll deductions.

7. Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$16,000, respectively. The Plan may use forfeitures to offset Plan expenses or Employer contributions at their discretion. The Plan did not use any forfeitures to reduce Employer contributions or Plan expenses during the year ending December 31, 2024.

8. Risks and Uncertainties

The Plan is comprised of investments in a combination of investment securities. Investment securities are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE D – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) as a practical expedient to fair value of the units held by the plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – FEDERAL INCOME TAXES

Effective January 1, 2019, the Plan has adopted the Volume Submitter 401k Profit Sharing Plan with CODA of KB Pension Services, Inc. The volume submitter sponsor obtained its latest advisory letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. There are no reconcilable differences between the financial statements and the Form 5500 as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

The Plan's policy is to evaluate the likelihood that any uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS, generally for three years after they were filed.

NOTE F – PARTY-IN-INTEREST TRANSACTIONS

John Hancock Life Insurance Company (U.S.A.) is the custodian and recordkeeper of the Plan, holds the Plan's investments, and executes transactions. KB Pension Services, Inc. is the third-party administrator. Merrill Lynch is the Plan advisor.

NOTE G – ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees to the custodian. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the employer on behalf of the Plan.

NOTE H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to reduce, suspend, or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE I – SECURE ACT 2.0

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE Act 2.0". SECURE Act 2.0 contains over 90 new retirement provisions continuing the reforms that began with the 2019 SECURE Act. These provisions have varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. There is no material impact to the Plan's 2024 financial statements.

NOTE J – SUBSEQUENT EVENTS

The Employer has evaluated subsequent events through October 1, 2025, the date which the financial statements were available to be issued.
