### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of One Anesthesia 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of One Anesthesia 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

## ONE ANESTHESIA 401(k) PROFIT SHARING PLAN

### NOTES TO FINANCIAL STATEMENTS

#### Note 1. Description of Plan

The following description of the One Anesthesia 401(k) Profit Sharing Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan was previously known as the Williams & Wagner, PSC 401(k) Profit Sharing Plan. Effective January 1, 2014, three additional plans merged into the Williams & Wagner, PSC 401(k) Profit Sharing Plan, which was then re-named the One Anesthesia 401(k) Profit Sharing Plan. The merged plans include Anesthesiology Associates of Clark County, Inc. Profit Sharing Plan; Southern Indiana Anesthesia Consultants, PLLC Profit Sharing Plan; and Anesthesia Associates of Louisville, P.S.C. 401(k) Profit Sharing Plan. The merger was in conjunction with a merger of the employers to create One Anesthesia, PLLC.

The Plan is a defined contribution plan covering certain employees of One Anesthesia, PLLC (Employer). Temporary, and seasonal employees regularly scheduled for less than 1,000 hours of service are excluded from the Plan. An eligible employee may enter the Plan on any entry date coincident with or following completion of six months of service. Entry dates are the first day of each month.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### Contributions:

The Plan is funded by both discretionary participant and employer discretionary matching, safe harbor and profit-sharing contributions. Each year, participants may contribute up to 100% of their compensation, as defined in the Plan, up to the maximum permitted by the Internal Revenue Code. Participants may also elect to defer a portion of their after-tax compensation as a Roth contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

## NOTES TO FINANCIAL STATEMENTS

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions are invested in a qualified default investment fund until changed by the participant.

Participants direct the investment of their contributions into various investment options offered by the Plan or into other investment securities within participant maintained brokerage accounts.

In 2024 and 2023, an employer profit sharing contribution was provided to participants equal to a percentage of participants' compensation. The contribution ranged from 2% to 10% for each of the years ended December 31, 2024 and 2023, dependent upon the participant's classification for plan purposes. All eligible employees also receive an employer safe-harbor contribution equal to 3% of their annual compensation. There were no discretionary employer matching contributions made to the Plan in 2024 and 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### **Participant accounts:**

Each participant's account is credited with the participant's contributions, employer discretionary matching, safe harbor, and profit-sharing contributions, and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting:**

Participants are immediately vested in their contributions and employer safe harbor contributions, plus actual earnings thereon.

Participants employed as of December 31, 2018 were immediately vested in the employer's discretionary matching and profit-sharing contributions. Through September 25, 2023, for new hires beginning on or after January 1, 2019, the employer discretionary matching and profit-sharing contributions were 100% vested after three years, with no vesting prior to that date. Effective September 25, 2023, the plan was amended and all participants employed as of September 25, 2023 are immediately vested in the employer's discretionary matching and profit-sharing contributions, and all new hires beginning on or after September 26, 2023 are 100% vested after three years, with no vesting prior to that date.

## NOTES TO FINANCIAL STATEMENTS

### **Payment of benefits:**

Upon termination of service due to death, disability, termination of employment, or attaining normal retirement age, a participant may elect to receive the vested value of his or her account in a lump sum payment or equal installment payments. The Plan specifically restricts the timing and method of benefit payments based on the participant's age, length of service, account value and reason for termination.

### **Forfeited accounts:**

There was no forfeited non-vested account balance at December 31, 2024. At December 31, 2023, forfeited non-vested accounts from previous discretionary employer contributions totaled \$2,861. These funds will be used to reduce future Plan expenses, to reduce future nonelective or matching contributions, or will be allocated as additional discretionary nonelective or employer matching contributions. In 2024 and 2023, \$39,592 and \$8,272, respectively, of forfeitures were utilized to reduce employer contributions.

### **Note 2. Summary of Significant Accounting Policies**

This summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

#### **Basis of accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **Investment valuation and income recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

## NOTES TO FINANCIAL STATEMENTS

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Certain plan assets report all changes in the value of plan assets, including interest and dividends, as appreciation in value. Therefore, the net appreciation includes certain effects of interest and dividends received during the year.

### **Payment of benefits:**

Benefits are recorded when paid.

### **Expenses:**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments as they are paid through revenue sharing, rather than a direct payment.

### **Contributions:**

Contributions from Plan participants and contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### **Subsequent events:**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

### **Note 3. Certified Investments**

Certain information related to investments held by American Trust Company disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, dividends and net appreciation in fair value of investments, for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American Trust Company, N.A., a qualified institution.

### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

## NOTES TO FINANCIAL STATEMENTS

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

All assets have been valued using a market approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds – valued at daily closing prices as reported by the fund.

Common/collective trusts – valued at the net asset value (NAV) of units held by the Plan at year end. The net asset value is used as a practical expedient to estimate fair value.

Self-directed brokerage accounts – valued at the sum of the fair value of the underlying investments, based on the underlying investments' exchange traded closing price or net asset value of shares/units held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Investments Measured Using Net Asset Value per Share Practical Expedient:

The common/collective trust funds have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' net asset value. The NAV is updated daily.

## NOTES TO FINANCIAL STATEMENTS

### **Note 5. Income Tax Status**

The Plan is a prototype plan offered by AT Retirement Services, LLC. The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in accordance with the applicable requirements of the IRC, and, therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will be entitled to 100% of the value of their accounts.

### **Note 7. Related Party and Party-in-Interest Transactions**

American Trust Company (ATC), is the recordkeeper of the Plan; therefore, transactions with ATC qualify as party-in-interest transactions. Fees paid by the Plan to ATC for administrative services amounted to \$106,102 and \$102,089, for the years ended December 31, 2024 and 2023, respectively.

Baird and Stock Yards Bank (SYB) serve as outside investment advisors to the Plan, and as such, transactions with Baird and SYB qualify as party-in-interest transactions. Fees paid by the Plan for these advisory services for the years ended December 31, 2024 and 2023 were \$43,110 and \$48,282 to Baird and \$24,822 and \$21,333 to SYB, respectively.

Certain administrative functions are performed by officers of employees of the Employer. No officer or employee receives compensation from the Plan.

## NOTES TO FINANCIAL STATEMENTS

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
