Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Varflex Corporation Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A--DESCRIPTION OF THE PLAN

The following description of the Varflex Corporation Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Varflex Corporation (“Plan Sponsor”/“the Company”). The Plan is subject to the provisions of ERISA. The Company’s Board of Directors is responsible for oversight of the Plan. NBT Bank, N.A., as the Plan’s trustee, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility: Employees must complete 60 days of service to be eligible to participate and defer into the Plan. Prior to January 1, 2024, employees were required to complete 90 days of service to be eligible to participate and defer into the Plan. The Plan’s entry date is the first day of the payroll period coinciding with or next following the date on which an employee meets the eligibility requirements.

Contributions: Each year, the Plan Sponsor may elect to make a discretionary contribution to the Plan for the allocation to all eligible participants. A participant must work at least 501 hours during the Plan year in order to be eligible to receive an allocation of the Company’s discretionary contribution. The discretionary contribution is allocated to participants using a uniform points allocation method, as outlined in the Plan document. The discretionary contribution, plus any forfeitures subject to reallocation, shall be allocated to eligible participants in the ratio that each participant’s total points bears to the total points of all participants. Participants shall be credited with two points for each \$200 of Plan compensation and two points for every year of service, as defined by the Plan. Discretionary contributions of \$391,409 and \$331,685 were made to the Plan in 2024 and 2023, respectively. In 2024 and 2023 the Plan Sponsor elected to make employer safe harbor non-elective contributions of 3% of a participants’ eligible compensation, as defined by the Plan, regardless if the employees make elective deferrals into the Plan. The safe harbor non-elective contributions amounted to \$169,915 and \$169,991 for 2024 and 2023, respectively. Participants may contribute tax-deferred and after tax Roth dollars through payroll deductions (elective deferral contributions) equal to the lesser of 100% of eligible compensation or \$23,000 and \$22,500 into the Plan for 2024 and 2023. Additionally, if a participant has attained the age of 50 before the end of the calendar year, the participant may make “catch-up” contributions of \$7,500 for 2024 and 2023, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from all permissible retirement plans (rollovers). After-tax rollover contributions are not permitted under the Plan.

NOTE A--DESCRIPTION OF THE PLAN--Continued

Participant Accounts: Each participant's account is credited with an allocation of (a) a participant's elective deferral contributions, (b) the Company's safe harbor and discretionary contributions, (c) Plan earnings, and (d) forfeitures of terminated participants' nonvested accounts and charged with Plan losses and an allocation of administrative expenses. Allocations are based on specified formulas which consider participant earnings and account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their elective deferral contributions and the employer safe harbor non-elective contributions plus actual earnings thereon. Vesting of the employer discretionary contributions made to a participant's account is based on years of service in which a participant is credited with at least 501 hours of service. Vesting is graded as follows:

<u>Years of service</u>	<u>Vested percentage</u>

2	20%
3	40%
4	60%
5	80%
6	100%

Upon attainment of normal retirement age of 62, death or disability, a participant becomes 100% vested in all amounts credited to the participant's account.

Payment of Benefits: Upon termination of service due to normal retirement, death, or disability, a participant will receive an amount equal to the participant's account balance in a lump-sum payment. In the event of the termination of a participant's employment for any reason other than normal retirement, death or disability, the participant's vested account balance will become due and payable. The distribution will be made in a single lump-sum payment. If a participant's vested account balance is between \$1,000 and \$5,000, and the participant fails to make a distribution election, a lump-sum amount will be rolled over to an individual retirement account without their consent. If a participant's vested account balance is \$1,000 or less, and the participant failed to make a distribution election, a lump-sum amount was to be paid to the participant without the participant's consent. The Plan does allow for in-service distributions to participants who have attained age 59½.

Forfeited Accounts: Forfeitures of nonvested discretionary contributions will be added to the Company discretionary contribution and allocated to eligible participants in the manner previously described under the Contributions caption within this Note. At December 31, 2024 and 2023, there were \$59,788 and \$42,557, respectively, of forfeited nonvested accounts that were available to be allocated to eligible participants. Forfeited nonvested accounts totaling \$42,557 and \$4,134 were reallocated to participants during the Plan years ending December 31, 2024 and 2023, respectively.

NOTE B--SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. See Note D for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions Receivable: Employer contributions receivable are presented in the statement of net assets available for benefits net of any allowance for credit losses. The Plan Administrator believes that no allowance for credit losses is necessary at December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: The Plan's expenses are paid either by the Plan or by the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Events Occurring After Report Date: Plan management has evaluated events and transactions that occurred between December 31, 2024 and October 6, 2025 which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. There were no such events or transactions identified by Plan management.

NOTE C--INFORMATION CERTIFIED BY NBT BANK (UNAUDITED)

The following is a summary of the Plan's asset information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule that were prepared by or derived from information provided by the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the Plan's asset information provided to the Plan Administrator by the trustee is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the asset information which appears throughout the financial statements and supplemental schedule relating to the following assets.

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) Topic 820, “Fair Value Measurements and Disclosures”, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the registered investment companies. The registered investment companies are open-ended and are registered with the Securities and Exchange Commission. These registered investment companies are required to publish their daily net asset value (NAV) and to transact at that price. The shares held in registered investment companies by the Plan are deemed to be actively traded.

NOTE D--FAIR VALUE MEASUREMENTS--Continued

Collective investment trust: Valued at the NAV of units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E--RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Fees paid by the Plan amounted to \$4,698 and \$3,602 for the years ended December 31, 2024 and 2023, respectively. The fees represent charges for benefit payment processing and third party administration services and are charged directly to participants' accounts. Trustee services, investment management services and auditing services are all provided by parties in interest and are paid directly by the Plan Sponsor. The Plan Administrator believes all party in interest transactions qualify for either statutory or administrative exemption from the prohibited transaction rules under ERISA.

NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE G--TAX STATUS

The Plan adopted a volume submitter plan sponsored by EPIC Advisors, Inc., the Plan's third party administrator. The IRS has determined and informed the volume submitter plan sponsor by a letter dated June 30, 2020, that the volume submitter plan qualifies under the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the volume submitter plan. Although the Plan has been amended since adopting the volume submitter plan, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE H--RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
