We have performed audits of the financial statements of the Cambridge Investment Group Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Plan Description

The following description of the Cambridge Investment Group Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Eneric Petroleum Corp. (the Sponsor) who have attained 18 years of age or older and have completed one month of service. Part-time employees must complete 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective June 1, 2024, the Plan name was changed from Eneric Petroleum Corp. 401(k) Retirement Plan to Cambridge Investment Group Retirement Plan. In addition, the Plan changed from Mid Atlantic Trust Company, former custodian, to Fidelity Management Trust Company, current trustee and changed record keeper from Spectrum Financial Group to Fidelity Management Trust Company effective June 1, 2024 and adopted a new non-standardized pre-approved plan sponsored by FMR, LLC.

Contributions: Participants may elect to defer from their compensation up to the maximum percentage allowable, not to exceed the limits of Internal Revenue Code (IRC) Section 401(k). Participants who are at least 18 years of age and completed one month of service are eligible for an employer matching contribution. Each year, the Sponsor may contribute to the Plan a discretionary amount as a matching contribution, as well as a discretionary amount as a profit sharing contribution. For the year ended December 31, 2024, the Sponsor contributed 100% of the employees' deferral up to 4.5% of eligible employees' compensation in the amount of \$2,992,793. There were no discretionary profit sharing contributions made for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions).

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of the Sponsor's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on continuous years of service. Participants vest 20% for each year of service in which they work over 1,000 hours beginning with the first year. A participant is 100% vested after five years of credited service. Effective June 1, 2024, a participant is 100% vested after three years of credited service.

Payment of benefits: Benefits may be paid to the participant or beneficiary upon death, disability, hardship, retirement or termination of employment. In-service distributions are allowed for active participants age 59½ and older. Benefits may be paid in a lump sum or in substantially equal installments. If the vested value of a participant's account is less than \$7,000 at the time of distribution, amounts payable shall be rolled over into an individual retirement account if the participant does not consent to a distribution after receipt of notice.

Forfeitures: Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to pay administrative expenses or to offset employer contributions. Forfeitures used to offset employer contributions totaled \$76,185 for the year ended December 31, 2024. Forfeited nonvested accounts were \$11,406 and \$0 as of December 31, 2024 and 2023, respectively.

Note 1. Plan Description (Continued)

Investment options: Upon enrollment in the Plan, a participant may direct investment balances among any or all of the investment options offered by the Plan. Investment allocations may be changed at any time.

Notes receivable from participants: Participants can elect to take out a note on their individual accounts. The minimum note amount shall be \$1,000 and the maximum amount is the lesser of \$50,000 or 50% of their vested account balance. Note terms range up to five years or up to a reasonable amount of time for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest is paid ratably through biweekly payroll deductions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Valuation of investments and investment income: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant notes are recorded as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: The Plan paid investment management fees of \$61,324 for the year ended December 31, 2024. All other expenses were paid by the Plan Sponsor.

Note 2. Significant Accounting Policies (Continued)

Income taxes: Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audit by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to a participant's account will become 100% vested.

Note 4. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Note 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the codification are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money market fund: Valued based on the quoted prices in the active markets in which they are traded.

Mutual funds: Valued based on the quoted prices in the active markets in which they are traded.

Unitized funds: Investment contracts valued at the net asset value (NAV) of shares held by the Plan in the trust account at year-end as determined by the third-party administrator based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Self-directed brokerage accounts: Accounts consist of mutual funds, common stock, money market funds and government bonds that are valued based on quoted prices in the active markets on which they are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (b) The Conservative Balanced portfolio seeks the highest return possible consistent with a goal to limit losses in excess of 5.0% over a 12-month period. There is no guarantee that this threshold will not be exceeded. The portfolio may be appropriate for investors who seek modest participation in stock market gains but are also concerned with short-term risk and preservation of capital in bad market environments. The portfolio may be appropriate for investors who place primary emphasis on capital growth with only moderate concern about short-term fluctuations in the portfolio's value. Investors should have a time horizon in excess of five years.

- (e) The Equity portfolio seeks high long-term growth of assets without concern for short-term losses. The portfolio's downside risk potential is comparable to the overall equity market and the portfolio may experience losses that are commensurate with those of the equity market. There is no guarantee that this threshold will not be exceeded. The portfolio may be appropriate for investors looking for high long-term returns who are not concerned about short-term losses or fluctuations in the portfolio's value. Investors should have at least a five to seven-year time horizon.
- (f) The Focused Opportunity portfolio seeks maximum long-term growth of assets without concern for short-term losses. The portfolio's downside risk potential is comparable to the overall equity market and the portfolio may experience losses that are commensurate with those of the equity market. There is no guarantee that this amount will not be exceeded. The portfolio may be appropriate for investors who are looking for maximum long-term returns and are not concerned about short-term losses in value or with performance that is out of sync with equity markets. This portfolio will not involve any short-term risk management. It is appropriate for investors with time horizons in excess of five to seven years.

Note 8. Related-Party and Party-in-Interest Transactions

Certain Plan investments were shares of unitized funds managed by Cambridge Investment Research Advisors, Inc., a subsidiary of the Sponsor. Transactions within the funds managed by them qualify as party-in-interest transactions. Spectrum Financial Group (Spectrum) was the third-party administrator for the Plan. Spectrum is owned by a member of the Board of Directors of the Plan Sponsor. Fees paid to Spectrum are not considered material and are paid by the Plan Sponsor, with the exception of participant loan application fees and participant qualified domestic relations order processing, which are paid from the Plan by the participant's account.

Certain Plan investments are management by a company affiliated with Fidelity Management Trust Company, the current trustee of the Plan. Any purchases and sales of these funds are preformed in an open market at fair value. Certain fees paid by the Plan for investment management services are included as a reduction of the return earned on each investment fund. Transactions with the trustee qualify as party-in-interest transactions. The Plan also makes loans to participants.

Note 9. Prohibited Transactions

During 2023, the Plan Sponsor inadvertently failed to deposit \$150 of participant deferrals within the required time frame as stated by the United States Department of Labor regulations. The Plan Sponsor deposited lost earnings to correct the failures in 2024. The correction was made from the Plan Sponsor's assets and not from assets of the Plan.
