Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rockingham Cooperative 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Plan Description

The following description of the Rockingham Cooperative 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Rockingham Cooperative Farm Bureau (the “Plan Sponsor”) who have attained eighteen years of age and completed one month of service. Employees may enter the first of the month following the date eligibility requirements were met. The Plan has an auto-enrollment feature providing for automatic deferral of 3%. If the employee opts out of automatic enrollment within ninety days of the first payroll deferral, the Plan Sponsor will refund the deferrals. Employees governed by a collective bargaining agreement are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute a percentage of pretax annual compensation or after tax with a Roth election as defined in the Plan, not to exceed the maximum allowable under the *Internal Revenue Code (IRC)*. The Plan permits catch-up contributions to be made by participants who have attained age 50 before the end of the year. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants direct their contributions into various investments offered by the Plan. The Plan Sponsor will make safe harbor matching contributions in an amount equal to the participant’s elective deferrals, up to 3% of the participant’s compensation, with an additional matching contribution equal to 50% of the participant’s elective deferral up to 6% of the participant’s compensation. The Plan Sponsor may also contribute a discretionary non-elective contribution at the option of the Plan Sponsor’s Board of Directors. In order for participants to share in the discretionary non-elective contribution, the participant must be employed on the last day of the Plan year (waived in the event of death, disability, or retirement). Additional amounts were not contributed for 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Plan Sponsor’s matching and any additional contributions, allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Plan Sponsor’s non-elective discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Vested account balances less than \$5,000 will be automatically

distributed in a lump-sum payment upon termination. Retirees may choose a lump sum payment or installments if the participant is subject to Required Minimum Distributions.

Administrative Expenses

Administrative expenses incurred by the Plan may be paid by either the Plan Sponsor or the Plan on a discretionary basis.

Notes from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested balance. Only one loan may be outstanding to a borrower at any time. The term of repayment of a loan under \$2,000 must be no greater than three years. All other loans must be repaid within a period of five years, except for a home loan, which must not be greater than 15 years. The loans are secured by the balance in the participant's account and bear interest at market rates as determined by the Plan Administrator. At December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

Forfeitures may be utilized to pay administrative expenses, with any remaining amount used to reduce the employer's discretionary non-elective contribution. There were no forfeited non-vested accounts at December 31, 2024 or 2023.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could

materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 13, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The stable return fund issued by Galliard Capital Management and the Capital Preservation Fund issued by Federated are valued at net asset value (NAV). The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount

different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is no notice period if the Plan initiates a full redemption of the fund.

Note 4 – Investment Contracts

The Plan has investments in the Federated Capital Preservation Fund. Included in this fund are traditional and separate accounts guaranteed investment contracts and certain wrapper contracts. The average yield for the fund was

approximately 3.32% and 3.69% for 2024 and 2023, respectively. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants during 2024 and 2023 was 3.27% and 3.62% respectively. The objective of the fund is to provide safety of principal and consistency of returns while attempting to maintain minimal volatility. The percentage of contributions allocated to this fund is determined by the participants.

The Plan also has investments in the Galliard Stable Return Fund. Included in this fund are guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive and since those contracts are purchased in the open market, are presented at fair value. The average yield for the fund was approximately 4.88% and 4.92% for 2024 and 2023, respectively. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants during 2024 and 2023, was 3.35% and 2.93%, respectively. The objective of the fund is to provide stability of principal and high current income. The fund invests primarily in stable value products, including investment contracts and security-backed contracts issued by major insurance companies and money market instruments. The percentage of contributions allocated to this fund is determined by the participants.

Note 5 – Related Party Transactions and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Plan Sponsor. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Certain Plan investments are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Empower Trust Company, LLC provides certain administrative services to the Plan pursuant to a Services Agreement between the Plan Sponsor and Empower Trust Company, LLC. Empower Trust Company, LLC receives revenue from mutual fund and collective trust fund service providers for services Empower Trust Company, LLC provides to the funds. This revenue is used to offset certain amounts owed to Empower Trust Company, LLC for its administrative services to the Plan. If the revenue received by Empower Trust Company, LLC from such mutual fund or collective trust fund providers exceeds the amount owed under the Services Agreement, Empower Trust Company, LLC remits the excess to the Plan's trust on a monthly basis. Such amounts may be applied to pay Plan administrative expenses. Administrative expenses are presented net of \$4,887 in credits received during the year ended December 31, 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan was adopted under a prototype plan sponsored by the Trustee. The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor, by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended; however, the Plan Sponsor and Administrator believe that the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions

taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
