Opinion

- 1. DESCRIPTION OF PLAN:** The following description of the American Business Institute Corp. Health and Welfare Benefit Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan was originally established on March 23, 2010, and effectively restated January 1, 2021, to provide health benefits to eligible employees of American Business Institute Corp. (the Sponsor) and covered dependents.

The Plan is available to employees who meet eligibility criteria as defined in the plan document.

At each annual enrollment, provisions, such as participant contribution rates, coverage, deductibles, copays, and out-of-pocket maximums, may change.

Benefits

The Plan provides health benefits including coverage for medical and prescription drugs, as well as multiple health reimbursement arrangements (HRA). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan has entered into an agreement with an insurance company to provide participants with *Health Maintenance Organization* insurance coverage (HMO). Premiums for insured benefits were paid from the general assets of the Sponsor.

Self-Insured Benefits

Minimum Essential Coverage (MEC) medical benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants using funds from the general assets of the Sponsors. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

HRA Benefits

Health Reimbursement Arrangement benefits (HRA) are provided through benefit cards issued to each participant. Participants can utilize their accumulated HRA funds by using the benefit card to pay for various health-related expenses.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Contributions

For HMO and MEC benefits, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. In addition, participants may be separately responsible for deductibles and copayments. The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Received

Contributions to the plan are recorded when funds are received from employers and participants to fund insured benefit premiums, self-insured benefit medical claims, and HRA benefit cards.

Payment of Benefits

Premiums paid by either the Sponsor or the plan trust are reported as premiums paid in the accompanying statement of changes in net assets available for benefits.

Claim payments for self-insured benefits are recorded when paid by the third-party claims processor. HRA benefits are recorded when a participant utilizes the HRA benefit card to cover various health-related expenses. Both are reported as benefits paid in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED:

Plan obligations at December 31 for claims incurred but not reported are estimated by the plan administrator based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. ADMINISTRATIVE EXPENSES:

The Plan pays administrative expenses that consist primarily of fees paid to third-party administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Such transactions are party-in-interest transactions under ERISA. During the year ended December 31, 2024, these administrative expenses were paid by the Sponsor on behalf of the Plan and are excluded from these financial statements.

5. TAX STATUS:

As a result of the Plan's funding policy, from time to time, the Plan may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

**TAX STATUS

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. TERMINATION OF
THE PLAN:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

**7. RISKS AND
UNCERTAINTIES:**

On occasion, the Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
