NOTE 1 DESCRIPTION OF PLAN

The following description of The Buccaneer, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provision.

General – The Plan is a defined contribution plan covering The Buccaneer, Inc.'s (Buccaneer) eligible full-time employees. In order to qualify for participation in the 401(k) Plan, an employee must have completed one year of service and attained the age of 21. Hours of service are generally counted as the basis of the actual number of hours the employee works or for which the employee is entitled to compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan, up to 100% of their compensation not to exceed the annual maximum allowable amount under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Buccaneer provides an employer matching contribution to the Plan up to 4% of the participant's eligible wages.

Participant Accounts – Each participant's account is credited with (a) the participant's contribution; (b) the employer's matching contribution, and (c) allocation of plan earnings or losses based thereon, excluding expenses paid by participants. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Participants may direct the investments of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus any earnings thereon. Vesting in the employer's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Rollovers – Rollovers represent transfers of eligible cash distributions from any other qualified plans through a direct transfer from such plan. All participants are 100% vested in their rollover contributions. There were no rollover contributions in 2024.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate as specified in the Wall Street Journal. Principal and interest are paid through payroll deductions.

Payment of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive either installment payments or lump sum amounts equal to the value of the participant's vested interest in his or her account. Additionally, under certain circumstances of financial hardship, the participants are allowed to withdraw funds from the Plan.

Forfeited Accounts – Forfeited accounts represents the non-vested funds of participants who terminate prior to being fully vested. Forfeitures may be applied to reduce plan administrative expenses, to restore participants' financial accounts, or to reduce employer contributions. At December 31, 2024 and 2023, the forfeited balances totaled \$3,075 and \$2,538, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by Buccaneer, and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included as administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 Fair Value Measurement and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market is valued based on over the counter trading value.

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to actively trade.

Buccaneer is the sponsor of the Plan, and as such, executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by the Plan sponsor on behalf of the Plan.

Ascensus Trust Company was the Plan's trustee and record keeper. Any transactions with trustee, including investment management and account services, qualify as party-in-interest transactions. Fees paid by the Plan to the custodian were \$10,079 for the year ended December 31, 2024.

NOTE 7 TAX STATUS

The Internal Revenue Service has determined and informed the Buccaneer by a letter dated November 27, 2001 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator and its tax counsel, as applicable, believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator does not believe the Plan has any uncertain positions that require disclosure or adjustment to the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, Buccaneer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. This review and evaluation revealed no material events or transactions which require additional adjustment to or disclosure in the accompanying financial statements.
