INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Samaritan Medical Center and Samaritan-Keep Nursing Home, Inc. Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Samaritan Medical Center and Samaritan-Keep Nursing Home, Inc. (1) Description of Plan

The following description of the Samaritan Medical Center and Samaritan-Keep Nursing Home, Inc. Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution retirement and savings plan for employees of Samaritan Medical Center (SMC), Samaritan-Keep Nursing Home, Inc. (SKH), and Samaritan Senior Village, Inc. (SSV), (collectively, "the Plan Sponsors"). The Plan provides for participation by all eligible union and non-union employees of SMC, SKH, and SSV under Internal Revenue Code Section 401(k). Employees are eligible to participate in the Plan if they are age 21 or older and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Employer contributions to the Plan are made at the discretion of the Plan Sponsors. Participants may elect to contribute any percentage of compensation on a pre-tax basis, subject to the maximum limitations on pre-tax elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of these contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common/collective trusts and a self-directed brokerage account as investment options for participants.

The Plan Sponsors may contribute discretionary matching or other non-elective contributions at the option of the Plan Sponsors. Certified nursing assistants at SKH and SSV and home health aides at SSV hired between June 1, 2016 and July 15, 2017 are not eligible to receive matching contributions. Non-elective contributions are available if elected by the Plan Sponsors. Additionally, certified nursing assistants at SKH and SSV and home health aides at SSV hired after July 15, 2017 are not eligible to receive non-elective contributions. For the years ended December 31, 2024 and 2023, the Plan Sponsors made discretionary matching contributions of \$1,814,057 and \$1,747,629, respectively. For the years ended December 31, 2024 and 2023, the Plan Sponsors made discretionary non-elective contributions of \$3,466,392 and \$3,198,058, respectively.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and the Plan Sponsors' contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan Sponsors' contribution portion of their accounts is based on years of credited service and is as follows:

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or up to 10 years for purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the current prime rate plus 1% at the time the loan originated, which is commensurate with interest rates charged by persons in the business of lending money for notes that would be made under similar circumstances. Principal and interest is paid ratably through payroll deductions while participants are actively employed by the Plan sponsor. Payments may be made directly to the Plan after termination of employment or retirement.

(f) Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over any period not extending beyond the joint and survivor life expectancy of the participant and his or her beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totalled \$169,819 and \$165,106, respectively. These accounts are used to offset Plan expenses or reduce the Plan Sponsors' contributions to the Plan. For 2024 and 2023, employer contributions were reduced by approximately \$180,000 and \$144,600, respectively, from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsors' Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains or losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefits paid to participants upon the occurrence of a distributable event.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsors and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(g) Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: The investments in the account consist primarily of mutual funds, which are valued at the daily closing price as reported by the fund. The mutual funds held in the account are open-end mutual funds that pre-registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held in the account are deemed to be actively traded.

Common/collective trust funds: Valued at the NAV of units of the common/collective trust fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(4) Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash, investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (the custodian of the Plan).

(5) Plan Termination

Although they have not expressed any intent to do so, the Plan Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(6) Tax Status

The Plan and trust have been established using a non-standardized prototype plan designed and maintained by the Plan's third-party administrator. The IRS has determined and informed the prototype sponsor by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(7) Party-in-Interest Transactions

As described in note 1(g), Plan assets include forfeited nonvested accounts. These amounts are held in a cash reserve account by State Street Bank and Trust Company (State Street). State Street is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. Therefore, these related transactions qualify as party-in-interest transactions. All other transactions which may be considered parties-in-interest transactions related to normal plan management and administrative services, and the related payment of fees.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
