## **Independent Auditors' Report**

To the Administrative Committee of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Coulter Affiliates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C)[ERISA section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Coulter Affiliates 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1: Description of the Plan**

The following description of the Plan provides only general information. Participants should refer to the pamphlet "Description of Employee Benefits" for a more complete description of the Plan's provisions.

**General**

The Coulter Affiliates 401(k) Plan is a defined contribution plan. The Plan covers all of the employees of the Coulter Auto Group and was adopted in 1985. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute up to 75% of pretax annual compensation, as defined in the plan or by the Internal Revenue Code annual limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Profit sharing amounts may be contributed at the option of the Employers' board of directors and are invested in a portfolio of investments as directed by the Participants. Contributions are subject to certain limitations. Employer contributions are made in an amount determined by the Employers' Board of Directors at their sole discretion. The Employer match for the year ended December 31, 2024, was \$179,348.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Employers' contribution, (b) plan earnings, (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employers' matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**NOTE 1: Description of the Plan (Continued)**

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1-5 years or may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Interest rates on loans outstanding were from 4.25% to 9.50%. Principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The plan allows for loans and hardship withdrawals.

**Forfeitures**

As of December 31, 2024, and 2023 forfeited non-vested accounts totaled \$38,871 and \$17,015 respectively. These accounts may be used to pay Plan expenses, be made available to reinstate previously forfeited account balances or to reduce Employer contributions. The forfeitures account was reduced by \$8,670 to pay for the employer match and plan administrative expenses for the year ended December 31, 2024.

**NOTE 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No reserve for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the loan balance is reduced, and the benefit payment is recorded.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative expenses**

Substantially all the expenses of maintaining the plan are paid from plan assets as specified in the plan document. Management fees and expenses of the Plan's investment funds are paid by each fund and reflected in the net appreciation (depreciation) in fair value of investments. Part of the management fees are refunded to the Plan based on revenue sharing agreements with respect to certain funds and reduce overall administrative expenses.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with the corresponding reduction to participant's contributions. The plan did not have any excess contributions for the year ended December 31, 2024.

**NOTE 3: Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan)

**NOTE 4: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common Collective Trusts:* Valued daily at the net asset value per unit, as practical expedient to estimate fair value, as determined by each common collective trust as of the valuation date. The investments in the common collective trusts are primarily composed of indirect investments in fully-benefit responsive contracts.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Stable Value Fund's objective is to protect principal while providing a higher rate of return than shorter maturity investments such as money market funds or certificates of deposit. To achieve this, the Fund invests in a fixed-income security portfolio of fixed-income securities and a value guarantee (wrapper) provided by a third party. The plan's stable funds are the Pimco Stable Income Fund and Putnam Stable Value Fund.

**NOTE 5: Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter the plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more than likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan, and concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recording of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions: however, there are currently no audits for any periods in progress.

**NOTE 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7: Related Party Transactions**

Certain Plan investments are shares of registered investment companies that were managed by the Fidelity Investments Institutional, an affiliate of Fidelity Trust Company. The plan paid management fees of \$34,517 to Fidelity Investments Institutional for the year ended December 31, 2024. The Plan also paid certain expenses related to the investment activity. These transactions qualify as party-in-interest transactions but are exempt under ERISA.

**NOTE 8: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE 9: Reconciliation of Financial Statements to Form 5500**

There were no difference between the form 5500 and the financial statements.

**NOTE 10: Non-Exempt Prohibited Transactions**

During 2024, the Company failed to remit employees' contribution in a timely manner. The amount representing lost earnings was \$29. The correction was made in 2024.

**NOTE 11: Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
