### Note 1: Description of Plan

The following description of the Kayser Automotive Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established by Kayser Ford, Inc. and its affiliates, Kayser Chrysler Center, Inc., Kayser Chrysler Center of Watertown, Inc., Vision Auto Group, Inc. (DBA S&L Motors, Inc.), Kayser Chevrolet, Inc., Kayser Ford of Sauk City, LLC, S&L Ford, LLC, and Kayser Chevrolet GMC, LLC (collectively the "Employer") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Employees who have completed at least 6 months of service with the Employer, as defined in the Plan, and are age 21 or older are eligible to participate, other than collectively bargained employees, non-resident aliens and leased employees.

#### Contributions

Each year, participants may contribute up to 80% of annual compensation on a pre-tax basis (participant salary reduction contributions) or roth elective deferrals, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Employer may elect to contribute to the Plan through a discretionary and/or discretionary matching contribution at the discretion of the Employer's Board of Directors. For 2024, the Employer made a discretionary matching contribution equal to 50% of the first 4% of the participant's contribution. A participant may direct Employer and participant contributions into any combination of investment options offered by the Plan. Annual contributions from all sources are subject to certain limitations as defined by the Internal Revenue Service (IRS).

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, and allocations of (a) discretionary Employer contributions, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus earnings (losses) thereon. Participants who leave the Plan because of death, normal retirement or disability retirement, as defined in the Plan, are considered 100% vested. Employer discretionary contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

#### Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of 50% of their vested balances or \$50,000. Loan terms range from one to five years, unless made for the purchase of a primary residence. Loans are secured by the participant's investment accounts and bear interest at rates that range from 4.25% to 9.50%, which determined using the prime rate plus 1%, as defined in the plan agreement. Principal and interest payments are paid through payroll deductions.

#### Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, retirement or termination of employment as defined in the plan agreement. The Plan provides for normal retirement at age 65. In-service withdrawals are permitted upon attainment of age 59 ½. The total vested portion of a participant's account balance is distributed in the form of a lump sum, partial lump sum, or installments. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,096 and \$8,528, respectively. The Employer may decide in its discretion how to treat forfeitures under the Plan in accordance with the plan agreement. During 2024, \$8,855 of forfeited nonvested accounts were used to reduce Employer discretionary matching contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan agreement.

#### **Excess Contributions Payable**

At December 31, 2024, amounts payable to participants totaling \$78,916 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. Excess contributions for the year ended December 31, 2023 totaled \$13,708.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan can be paid by the Plan and/or the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to Plan record-keeping and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Interest-bearing cash:* Comprised of a bank money market account valued at cost plus accrued interest, which approximates fair value.

*Life insurance contracts:* Valued at the cash surrender value of the insurance policy, which approximates fair value.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, non-interest-bearing cash, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by First Business Bank, the Trustee of the Plan.

### Note 5: Party-in-Interest Transactions

Fees incurred and paid to First Business Bank for recordkeeping and investment management services were \$100,713 for the year ended December 31, 2024. First Business Bank is the Trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer discretionary contributions.

### **Note 7: Tax Status**

The Employer adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Reclassification**

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 classifications.

Plan assets amounting to \$1,070,368 (Charles Schwab Money Market) have been reclassified from interest-bearing cash to investments in the 2023 Statement of Net Assets Available for Benefits.
