## INDEPENDENT AUDITOR'S REPORT

To the Participants, Plan Administrator, and 401(k) Committee  
Bennett Companies 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bennett Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Note 1 – Description of the Plan**

Bennett Steel Fabrication, Inc. (the Company) sponsors the Bennett Companies 401(k) Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan established for the benefit of employees of the Company and adopting employers (collectively, the Employer), except for leased employees, union employees, residents of Puerto Rico, and nonresident aliens with no United States source income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The 401(k) Committee, which is appointed by the Company's board of directors, is responsible for the oversight of the Plan. Nationwide Trust Company, FSB (Nationwide) maintains the records of the participant data and holds the Plan assets. Nationwide Life Insurance Company (Nationwide Life) is an affiliate of Nationwide and is the issuer of the guaranteed investment contract.

##### Eligibility

Nonexcluded employees who have reached 18 years of age and have completed two months of service are eligible to participate in the Plan. Eligible employees may enroll in the Plan on the first day of the month after or coinciding with satisfying eligibility requirements. Participants must complete one year of service, as defined in the Plan document, to be eligible for Employer contributions and entry dates are January 1 and July 1 of each Plan year.

##### Contributions

Participants may contribute up to 100% of their compensation, as defined in the Plan document, as either pretax or Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan provides for Employer safe harbor matching contributions equal to 100% of deferrals up to 3%, plus 50% of deferrals greater than 3% not to exceed 5% of the participant's compensation.

The Plan also provides for additional Employer matching contributions at the discretion of the Company's board of directors. For the year ended December 31, 2024, there were no additional Employer matching contributions.

Additional amounts may be contributed by the Employer under the Plan's profit sharing provisions at the discretion of the Company. Participants must complete 1,000 of service during the Plan year and be employed on the last day of the Plan year to receive an allocation of Employer profit sharing contributions. The allocation of Employer profit sharing contributions is based on the one group per participant method. For the year ended December 31, 2024, there was \$60,000 in Employer profit sharing contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations of the Internal Revenue Code (the Code).

#### Participant accounts

Each participant's account is credited with participant contributions, Employer safe harbor matching contributions, additional Employer matching contributions, and allocations of Employer profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions and Employer contributions, plus actual earnings thereon.

#### Notes receivable from participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the difference between the highest outstanding loan balance during the preceding 12-month period and the outstanding loan balance on the date the loan was made, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 10.50%, which is based on prime rate plus 2% on the date of origination. Participants may only have two loans outstanding at any given time. Terms range from one to five years or up to 15 years for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

#### Payment of benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$7,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the Plan administrator.

#### Forfeitures

Forfeitures may be used to restore participant balances previously forfeited, to pay Plan administrative expenses, to reduce Employer contributions, or may be reallocated to participants as an additional Employer contribution. The Plan had \$662 and \$0 in unallocated forfeitures as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures in the amount of \$1,001 were used to pay Plan administrative expenses.

#### Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup. The Plan participates in an agreement with Nationwide, where excess revenue may be returned and deposited into an unallocated expense budget account. The amounts in the unallocated expense budget account may be used to pay reasonable and necessary Plan expenses or may be allocated to participants. There were no unallocated funds in the expense budget account as of December 31, 2024 and

2023. For the year ended December 31, 2024, the Plan used \$504 from the expense budget account to pay certain Plan expenses.

## **Note 2 – Summary of Significant Accounting Policies**

### Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the valuation policies utilizing information provided by Nationwide and Nationwide Life. See Note 4 for discussion of fair value measurements and Note 6 for contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for delinquent notes receivable from participants has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

### Contributions

Participant contributions, and the related Employer safe harbor matching and additional matching contributions, are recorded in the year in which the participant deferrals are withheld from compensation. Employer profit sharing contributions are recorded once approved by the Company for the respective Plan year.

### Payment of benefits

Benefit payments are recorded when paid. There were no benefits requested before year-end that were not paid.

### Subsequent events

The Plan administrator has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

### Note 3 – Information Certified by Nationwide and Nationwide Life

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide and Nationwide Life have certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information, except for notes receivable from participants, included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

### Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

*Collective investment funds* – Stated at fair value as determined by the issuer of the collective investment funds based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) of units of the collective investment funds. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be

probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Mutual funds* – Valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 6 – Fully Benefit Responsive Investment Contract**

The Plan holds a traditional guaranteed investment contract issued by Nationwide Life. This contract meets the fully benefit responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment account at contract value with no redemption requirements. Nationwide Life maintains the contributions in a general account.

Nationwide Life is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract has no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate is based on a formula established by Nationwide Life. The net rate and crediting rate are the same, and as of December 31, 2024, were 1.94%. Such rates are reviewed on a quarterly basis for resetting.

The contract has a 30-day notification requirement for any of the following events:

- Amendments or modifications to the Plan documents
- Change in the administrative practice adhered to by the Plan
- Change in investment options offered by the Plan
- Reduction in the number of participants
- Full or partial Plan termination
- Merger with another plan for all or a class of participants

The guaranteed investment contract allows Nationwide Life to terminate the agreement on the date coinciding with the latest of the following: the day the guaranteed fund is exhausted by withdrawals, the day no further annuity payments are payable, or 12 months following the effective date of the contract if no deposits have been made to the contract or to a companion contract.

The contract also includes certain events, such as Plan termination or merger, or a reduction in the number of participants, that might limit the ability of the Plan to transact at contract value with Nationwide Life.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Nationwide Life or that might limit the ability of the Plan to transact at contract value with the participants.

## **Note 7 – Related Party and Party-in-Interest Transactions**

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Certain administrative expenses, totaling approximately \$22,000, were paid by the Company on behalf of the Plan for the year ended December 31, 2024. The Company does not expect reimbursement from the Plan for these expenses.

The fully benefit responsive investment contract is issued by Nationwide Life. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 9 – Tax Status**

The Company adopted a preapproved defined contribution plan (the Preapproved Plan) sponsored by DST Retirement Solutions LLC. The Internal Revenue Service has determined and informed the Preapproved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Preapproved Plan is designed in accordance with the applicable sections of the Code. The Preapproved Plan's opinion letter is being relied on by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

### **Note 10 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
