### Note 1: Description of Plan

The following description of the Entrust Corporation Employee Investment Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Entrust Corporation Employee Investment Plan (The "Plan"), formerly known as "Entrust Datacard Corporation Employee Investment Plan" is a defined-contribution plan. Entrust Corporation (the "Company" or "Employer") is the plan sponsor and administrator. Principal Trust Company is the Trustee of the Plan. All the funds are invested in the specific funds, trusts, bonds or stocks as designated by the participants. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted changes to distributions of vested accounts less than \$7,000 in 2024. Plan management will determine the remaining optional provisions to elect in the future.

#### Participation

To be eligible to participate in the Plan, an employee must be a qualified employee in the United States who is regularly scheduled to work 1,000 or more hours per year. Newly hired employees are automatically enrolled in the Plan at a deferral rate of 6% with automatic increases of 1% each year on December 31, unless the employee elects to waive contributing to the Plan or chooses to enroll at a different contribution percentage. The automatic contribution increase will not cause a participant's combined before-tax and after-tax contribution percentage to exceed 10%.

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. One year of service is defined as 1,000 hours during the plan year. Employees vest at a rate of 50% per year and are 100% vested after two years of employment.

### Note 1: Description of Plan (Continued)

#### Contributions

Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matched employee contributions dollar for dollar up to 6% of eligible compensation for the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, Company safe harbor matching contributions, and allocations of plan earnings (losses). Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Loan Provision

The Plan allows participants to borrow funds from their accounts. The maximum loan amount is 50% of a participant's vested account balance or \$50,000, whichever is less. Payroll deductions are required to repay the loan in 5 years or less at an interest rate determined according to the provisions of the Plan. The loan must be repaid in full within 60 days after retirement or termination. If the termination was a result of an involuntary layoff, the employee has the option to pay back the loan by making periodic payments according to the amortization schedule with the Trustee.

Section 2202 of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) enacted on March 27, 2020, permits an additional year for repayments of loans for new and current loans, though interest will accrue.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. If no election is specified by a participant upon termination, vested balances less than \$7,000 and greater than \$1,000 are automatically rolled into another qualified plan or designated IRA. For terminated participants with vested balances less than \$1,000, amounts are paid out in the form of a lump sum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

### **Note 1: Description of Plan (Continued)**

#### **Forfeitures**

Forfeitures arising from nonvested portions attributable to terminated employees may be used by the Company to reduce administrative costs of the Plan or to reduce the Company's matching contribution. Forfeited amounts are used to cover consulting fees, employee financial planning and education services, Trustee fees, and to provide necessary amounts previously forfeited by participants but reinstated according to the Plan terms. At December 31, 2024 and 2023, the accumulated forfeiture balance totaled \$359,630 and \$270,573, respectively. The Company used \$320,775 and \$442,843 of forfeitures in 2024 and 2023, respectively.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Presentation**

The accompanying financial statements have been prepared in conformity with U.S. generally accepted accounting principles (GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investments purchased and sold through Principal Self-Directed Brokerage, the brokerage service available through Principal Trust Company, allows plan participants to develop a portfolio of individual stocks, bonds, and mutual funds that are valued on the basis of readily determinable market prices.

#### **Note Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor, and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to record-keeping services are charged directly to plan participants based on their perspective account balances and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and included in net appreciation in fair value of investments.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 or 2023.

*Mutual funds and self-directed brokerage accounts:* These investments consist of various publicly traded mutual funds and common stocks. The fair values are based on the closing price reported in the active market in which the individual securities are traded.

*Common collective trust funds:* Valued at the net asset value (NAV) of units of a bank collective trust which are composed primarily of fully benefit-responsive investment contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee of the Plan.

### **Note 5: Party-in-Interest Transactions**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Certain plan investments are managed by Principal Trust Company. Principal Trust Company is the Trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services were \$235,230 and \$169,373 for the years ended December 31, 2024 and 2023, respectively, and are included in administrative expenses.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 7: Tax Status**

The IRS has determined and informed the Plan by a letter dated August 7, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
