Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Notes to Financial Statements**

**1. DESCRIPTION OF PLAN**

The following description of Smith-Emery International, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, effective September 29, 1944, and most recently amended and restated effective January 1, 2022, under the provisions of Section 401(a) of the Internal Revenue Code (IRC) which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of Smith-Emery International, Inc. and participating employers (collectively, "the Company"). Employees of the Company except for union, non-resident alien, leased, and Puerto Rico based employees are eligible to participate in the Plan if they have completed at least one month of service and have attained age 21. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a certain amount of their annual compensation as defined in the Plan through salary deferral payroll deductions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company may make discretionary matching and discretionary non-elective contributions for eligible employees. For the year ended December 31, 2024, there were no matching or non-elective contributions contributed to the Plan.

Participant Accounts

Participants direct the investment of their accounts into various investment funds offered by the Plan. Each participant's account is credited with the participant's contribution, the discretionary matching and non-elective contributions, an allocation of plan earnings and expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution to the participants' accounts is based on years of continuous service. A participant is 100 % vested after five years of credited service, or in the event the participant reaches normal retirement age, dies or becomes totally disabled.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable interest rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates on the notes outstanding at December 31, 2024 were 3.25% to 8.50%. Principal and interest is paid ratably through payroll deductions.

**1. DESCRIPTION OF PLAN (Continued)**

Payment of Benefits

Upon termination of employment, a participant may withdraw his or her accumulated balances in the Plan. If a participant has reached the age of 59 ½, distributions may be made, at the participant's election, from any account which are 100% vested without requiring the participant to terminate employment. Hardship withdrawals are allowed from the participant's elective account only, consistent with ERISA requirements. Only lump sum cash distributions are permitted.

Participants Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts were \$93,360 and \$90,054, respectively. Forfeited nonvested accounts, if any, will be used to pay plan administrative expenses or as a credit to reduce future Company's contributions. For the year ended December 31, 2024, no forfeiture balance was used to reduce employer contributions or pay plan expenses.

Plan Termination

Although they have not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts and all accounts would be distributed in the form and manner determined by the Plan document.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value. Refer to Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion regarding fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, which approximates when interest is received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income associated with the notes receivable is recorded as earned as per the related loan amortization schedules. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Administration Expenses

Certain expenses of maintaining the Plan are paid directly by the Company, at its option, and are excluded from these financial statements. Fees related to specific participant transactions, such as for participant loans and benefit payments, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid or upon distribution.

**3. FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN AND TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, which include investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in fair value of investments and interest income from notes receivable from participants for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower), the custodian and trustee of the Plan, in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**4. INVESTMENTS AT FAIR VALUE - FAIR VALUE MEASUREMENT**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments in Level 1 include listed equities and other securities held in the name of the Plan, and exclude listed equities and other securities held indirectly through commingled funds.

Level 2 - Pricing inputs, including broker quotes, are generally those other than exchange quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value is determined through the use of models or other valuation methodologies.

Level 3 - Pricing inputs are unobservable for the investment and include situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. Investments that are included in this category generally include privately held investments and partnership interests.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds

Mutual funds are carried at fair value using quoted prices in active markets or level one inputs under ASC 820.

**5. INVESTMENT AT CONTRACT VALUE - FULLY BENEFIT RESPONSIVE**

The Plan has entered into a benefit-responsive traditional investment contract with Empower Trust Company, LLC (“Empower”). The Key Guaranteed Portfolio Fund investment choice is invested in the general account of Empower. The account is credited with earnings based upon interest rates set monthly and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. As described in Note 2, because the Key Guaranteed Portfolio Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Empower contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**6. PARTY-IN-INTEREST TRANSACTIONS**

The Plan has deposits in the general account of Empower. Empower is the investment contract issuer. In addition, certain plan investments are shares of mutual funds managed by Empower. Fees paid to Empower related to investment services including other investment management companies, recordkeeping services and third party advisory services are included in the net appreciation in fair value of the Plan investments.

For the year ended December 31, 2024, the Plan paid \$54,990 for services rendered by Empower as the plan recordkeeper and investment advisory services. The above transactions, including notes receivable from participants, qualify as allowable party-in interest transactions for which there are statutory exceptions.

**7. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the plan year ended December 31, 2024, certain participant contributions were not remitted to the Plan within the time frame required by the Department of Labor's regulations. Such late remittances constitute prohibited transactions under ERISA.

The Plan Sponsor subsequently remitted the delinquent contributions, along with lost earnings, directly to the affected participants' accounts. These corrections were made outside of the Department of Labor's Voluntary Fiduciary Correction Program (VFCP).

**8. PRIOR PERIOD RESTATEMENT**

The accompanying statement of net assets available for benefits as of December 31, 2023, has been restated to correct an error made regarding misclassification of investments held in fully benefit-responsive investment contract presented as insurance company general account which was discovered subsequent to issuance. The effect of the restatement caused a reclass of \$2,162,759 from insurance company general account to investment at contract value on the statement of net assets available for benefits, removed from Note 4 Fair Value Measurements and included in Note 5 Investment at Contract Value - Fully Benefit Responsive. This reclassification had no effect on previously reported changes in net asset available for benefits.

**9. TAX STATUS**

The Internal Revenue Services (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (none recognized) for any uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities available in accordance with the Plan's investment agreement, through participant direction. Due to the inherent risk associated with investment securities, it is possible that changes in the value of investment securities can occur in the near term that could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**11. SUBSEQUENT EVENTS**

The Plan Committee evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.
