## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

A. DESCRIPTION OF PLAN

The following description of Deringer-Ney Inc. 401(k) and Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering all eligible employees of Deringer-Ney Inc. Company employees who have six months of service are eligible to participate in the salary reduction and matching contribution portion of the plan. Employees who have completed two years of service with at least one thousand hours of service each year are eligible to participate in the discretionary profit sharing contribution portion of the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. *Contributions.* Each year, participants may contribute up to the maximum amount allowed under Internal Revenue Code Section 402(g). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 50 percent of the first 6 percent of base compensation that a participant contributes to the Plan. For the year ended December 31, 2024 the Company made profit sharing and match contributions of \$1,771,285. The Company contributes to the Plan each year an amount not to exceed the maximum deduction allowed under Internal Revenue Code Section 404(a)(3)(A). Company contributions for any plan year shall be made out of the net profits of the Company for such year and out of accumulated net profits from proceeding years. Effective June 24, 2022 the Plan includes an auto-enrollment provision whereby all newly eligible employees are offered an automatic enrollment feature after six months of service unless they affirmatively elect out to participate in the auto-enrollment provision. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The deferral rate of 1% has yearly escalations depending on the time of automatic enrollment.
3. *Participant's Account.* Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are immediately vested in their elective deferral contributions and rollover plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts, plus earnings thereon, is based on years of continuous service. A participant is 100 percent vested after five years of credited service on all employer matching contributions. A participant is immediately vested on any discretionary Company profit sharing contribution.
5. *Notes Receivable from Participants.* Participants may borrow from their elective deferral accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested interest in the Plan. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.
6. *Payment of Benefits.* Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or substantially equal installments over a period not exceeding ten years from date of termination or in the case of a retired participant, over a period not to exceed such participant's normal life expectancy.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

A. DESCRIPTION OF PLAN - CONT.

7. *Forfeited Accounts.* The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Any forfeiture attributable to matching contributions will be used to reduce any matching contributions. At the beginning of the plan year the beginning balance was \$4,810. During plan year 2024, forfeited non-vested accounts totaled \$54,950. In 2024, employer matching contributions were reduced by \$58,004. As of December 31, 2024, there is an ending balance of \$1,756 in forfeited accounts to offset future employer contributions.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments are valued at quoted market prices.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Payment of Benefits*

Benefits are recorded when paid.

*Investment Options*

Upon enrollment in the Plan, a participant may direct contributions in a variety of investment choices. Investment choices are more fully described in the Plan's literature. Participants may change their investment options at any time.

NOTES TO FINANCIAL STATEMENTS

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONT.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

C. TAX STATUS

The Company has adopted a non-standardized prototype plan sponsored by Vanguard. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code. The Plan Administrator does not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service opinion letter will affect the qualified and tax-exempt status of the Plan and the Trust, respectively. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

D. SUBSEQUENT EVENTS

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

E. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, interest on notes receivable and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

F. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

G. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by an affiliate of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company acts as a trustee for only those investments as defined by the Plan. Additionally, certain plan assets are loans to participants who are employees of the Company. Transactions in such investments and loans qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid by the Plan for administrative expenses amounted to \$15,289 for the year ended December 31, 2024. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Employer are excluded from these financial statements.

H. FAIR VALUE MEASUREMENTS

The Fair Value Measurements and Disclosures Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan did not hold any investment assets classified as Level 3. Level 1 of the fair value hierarchy under FASB ASC 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investments are valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan are open-end mutual funds that are registered with the SEC. These fund are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
