Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Midwestern University Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Midwestern University Retirement Plan (the Plan) provides general information about the Plan's provisions. Midwestern University (the University) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan covering substantially all eligible employees, defined as those who have attained the age of 18 and are employed by the University as members of the faculty, staff, or administration working 20 hours per week or more. Eligible participants are enrolled in the Plan once they have completed the appropriate application.

The University is responsible for the general administration of the Plan. Teachers Insurance and Annuity Association of America (TIAA) is the record-keeper and custodian for substantially all assets held by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Employer contributions are made to the Plan by the University, regardless of whether the employee contributes to the Plan. The University contributes 10% of an employee's eligible compensation after the employee has completed one year of service.

Notwithstanding anything in the Plan or Adoption Agreement to the contrary, compensation for purposes of determining the amount of any employer contributions under Section Three, Part E of the Adoption Agreement shall include only those amounts classified and reported in the University's payroll system using the following pay codes: regular time, personal days, vacation days, additional vacation, flex/sick, additional flex, short-term disability, bereavement, consulting, meetings/conferences, holiday time, jury duty, retro earnings, overtime, double time, military pay, grant recaptured salary payments, dental clinic incentive payments, multispecialty clinic incentive payments, shift differential pay, quarantine, and volunteer day.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

If employees do not enroll prior to the start of the month in which they are eligible to participate in the Plan, the University will automatically enroll them in the Plan to receive employer contributions. If employees are automatically enrolled, their employer contributions are invested in the appropriate TIAA Lifecycle fund based upon their ages. Employees may change this allocation at any time, and they must also appoint beneficiaries.

Employee Contributions

Upon their hire date, participants may contribute a portion of their pretax or after-tax (Roth effective February 2024) compensation, up to the maximum annual amount allowed by the Internal Revenue Code (the Code). As permitted under Internal Revenue Service (IRS) regulations, additional contributions may also be available through the 15-Year Rule; calculations are required for each participant. Employees can elect a percentage of pay for their contribution to the Tax Deferred Plan or a flat dollar amount.

For both employer and employee contributions, participants may direct the funds into various investment options offered by the Plan and can change their investment options on a daily basis.

Participant Accounts

Each participant's account is credited with the participant's contributions, the University's contributions, and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participants' shares of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their accounts.

Forfeitures

A forfeiture may arise if an adjustment is made to an employee's account due to overfunding of the account based upon annual limits that apply to the employer contributions. The adjustment is made in the plan year immediately following the plan year when the overfunding occurred. The adjustment is then placed in the forfeiture account for use in offsetting employer contributions in future plan years.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Loans to Participants

Prior to September 9, 2021, participants could borrow directly from TIAA using a portion of their plan accounts as security for the loans. Such loans are subject to certain limitations. Applicants receiving such loans are required to pledge as collateral the annuity account value of the loan amount for the period of time the loan is outstanding. Loan balances outstanding from TIAA to the Plan's participants were \$214,000 and \$315,000 as of December 31, 2024 and 2023, respectively. As such, annuity account values of \$214,000 and \$315,000 as of December 31, 2024 and 2023, respectively, serve as collateral for the related loans, which are included in investments on the accompanying statements of net assets available for benefits.

Effective September 9, 2021, the Plan was amended to allow participants to borrow directly from their plan accounts. Participants may borrow between \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a principal residence. A participant may have a maximum of three loans outstanding at any time. Loans bear interest at one percentage point above the prime rate published by *The Wall Street Journal* on the date the loan is processed. Participants are charged a one-time origination fee and an annual maintenance fee. The loans are secured by the balance in the participant's account.

Payment of Benefits

Upon separation from service with the University due to death, disability, retirement, or termination, participants or their beneficiaries may elect to receive either a lump sum or quarterly or annual installment payments. Certain annuity contracts are subject to mandatory installment payments.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS, and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the University, as provided by the Plan's provisions. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Certain other expenses are paid by the University. Expenses paid by the University are excluded from the accompanying financial statements.

Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants remain fully vested in their account balances. To the extent participants are vested in an annuity contract, they will receive a distribution of the contract.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes and supplemental schedule. Although estimates are considered to be fairly stated at the time the estimates are made, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

The Plan holds investments in TIAA Traditional Annuity Contracts (annuity contracts). These annuity contracts guarantee principal and a specified interest rate, with the opportunity for additional amounts as determined annually by TIAA's Board of Trustees. Certain restrictions limit participant access to funds based on the type of contract held. Participants with a Retirement Annuity (RA) contract are unable to receive lump-sum cash withdrawals from the TIAA Traditional Annuity Contract, and transfers must be spread over a ten-year period. Participants with a Group Retirement Annuity (GRA) contract are able to receive a lump-sum withdrawal from the TIAA Traditional Annuity Contract only within 120 days after termination of employment and subject to a surrender charge. All other transfers from the GRA contracts must be spread over a ten-year period (five years for withdrawals after termination of employment). Given the aforementioned limitations on participant access to the funds, management does not consider the contracts to be fully benefit responsive. Management has determined that the contract value of the non-benefit-responsive contracts is a reasonable approximation of their fair value.

The Plan also invests in the TIAA Traditional Group Supplemental Retirement Annuity (GSRA) and the TIAA Supplemental Retirement Annuity (SRA) contracts, which are fully benefit-responsive contracts. These investments are recorded at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value represents contributions made plus earnings, less participant withdrawals and administrative expenses.

2. Summary of Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

Other than certain mutual funds of \$1,534,125 and pooled investment funds of \$252,857 as of December 31, 2023, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by TIAA-CREF, custodian of certain plan assets and as agent for TIAA Trust Company, FSB, directed trustee, and Newport Trust Company LLC, AXA (Equitable Life), ING (Relistar Life), Fidelity and Metlife, additional custodians of certain plan assets.

4. Fair Value Measurements

Accounting Standards Codification 820, *Fair Value Measurement* (ASC 820), defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). ASC 820 includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include the University's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for assets measured at fair value:

Mutual funds: Valued at quoted market prices, which represent the net asset value of shares held at year-end.

Non-benefit-responsive annuity contracts: Valued as described in Note 2.

Variable annuity contracts: Valued at the net asset value of units held by the Plan at year-end as determined by the issuer.

Pooled separate accounts: Valued at the net asset value of units held by the Plan at year-end as determined by the issuer.

5. Fully Benefit-Responsive Annuity Accounts

As described in Note 2, the Plan invests in GSRA and SRA fully benefit-responsive investment contracts.

TIAA maintains the contributions in its general account. TIAA's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the issuer or otherwise.

All investment contracts through the TIAA Traditional Account are directly between TIAA and the participants. Benefit payments from the contracts are paid as an annuity or a lump sum, as defined in the contracts and as elected by the participant upon meeting the eligibility requirements.

There are no conditions specified in any of the contracts under which participant withdrawals and transfers would be restricted or made at a value other than contract value or the annuity or lump-sum benefit, as defined in the contracts. The contracts do not provide any provisions that would allow the issuer to terminate the contracts between the issuer and the participants.

The crediting interest rates of the fully benefit-responsive contracts may vary from participant to participant. The crediting rates are based on an agreed-upon formula, as defined in the contract agreement. The guaranteed annual interest rate is 3% for all premiums remitted since 1979 under the SRA and GSRA contracts. Such interest rates are reviewed on a periodic basis and may, from time to time, have a new rate substituted for the one in the current certificate. A new rate will apply to only benefits arising from any premiums, additional amounts, and internal transfers applied to the Traditional Annuity while such rate schedule is in effect and will not affect any benefits purchased prior to the change, as defined in the contracts.

The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers, and withdrawals into/out of the contracts; and the duration of the underlying investments backing the contract.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

7. Tax Status

The underlying prototype plan has received an opinion letter from the IRS dated August 7, 2017, stating that the written form of the underlying prototype document is qualified under Section 403(b) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 403(b) of the Code, and, therefore, the related custodial accounts and tax-deferred annuities are tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related custodial accounts and tax-deferred annuities are tax- exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Transactions With Parties-in-Interest

The Plan holds funds managed by TIAA. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. All expenses incurred in the administration of the Plan are paid directly by the University.

9. Subsequent Events

The University evaluated events and transactions occurring subsequent to December 31, 2024 through October 9, 2025, the date the accompanying financial statements were available to be issued. During this period, there were no subsequent events requiring recognition or disclosure in the financial statements.
