Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CommonBond Communities 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CommonBond Communities 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. DESCRIPTION OF THE PLAN

The following description of the CommonBond Communities 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan is a single-employer defined contribution safe harbor 401(k) profit sharing plan covering substantially all employees who are age twenty-one or older. An employee enters the Plan on the first day of the month following the date of hire. The Plan excludes employees whose employment will be for a specific term of less than 12 months; part-time, temporary, or seasonal employees; and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA), as amended. The Plan's trustee is The Standard Insurance Company (the trustee) and the Plan's Sponsor and Administrator is CommonBond Communities (the Employer). CommonBond Housing is a participating employer in the Plan.

Investments held with The Standard Insurance Company are invested in pooled separate accounts. Pooled separate accounts are each invested in a distinct underlying mutual fund. The fair value of each pooled separate account equals the net asset value of the underlying mutual fund shares which are actively traded. A pooled separate account is a fund with an insurance company in which at least two investors pool their funds together to purchase shares of an underlying investment.

Contributions - Plan participants are allowed to make elective pre-tax and Roth deferral contributions of up to 100% of eligible wages, subject to Internal Revenue Code limitations. The Plan includes an automatic enrollment feature, whereby participants are enrolled in the Plan at a 6% deferral rate, escalating to up to a 10% deferral rate in subsequent years, unless elected otherwise. The Plan allows participants aged 50 and older to make catch up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans.

The Employer makes safe harbor matching contributions allocated to those who elect salary deferral contributions. Safe harbor matching contributions are equal to 100% of the first 1% of compensation and 50% of the next 5% of compensation that a participant contributes to the Plan. A participant must complete three consecutive months of employment in order to be eligible for the Employer matching contribution, unless the participant terminates employment because of death, disability, or attainment of normal retirement age (65). Contributions are subject to certain limitations.

Each year, at its discretion, the Employer may choose to make an additional matching contribution allocated to all eligible participants equal to a uniform percentage of each tier of participant salary deferrals. The Employer will annually determine the uniform percentage. A participant must complete 1 hour of service during the Plan year and be employed on the last day of the Plan year in order to be eligible for the Employer discretionary matching contribution, unless the participant terminates employment because of death, disability, or attainment of normal retirement age (65). The Employer discretionary matching contributions will not exceed 4% of a participant's compensation. There were no Employer discretionary matching contributions made to the Plan for the years ended December 31, 2024 and 2023.

Each year, at its discretion, the Employer may choose to make a profit-sharing contribution allocated to all eligible participants. A participant must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year in order to be eligible for the Employer discretionary contribution, unless the participant terminates employment because of death, disability, or attainment of normal retirement age. There were no Employer discretionary profit-sharing contributions made to the Plan for the years ended December 31, 2024 and 2023.

Participant Accounts - Each participant's account is credited with the participant's contributions and qualified safe harbor matching contributions plus an allocation of (a) the employer's discretionary matching contributions, if any, (b) the employer's discretionary profit-sharing contributions, if any, and (c) Plan earnings, net of expenses. Allocations are based on account balances or compensation as defined in the Plan.

Vesting - The participant's elective deferral contributions and the earnings thereon are always 100% vested.

Vesting in Employer qualified safe harbor matching contributions and earnings thereon is based on the following schedule:

Notwithstanding the above, a participant's account will be fully vested upon death, disability, or attainment of normal retirement age of 65.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at varying rates from 2.56% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably either through payroll deductions or by direct payment from the participant.

Payment of Benefits - The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. If a participant terminates employment and the participant's account value is less than \$1,000, the balance is automatically distributed. Accounts with balances of \$5,000 or less are distributed in a single lump sum payment. If the participant's account value exceeds \$5,000, the Plan allows for the participant to elect single lump-sum payment, installment payments, and partial withdrawals. The Plan also allows for in-service withdrawals and hardship withdrawals subject to Plan provisions.

Forfeitures - Forfeited nonvested accounts are first used to pay administrative costs and then used to reduce future Employer matching contributions to the Plan. The forfeited nonvested amounts used to pay administrative costs and/or reduce Employer matching contributions were \$8,903 and \$20,868 during the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, there was \$96,305 and \$31,955 available to reduce future Employer contributions and pay administrative costs.

Investment Options - Participants may direct their contributions among the investment options offered by the Plan. Employer contributions are allocated on the same basis as participant contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles.

Estimates - The preparation of financial statements in accordance with generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses - The Employer pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodologies used to measure the fair value of the Plan's investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts - Pooled separate accounts (PSA's) are comprised of mutual funds held in sub-accounts of an insurance company. The fair value of each pooled separate account is determined using the value per unit, which is based on the value of the underlying mutual fund shares which are actively traded. There are no redemption restrictions or unfunded commitments in the pooled separate accounts.

Because Net Asset Value (NAV) is used as a practical expedient, these investments are not categorized within the fair value hierarchy. The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the pooled separate accounts could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS

The volume submitter plan document adopted by the Plan obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are held by The Standard Insurance Company, who is the Plan trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for consulting and recordkeeping services amounted to \$66,451 and \$66,643 for 2024 and 2023.

Notes receivable from participants qualify as party-in-interest transactions.

The Plan's sponsor, CommonBond Communities, pays certain expenses of the Plan.

8. SUBSEQUENT EVENTS

The Plan's Sponsor anticipates laying off a number of employees in 2025, which is expected to result in a partial plan termination. All affected participants are expected to become fully vested in their account balances at the date of the partial plan termination. Management does not believe this will have a material effect on the Plan's financial statements.

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available for issue.
