Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Leadwise 401(k) Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all salaried and hourly wage earning employees of CESO, Inc., Threecore, LLC, DDC Management, LLC, Matrix 5, LLC, Legacy5 Corporate Services, LLC, and Hartizen Homes, LLC (collectively the "Company" or Plan Sponsor) as a controlled group. Effective July 7, 2023, employees of TRG Advisors, LLC became eligible to participate in the Plan. Effective January 1, 2024, Matrix5, LLC was removed as a participating employer. The Plan allows all eligible employees of the Company, not covered by a collective bargaining agreement and not nonresident aliens who have three months of service and have attained age 18, to participate. Effective January 1, 2023, the Plan no longer allows cooperative (co-op) employees to participate in the Plan. Upon satisfaction of the eligibility requirements, employees may enter the Plan on the first day of the next payroll period. Additionally, the Plan contains an automatic enrollment provision. Under this provision, unless notified otherwise, upon meeting the requirements for eligibility, all eligible employees are enrolled into the Plan at a deferral rate of 5%. The Plan also includes a provision that those participants with a deferral rate greater than zero will have their deferral increased annually by 1% as a pre-tax deferral contribution until a deferral rate of 15% is reached. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. In addition, the Plan allows Roth 401(k) contributions. Effective May 8, 2023, in-plan Roth conversions are allowed. The Plan is also a safe harbor 401(k) plan which the Company matches 100% of elective deferrals up to 3% of compensation and 50% of elective deferrals on the next 2% of compensation. The Company may make additional matching contributions and/or non-elective discretionary contributions. For the years 2024 and 2023, the Company did not make these types of contributions to the Plan.

The Plan also includes a prevailing wage contribution provision. For each Plan year, the Company shall contribute, for each eligible employee who performs services covered by the applicable prevailing wage laws, such amount as the Company may determine is required to be contributed to the Plan under such laws to meet the required benefit levels for such Plan year. Due to Matrix5, LLC being removed as a participating employer as of January 1, 2024, no prevailing wage contributions were made in 2024. Prevailing wage contributions for 2023 totaled \$8,215. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

**Participant Accounts** - Fidelity Management Trust Company is the Trustee and Custodian of Plan investments. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution and employer contributions are to be invested.

#### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Vesting** - Participants are immediately vested in their voluntary contributions, rollovers, and corresponding earnings. Beginning January 1, 2015, participants are immediately vested in employer matching contributions under the safe harbor rules. Participants are immediately vested in employer prevailing wage contributions. For matching contributions made prior to January 1, 2015, and for additional matching and non-elective discretionary contributions, the following schedule will be used to determine vesting in these contributions and corresponding earnings:

<u>Completed Years of Service</u>	<u>Vesting Percentages</u>
Fewer than 3	0%
3 or more	100%

For those employees who began participating prior to October 1, 2016, discretionary profit sharing contributions follow a three-year vesting schedule (Year 1 - 0%, Year 2 - 20%, Year 3 - 100%). For participants that were terminated prior to October 1, 2016, discretionary profit sharing contributions follow a five-year vesting schedule (Year 1 - 0%, Year 2 - 20%, Year 3 - 40%, Year 4 - 60%, Year 5 - 100%).

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. Prior to January 1, 2024, if the participant's account balance was \$5,000 or less, the Plan Administrator could elect to automatically distribute the balance to the participant in a single-sum payment. Effective January 1, 2024, the account balance threshold for an automatic distribution was increased to \$7,000. In addition, participants may receive distributions of all vested amounts for qualified financial hardships.

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions and pay Plan expenses. Forfeitures in the amount of \$7,553 and \$5,621 were used during 2024 and 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$32 and \$35.

**Investment Options** - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options and deferral percentages at any time via telephone or the Internet.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Company pays certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 29, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, and interest and dividends for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Trustee of the Plan).

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

#### NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Money market fund:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Registered investment companies:* Valued at the quoted market prices of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 - RELATED PARTY TRANSACTIONS**

Certain Plan assets are invested with Fidelity Management Trust Company. Thus, Fidelity Management Trust Company, as Trustee defined by the Plan, qualifies as a party-in-interest. Fees paid by the Plan for Trustee services for the years 2024 and 2023 totaled \$70,768 and \$53,388.

Ironshore Financial, LLC, as a provider of investment advisory services, qualifies as a party-in-interest. Fees paid by the Plan for investment advisory services for the years 2024 and 2023 were \$22,500 and \$18,750.

The Company provides certain accounting, recordkeeping, and administrative services to the Plan, for which it receives no compensation.

#### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer portion of contributions.

#### **NOTE 7 - TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 9 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS**

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

#### **NOTE 10 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

For the years 2024 and 2023, there were no differences between the financial statements and the Form 5500.
