Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of S&S Truck Parts, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Merger In

As discussed in Note 1 to the financial statements, the Board of Directors of the Plan Sponsor voted, on October 20, 2023, to merge the Midwest Truck 401(k) Plan (the Midwest Plan) into the Plan effective January 1, 2024. All of the plan assets of the Midwest Plan, totaling approximately \$9,560,000, were transferred to the Plan by February 14, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the S&S Truck Parts, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan, which was most recently amended and restated effective January 1, 2024, is a contributory, defined contribution plan maintained for the benefit of all eligible employees, as defined by the Plan, of S&S Truck Parts, LLC (the Sponsor). The Sponsor is the Plan Administrator.

The Plan conforms to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and has been approved as being exempt by the Internal Revenue Service (IRS).

American United Life Insurance Company (AUL), a OneAmerica company (OneAmerica), is the custodian and recordkeeper for the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Eligibility: Employees are eligible to make participant-directed contributions after they have attained the age of 21 years. Eligible participants enter the Plan on the first day of each month.

The Plan's investments are 100% participant-directed.

Contributions: All contributions are recorded in the year in which the employee contributions are withheld from compensation. The Plan provides for the following contributions, subject to certain limitations, which are to be maintained in separate accounts for each participant.

Participant-directed contributions: Participants may elect to contribute pre-tax earnings up to current IRS regulations. Participants are permitted to designate a portion or all of their contributions to be Roth 401(k) contributions that are includable in the participant's gross income at the time deferred. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2024, upon eligibility, all employees who do not select a contribution percentage, if they do not opt out, are automatically enrolled in the Plan at a deferral rate of 6%.

Sponsor safe harbor matching contributions: The Sponsor contributes safe harbor matching contributions to all eligible participants, as defined, equal to 100% of the first 1% of the participant's eligible compensation, as defined, plus 50% of the next 5% of a participant's eligible compensation that is contributed to the Plan.

Sponsor discretionary matching contributions: The Sponsor may, but is not required to, make discretionary matching contributions on behalf of participating employees. No discretionary matching contributions were provided for the year ended December 31, 2024.

Sponsor discretionary nonelective contributions: The Plan allows for discretionary nonelective contributions to be made by the Sponsor at the Sponsor's discretion. No discretionary nonelective contributions were provided for the year ended December 31, 2024.

Rollover contributions: The Plan provides for participant rollovers to be made by the employee from amounts distributed or transferred from other qualified deferred compensation plans.

Notes to Financial Statements

Note 1. Description of Plan (Continued)

Participant accounts: Each participant's account is credited with the participant-directed contributions, allocations of the Sponsor's safe harbor matching contributions, any discretionary matching and discretionary nonelective contributions, rollover contributions, and allocation of investment earnings (losses), and administrative expenses. Allocations are based on participant earnings (losses), account balances or specific transactions, as defined. The benefit to which a participant is entitled is what can be provided from the participant's vested account.

Participants' contributions are credited to their respective accounts, as directed, as soon as practicable, after receipt. Investment income is allocated daily.

Participant investment options: Upon enrollment in the Plan, a participant directs their account balances to be invested in selected funds as made available and determined by the Plan Administrator. Participants are allowed to change their investment options on a daily basis.

Vesting: Participants are vested immediately in their participant-directed and rollover contributions plus actual earnings thereon. Effective January 1, 2024, vesting in the Sponsor's safe harbor matching, discretionary matching, and discretionary nonelective contribution portions of their account is based on years of service, with 100% vesting after two years.

Forfeitures: In the event of termination prior to full vesting, the nonvested portion is immediately forfeited. Forfeitures may be used to reduce future employer contributions or pay plan expenses. Forfeited nonvested accounts totaled approximately \$4,400 and \$6,200 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, nonvested forfeited accounts totaled approximately \$19,600. For the year ended December 31, 2024, forfeitures of approximately \$21,400 were used to reduce employer contributions.

Notes receivable from participants: Participants may borrow from their accounts a minimum loan of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's accounts and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Each participant note is considered an investment of that participant's account. Accordingly, principal and interest payments are credited to the respective participant's account. Notes are repaid over a period ranging from one to five years. The interest rates ranged from 4.25% to 9.75% at December 31, 2024 with maturities through November 2027. Principal and interest is paid ratably through payroll deductions. The participants may not have more than two loans outstanding at any time.

Note receivable balances at the time of a participant's termination of employment are treated as distributions based upon the terms of the Plan document.

Payment of benefits: On termination of service due to death, disability or retirement a participant or his beneficiary may elect to receive a single lump-sum payment equal to the value of the participant's vested interest.

Plan merger: Effective January 1, 2024, the Midwest Truck 401(k) Plan merged into the Plan. Net assets of approximately \$9,560,000 were transferred into the Plan in January 2024, with the remaining balance transferred in February 2024. As such, the transferred assets have been disclosed as a transfer to the Plan on the statement of changes in net assets available for benefits.

Notes to Financial Statements

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Valuation of investments: Investments are reported at fair value (except for direct investments in fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Investment contracts: Investments held by a defined contribution plan are required to be reported at fair value, except for direct investments in fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to direct investments in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition: Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule of assets (held at end of year). No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Administrative expenses: Administrative expenses of the Plan are charged against earnings except to the extent the expenses are paid by the Sponsor.

Payment of benefits: Benefit payments are recorded upon distribution.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and all assets will be liquidated and paid to participants.

Note 4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of pooled separate accounts: Valued at the total of the net asset value (NAV) of shares of mutual funds and cash held by the account at year-end. The Plan's interest in the pooled separate accounts is valued based on the information reported by the investment advisor. The NAV is used as a practical expedient to estimate fair value. The NAV of the pooled separate account itself is not publicly quoted but the values are not dependent on the input of any significant judgments or assumptions by management.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan Administrator evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Information Certified and Provided by AUL

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, that was prepared by or derived from information certified and provided by AUL and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from AUL that the information provided to the Plan Administrator by AUL related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets and income.

Note 6. Tax Status

The Plan is a nonstandardized preapproved plan sponsored by OneAmerica Financial Partners Inc. (OAFP) that has been adopted by the Sponsor. The preapproved plan provider obtained its latest opinion letter on September 19, 2020, by which the IRS has determined and informed OAFP that the Plan and related trust, as then designed, were designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits at December 31, 2024.

Note 8. Party-in-Interest Transactions

Certain employees of the Sponsor act as fiduciaries of the Plan and are responsible for the administration of the Plan. The employees are compensated by the Sponsor and do not receive any compensation from the Plan. In addition, certain administrative expenses are paid by the Sponsor on behalf of the Plan.

AUL provides administrative and recordkeeping services for which such transactions qualify as party-in-interest transactions. The Plan incurred fees to AUL of \$5,114 for the year ended December 31, 2024.

Certain Plan investments are managed by Mesirow Financial Investment Management (Mesirow), an investment advisor to the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan incurred fees to Mesirow of \$7,189 for the year ended December 31, 2024.

Certain Plan investments are managed by AUL, the custodian for the Plan and therefore, these transactions qualify as party-in-interest transactions.

Note 9. Investment Contract With Insurance Company

The Plan maintains a fully benefit-responsive investment contract with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by AUL. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by AUL, represents contributions made under the contract plus the average yield and crediting interest rate of 3.00% for the year ended December 31, 2024, as determined by AUL, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the group annuity contract is \$3,266,694 and \$1,493,403 at December 31, 2024 and 2023, respectively. The crediting interest rate is updated annually and based on a formula agreed upon with the issuer, but it may not be less than 0%.

The group annuity contract is not a stable value fund invested in guaranteed investment contracts. It is backed by AUL's general account that is invested in conservatively managed, well-diversified portfolio consisting predominately of fixed-income investments (bonds, mortgages and private placement) where the objective is to maximize long-term risk-adjusted returns.

Amounts may be transferred from the participant's account balance in the AUL Stable Value Account at any time. The value of the AUL Stable Value Account in respect of the participant will be determined as the value of the sum of the participant's AUL Stable Value Account contributions plus interest and transfers minus the sum of any amounts distributed, transfers and premium tax.

Note 9. Investment Contract With Insurance Company (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.

Note 10. Prohibited Transactions

During 2023 and 2022, the Company inadvertently failed to deposit a total of \$412,627 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Plan Sponsor deposited the lost earnings to correct these failures, filed the Form 5330, and paid the applicable excise tax in 2025. The excise tax payments were made from the Plan Sponsor's assets and not from the assets of the Plan.
