**Note 1 - Description of the Plan**

The following description of Wilcox Farms, Inc. 401(k) Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan’s definitions, benefits, eligibility, and other matters.

**General** - The Plan is a defined contribution plan covering substantially all employees of Wilcox Farms, Inc. (Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility** - Employees, excluding leased employees and those employees covered by a collective bargaining agreement, who are 20 years of age or older and have completed 500 hours or more of service in six consecutive months are eligible to participate in the Plan. Employees may begin participating on the first day of any calendar quarter after meeting the eligibility requirements.

**Contributions** - The Plan’s provisions permit pre-tax and Roth contributions by employees pursuant to section 401(k) of the Internal Revenue Code (IRC). Participants may elect to defer amounts between 1% up to 50% of eligible compensation subject to certain limitations. Participants who attained age 50 before the end of a calendar year may make additional “catch-up” deferrals, not to exceed annual limitations prescribed by the Internal Revenue Service (IRS). Participants may also rollover amounts representing distributions from other qualified plans.

Participants are automatically enrolled into the Plan upon meeting the eligibility requirements, under which new participants are set up with a 3% pre-tax deferral unless they formally waive participation or elect a different participation level. Participant deferrals will be 100% directed to the Vanguard Target Retirement Funds based on the expected retirement age of the participants upon auto-enrollment, unless alternative plan investment options are requested by the participant.

If the participant does not make any change to their deferral election percentage, the contribution will automatically increase as follows:

The Sponsor can make discretionary matching contributions. For 2024, the contribution was equal to 50% of each participant’s contribution up to a maximum of 4% of eligible compensation. To be eligible for employer matching contributions, an employee must be actively employed on December 31 and have completed 500 hours or more of service during the plan year.

Additional profit sharing contributions may be made in amounts decided at the discretion of the Sponsor's Board of Directors. To be eligible for profit sharing contributions, an employee must be actively employed on December 31, and have completed 1,000 hours or more of service during the plan year. There were no profit sharing contributions made to the Plan during 2024.

**Participant Accounts** - Participant contributions to the Plan are voluntary. Participants are allowed to direct the investment of all contributions into various investment options that offer a diversity of investment risk and return. Each participant's account is credited with any contributions made to the account as well as increases or decreases in the market value of investments, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Allocation Provisions** - Dividend income, interest income and net realized and unrealized investment gain or loss of each fund shall be allocated to the accounts of each participant based on the participant's proportionate share of the various investment funds held in their investment account.

**Vesting** - Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Discretionary employer matching and profit sharing contributions are subject to a vesting schedule based on years of credited service as follows:

**Forfeitures** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$22,000 and \$23,000, respectively.

**Payment of Benefits** - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to take a distribution equal to the value of the participant's vested interest in his or her account in the form of a lump-sum payment or installment payments. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their elected deferral account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. If the participant's account is valued at \$5,000 or less when they terminate employment with the Sponsor, the amount will be distributed in a lump sum.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits Paid to Participants** - Benefits paid to participants are recognized when they are paid.

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities with disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions to or deductions from plan assets during the reporting period. Actual results could differ from those estimates.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Subsequent Events** - The Plan's management has evaluated subsequent events through October 9, 2025, the date on which the Plan's financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - Valued at the Net Asset Value (NAV) provided by Principal Life Insurance Company (Principal Life). The NAV is based on the fair value of the underlying investments less its liabilities. #### Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

#### **Note 6 - Party-in-Interest Transactions**

Certain plan investments are managed by Principal Trust Company. Principal Trust Company is the trustee for the Plan and, therefore, transactions with such investment are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various services providers. These transactions are party-in-interest transactions.

#### **Note 7 - Federal Income Taxes**

The Sponsor adopted a Principal Trust Company pre-approved plan document. Principal Trust Company received an approval letter from the IRS dated June 30, 2020, which states that the form of plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

#### **Note 9 - Delinquent Contributions**

The Company determined there were instances during 2022, 2023 and 2024 in which participant deferral contributions were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$4,146 of deferral contributions were identified as delinquent during the year ended December 31, 2024. During 2025, the Company restored lost earnings associated with \$2,327 of delinquent deposits. The Company is currently working with Principal to calculate and remit lost earnings associated with the remaining delinquent deposits.

In total, \$4,355 and \$36,837 of deferral contributions were identified as delinquent during the years ended December 31, 2022 and 2023, respectively, and all lost earnings were restored to the plan during 2024.
