Independent Auditor's Report

To the Board of Trustees
Towne Retirement 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Towne Retirement 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Towne Retirement 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Towne Retirement 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Towne Retirement 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Description of the Plan

The following description of the Towne Retirement 401(k) Plan (a profit sharing 401(k) plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution salary reduction plan covering employees electing to participate in the Plan and who are 18 years of age or older and have completed six (6) months of service with Towne Properties Asset Management Company (the Employer). The Plan was originally adopted on January 1, 1986. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for contributions by participating employees of an amount not to exceed the maximum amount deductible under the applicable provisions of the Internal Revenue Code of 1986, as amended (the Code). Newly eligible employees are automatically enrolled into the Plan at the default deferral rate of three percent (3%) of eligible compensation; however, employees are allowed to waive the automatic enrollment. In addition to the elected deferral each year, the Employer may contribute a discretionary matching contribution equal to a percentage of the employee salary deferral, which will be determined each year by the Employer. During 2024 and 2023, the Employer elected to match 75% of employee deferrals, up to a maximum of \$1,000. The Employer may also elect to make a discretionary, non-elective contribution. There were no discretionary, non-elective contributions during 2024 or 2023. The Employer can also make qualified non-elective contributions for the benefit of such participants at the discretion of the Employer. Qualified non-elective contributions totaled \$2,282 and \$0 during 2024 and 2023, respectively.

Rollovers

The Plan permits participants to transfer distributions from other qualified plans into the Plan.

Participant Accounts

Each account is credited with (a) the participant's contribution, (b) an allocation of the Employer contribution, (c) Plan earnings or losses, and (d) administrative fees. Allocations are based upon participant account balances and their selection of investment. The participants direct the investment of their account balances among certain investment options. The Employer contributions are invested in accordance with the participants' investment selection.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions in various investment options offered by the Plan. Participants may change their investment options daily. Except for the MetLife Stable Value Fund, there is no guarantee of principal or earnings when participating in these funds.

Vesting

Participants are 100% vested in the amount of their elective deferral, rollover and qualified non-elective contribution accounts, and earnings thereon. Participant vesting of Employer matching and non-elective contribution accounts is based on the following schedule:

0 - 2	0%
3 or more	100%

Forfeitures

Forfeitures are created when participants terminate employment before becoming fully vested in Employer contributions. Forfeitures may be used to reduce future Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,885 and \$10,571 respectively. During 2024 and 2023, forfeited nonvested accounts were used to reduce employer contributions by \$42,816 and \$31,493, respectively.

Notes Receivable from Participants

Under the Plan, participants with Plan account balances may borrow the lesser of \$50,000 or 50% of the participant’s vested account balance. The notes are secured by the balance of the participant’s account and bear interest at prime plus one percent. The repayment period shall not exceed five (5) years, except when the monies borrowed are used for the purchase of the participant’s principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions made and income earned on investments, net of expenses. Upon termination of service, a participant may elect to receive either a lump sum payment or partial withdrawals of their vested account balance, a direct rollover to an individual retirement arrangement or another employer plan or, if the account balance is \$5,000 or more, remain in the Plan until retirement, disability, or death.

Hardship Withdrawals

The Plan allows for hardship withdrawals in the event of immediate and heavy financial need of up to 100% of the employee contribution account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

3. Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3.

The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net investment gain from common/collective trust, which consists of interest, dividends, realized gains or losses and unrealized appreciation (depreciation) on that investment. The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net investment gain from registered investment companies, which consists of realized gains or losses and unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are reflected on a trade-date basis. Interest and dividend income is recorded when earned. Capital gain distributions are included in dividends.

Payments of Benefits

Benefits are recorded when paid.

Payment of Expenses

All expenses of administration may be paid out of the Plan unless paid by the Employer. Such expenses shall include any expenses incident to the functioning of the Administrator, including, but not limited to, fees of accountants, counsel, and other specialists and their agents, contract plan administration, investment advisory and other costs of administering the Plan. Until paid, the expenses shall constitute a liability of the Plan. However, the Employer may reimburse the Plan for any administration expense incurred. Any administration expense paid to the Plan as a reimbursement shall not be considered an Employer contribution. During 2024 and 2023, the Employer elected to pay some of the expenses of the Plan.

3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan utilizes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of inputs used to measure fair value under this accounting standard are described as follows:

- Level 1 - Quoted prices in active markets that are accessible at the measurement date for identical assets or liabilities.
- Level 2 - Observable inputs other than quoted prices included within Level 1. Inputs that are principally derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value measurement of the assets or liabilities. These include certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies the Plan used for assets measured at fair value.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the net asset value of units of the common/collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the investments will be sold for an amount different from the reported net asset value. Transactions (purchases and sales) may occur daily. There are no unfunded commitments or significant redemption restrictions at December 31, 2024 and 2023.

4. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplementary schedule, including all investments held at December 31, 2024 and 2023, and the related dividends from registered investment companies, net investment gain from common/collective trust, and net investment gain from registered investment companies, was obtained or derived from unaudited information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the Trustee of the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Risks and Uncertainties

The Plan invests in various investment options. These investment options are exposed to risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The Employer adopted the CCH Incorporated DBA ftwilliam.com Basic Plan Document #01, a Non-Standardized 401(k) Profit Sharing Plan and need not apply for a separate determination letter, but instead may rely on the opinion letter issued by the Internal Revenue Service (dated June 30, 2020) stating that employers who adopt the Plan will be considered to have a plan qualified under Code section 401. Accordingly, the Plan's net investment income is exempt from tax. The 2021 through 2023 tax years remain subject to potential examination by taxing authorities.

Accounting principles generally accepted in the United States of America require the Plan sponsor to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

The Employer has contracted with Pension Corporation of America (PCA) or its affiliates to provide certain bookkeeping, investment advisory and administrative services to the Plan. During 2024 and 2023, fees paid by the Plan to parties-in-interest for investment advisory, recordkeeping, and administrative services totaled \$166,136 and \$142,204, respectively.

9. Subsequent Events

The Plan's management evaluated the activity of the Plan through September 11, 2025 (the date the financial statements were available to be issued) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
