Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Progressive Quality Care, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan.

General:

The Plan is a defined contribution (401(k) salary deferral) plan which provides savings benefits to eligible employees. Under the Plan, all employees of Progressive Quality Care, Inc., Progressive Parma Care Center LLC, Progressive Interchange Healthcare LLC (dba The Avenue), Progressive Medina LLC (dba Avenue at Medina), Progressive Aurora LLC (dba Avenue at Aurora), Home Preferred Home Health (dba Attentive Home Health), Progressive Macedonia LLC (dba Avenue at Macedonia), Progressive Wooster (dba Avenue at Wooster), Progressive Broadview Heights, LLC (dba Avenue at Broadview Heights), Progressive Hospice LLC (dba Serenity Hospice), Progressive North Ridgeville, LLC, and Strongsville Healthcare and Rehabilitation, LLC (dba Avenue at Strongsville) (collectively, the "Company") who have met eligibility requirements can participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Participation:

An eligible employee may elect to participate in the Plan following attainment of the age of 18 and completion of at least one year of service during an eligibility computation period.

Contributions:

Participating employees may elect to contribute between 1% and 75% of eligible compensation on a pre-tax basis subject to certain limitations of the Plan and the Internal Revenue Code ("IRC"). The Plan also provides for the investment of qualified rollover contributions and catch-up contributions. The Company may elect to make matching contributions and additional discretionary contributions. No matching or discretionary contributions were made for the year ending December 31, 2024.

Vesting:

The participants are immediately vested in their contributions plus actual earnings thereon. Company contributions are fully vested upon the occurrence of certain events, and otherwise vesting is based on years of continuous service in accordance with the following schedule:

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$873 and \$832, respectively. During 2025, these accounts will be used to offset plan administrative expenses. Forfeitures applied to expenses for 2024 were \$-0-

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) Company contributions and (b) Plan earnings of the investments the participant has selected. The account is then charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits:

At the direction of the Plan's administrator, the value of the participant's account is payable as a benefit upon termination of service, retirement, disability, or death. The Plan has provisions for an active participant to make withdrawals from his or her account, subject to limitations and restrictions. On termination of service, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account or monthly payments if the account is over \$5,000.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and T. Rowe Price ("Custodian"). See Note 3 for discussion of fair value measurements.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are accrued on ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Significant Accounting Policies (Continued)

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

All of the expenses are paid by the Plan or the Company, at the Company's option.

Certain administrative functions are performed by officers or employees of the Company, at no cost to the Plan.

Evaluation of Subsequent Events:

The Plan has evaluated subsequent events and transactions for potential recognition and presentation through the date the financial statements were available to be issued, September 16, 2025.

Note 3. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- The fair value of investments held in the mutual funds and a money market fund are determined based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.
- The investments in the common/collective trust are held by T. Rowe Price. The fair value of investments held in this account is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Tax Status

The Plan has adopted a prototype plan document. This plan document has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the prototype plan document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 5. Party-in-Interest Transactions

Certain Plan investments are held in mutual funds, a money market fund, and a common/collective trust managed by T. Rowe Price. T. Rowe Price was the Plan Custodian in 2024 and 2023. Therefore, these qualify as party-in-interest transactions.

Administrative expenses of the Plan are paid to T. Rowe Price, the Custodian. These expenses totaled \$15,571 for the year ended December 31, 2024.

Note 6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to alter, amend, or terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
