Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of Principle USA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). Substantially all employees, as defined by the Plan Document, of Principle USA, Inc. (the “Plan Sponsor”) are eligible to participate in the Plan.

Management of the Plan Sponsor is responsible for oversight of the Plan and for determining the appropriateness of the Plan’s investment offerings and monitoring the investment performance. Transactions are processed through Ascensus Trust Company (the “Custodian”), who maintains the investments in various mutual funds and common collective trusts.

Contributions

Participants may contribute up to 100% of their pre-tax or post-tax (Roth) annual compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions to the Plan. Participants may also contribute to the Plan amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change the investment options previously elected at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at a 3% pre-tax deferral rate of compensation, as defined by the Plan Document.

Each year, the Plan Sponsor may make discretionary matching or profit-sharing contributions to participants. No Plan Sponsor profit sharing contributions were made during 2024. During 2024, the Plan Sponsor made discretionary matching contributions of 100% of participant contributions up to 3% of eligible compensation, as defined by the Plan Document.

Cash contributions receivables are unsecured.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant’s relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan (continued)

Excess Contributions Payable

Amounts payable to participants totaling \$3,334 as of December 31, 2024 for contributions in excess of amounts allowed by the Internal Revenue Service (IRS), are recorded as a liability with a corresponding reduction to cash contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Vesting

Participants are immediately vested in their contributions, including rollover contributions, plus actual earnings thereon. Participants become fully vested in the Plan Sponsor's discretionary matching or profit sharing contributions after six years of service as follows:

Notes Receivable from Participants

Subject to approval by plan management, participants may borrow from their fund accounts. The minimum amount of the loan is \$1,000, and the maximum amount is the lesser of one-half of the borrower's vested account balance or \$50,000. One loan can be outstanding at a time per participant, and the loans bear interest at a rate established by the Plan Administrator in a nondiscriminatory manner. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over a period of time up to 30 years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the Internal Revenue Code (IRC), has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

1. Description of the Plan (continued)

Payment of Benefits

At any time on or after the age of 59½ or upon termination of service due to death, disability, or retirement, a participant (or the participant's beneficiaries) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of service due to other reasons, a participant (or his or her beneficiaries) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' nonvested accounts can be used to reduce future Plan Sponsor contributions to the Plan or to pay plan expenses. If a terminated participant, who is deemed to have received a distribution, resumes participation in the Plan before five consecutive one-year breaks in credited service, the participant is entitled to a restoration of any amount forfeited. There were no forfeitures during 2024.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Plan Sponsor contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value (*Note 5*) is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's management determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financials were available to be issued.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by Ascensus, LLC that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held and notes receivable from participants as at December 31, 2024 and 2023, and dividend income, interest on notes receivable from participants, and net realized and unrealized appreciation in the fair value of investments for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Ascensus, LLC, a qualified institution, as agent for the Custodian.

5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurement (continued)

The fair value measurement level for the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management of the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and amounts reported in the statements of net assets available for benefits.
