## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Land Trust Alliance, Inc. Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Land Trust Alliance, Inc. Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE A – DESCRIPTION OF PLAN**

Land Trust Alliance, Inc. Defined Contribution Retirement Plan (the “Plan”) is a defined contribution plan established on January 1, 1997. Land Trust Alliance, Inc. (the “Alliance”) is the Plan sponsor. The Plan trustee is TIAA-CREF (the “Trustee”). Newport Group provides bookkeeping and administrative services for the Plan.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

The Plan is a defined contribution plan covering all employees of the Alliance who normally work more than twenty hours per week. Employees are eligible to participate in the Plan on the date of hire for elective deferrals. Employees need to complete six months of service for nonelective deferrals. However, deferral contributions are not automatically deducted from each payroll unless the employee has made an election. An employee may opt out of participating in the Plan at any time.

Employer Contributions

Participants are eligible to receive employer non-elective contributions upon the completion of six months of service. The Alliance makes non-elective contributions of 6.5% of a participant’s eligible compensation upon completion of six months of employment and will continue to do so until the participant reaches 36 months of employment, and afterwards, the contribution rate will increase to 8%. For the President, the Alliance makes non-elective contributions of 7.946% of the President’s eligible compensation upon completion of six months of employment and will continue to do so until the completion of 36 months of employment, and afterwards, the contribution rate will increase to 9.76%. Employer contributions are invested in accordance with participants’ election(s).

Participant Contributions

Participants may contribute a percentage of their annual pre-tax compensation, as defined in the Plan, not to exceed the maximum allowable amounts under the Internal Revenue Code (“IRC”). Participants who are at least age 50 can make additional catch-up deferral contributions as defined under the IRC.

Rollover Contributions

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, subject to the Plan provisions.

Vesting

Participants are always 100% vested in their deferral contributions and the employer's non-elective contributions (as adjusted for investment gains and losses). Prior to each Plan year, the Alliance provides written notice to all Plan participants describing their rights and obligations under the Plan.

Investment Options

The Plan provides for participant-directed investment programs; whereby, the Plan determines which investment options are available and the participants may choose among the available options. Participants may have their accounts invested in any single or a combination of mutual funds, or a common collective trust. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is self-directed and is credited with the participant's elective contribution (including elective deferrals, catch up contributions, and/or rollover contributions), the Alliance's contributions, share of any investment earnings, and increases in the value of investments. Participant accounts are reduced by any withdrawals or distributions, investment losses, decreases in values of investments, and share of fees and expenses, as applicable. Allocations are pursuant to the Plan provisions.

Notes Receivable from Participants

The Plan allows active participants to borrow from their vested account balances. Loans are provided under a separate written loan policy. Participant loans are limited to a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, less the highest outstanding loan balance in the prior twelve month period. Participants are permitted to have only one outstanding loan at any time and the loan must be repaid within a five year period, unless the loan is for the acquisition of a primary residence.

Payment of Benefits

Benefits may be paid from participant accounts at age 59 1/2, or upon disability, termination of employment, death, or upon the Plan's termination. Participants who are age 72 and over are required by the Internal Revenue Service ("IRS") to make certain required minimum distributions. If a participant's account is valued at \$5,000 or less, than a lump sum of the account balance will be distributed to the participant upon termination of employment.

The taxable portion of a withdrawal is subject to federal and state income taxes and a penalty, if the participant has not reached retirement age, unless the amount is rolled over into another eligible plan or an Individual Retirement Account. Eligible participants may request an in-service hardship distribution of elective deferrals and any vested employer contributions, subject to the Plan's provisions. Vested benefits may be paid to the participants in a lump-sum distribution or direct rollover distribution to another qualified plan.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administration and Operating Expenses

Administrative costs, except for certain investment fees and loan fees that are paid out of the related participant accounts, are paid by the Alliance and have not been included in the accompanying financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for those common collective trust investment contracts, which are reported at net asset value; and except for those investments in guaranteed investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See Note D regarding the fair value measurement of investments. Net asset value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to common collective trust investment contracts. As such, net asset value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to guaranteed investment contracts. As such, contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Interest is recorded as earned and dividend income is accrued as of the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents.

**NOTE C – INFORMATION CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, information certified by TIAA-CREF (the “Trustee”), a qualified institution, as of and for the years ended December 31, 2024 and 2023, was not audited, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

**NOTE D – FAIR VALUE MEASUREMENT**

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2            Inputs to the valuation methodology include a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value of mutual funds are determined by using the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan invests in the TIAA Real Estate Account (“REA”), which is a pooled separate account, for which quoted prices are not available in active markets. The funds seek to preserve the principal investment while earning a level of interest income that is consistent with principal preservation. The REA invests mainly in real estate and real estate-related investments. There are no unfunded commitments and the redemption frequency is daily. The REA is valued at net asset value (“NAV”) as a practical expedient, as determined by the trustee.

TIAA Traditional Non Benefit Responsive Guaranteed investment contracts are stated at fair value as determined by discounted cash flows or reference to the value of underlying assets, when available. The guaranteed interest account provides a guaranteed interest rate, which ranges from 1% to 3%, for a specified period of time as determined, or allowed, by the Plan. The guaranteed interest account promises contract value for a benefit event; however, there is a possible market value adjustment when funds are withdrawn prior to maturity. Thus, the funds are not considered benefit responsive. These investments are classified as Level 3 of the fair value hierarchy.

Realized and unrealized gains or losses included in revenues for the years ended December 31, 2024 and 2023, for assets measured at fair value on a recurring basis using significant unobservable inputs (Level 3) are reported within net appreciation (depreciation) in fair value of investments on the statements of changes in net assets available for benefits.

**NOTE E – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan holds investments in guaranteed investment contracts with TIAA (the issuer). The TIAA Traditional Benefit Responsive Fund is an unallocated fixed-annuity contract that is fully and unconditionally guaranteed by TIAA. The contract meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for these investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The contract value of the TIAA Traditional Benefit Responsive Fund equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. The TIAA Traditional Benefit Responsive Fund is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate shown on the contract specifications. The interest crediting rate is declared on a quarterly basis.

The TIAA Traditional Benefit Responsive Fund is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on the issuer's ability to meet its financial obligations from general assets. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, or would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; and (4) a material amendment to the agreement without the consent of the issuer. Investments measured at contract value as of December 31, 2024 and 2023, totaled \$1,405,645 and \$1,284,378, respectively.

**NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As the Trustee and Custodian of the Plan, TIAA-CREF receives a percentage amount of the total investments for managing the Plan's assets, which qualifies TIAA-CREF as a party-in-interest to the Plan. For the years ended December 31, 2024 and 2023, fees paid by the Plan for the investment management and administrative services totaled \$275 and \$75, respectively. Certain accounting and administrative functions of the Plan are performed by employees of the Plan sponsor at no cost to the Plan.

**NOTE G – PRIORITIES UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Alliance has the right to amend the Plan, discontinue its contributions at any time, and terminate the Plan subject to the provisions of ERISA and the Plan document. Upon the Plan's termination, participants will continue to be 100% vested in their accounts.

**NOTE H – INCOME TAX STATUS**

The Internal Revenue Service has determined 403(b) plans comply with laws and regulations if the Plan sponsor has adopted a written plan and operated it in accordance with the requirements. The plan administrator believes that the Plan is designed and is being operated in accordance with the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements. The Plan is subject to routine examinations by the Internal Revenue Services, but no request has been made for an examination as of the date of these financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**NOTE I – RISKS AND UNCERTAINTIES**

The Plan provides for investments in various securities. Investment securities are exposed to various risks such as interest rate, credit risks, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE J – SUBSEQUENT EVENTS**

In preparing these financial statements, the Plan's management has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued. There were no additional events or transactions that were discovered during the evaluation that required further recognition or disclosure.
