Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of P & K 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of P & K 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the P & K 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Company established the Plan to provide employees with a systematic means of savings and investing for the future. Eligible employees of the Company, as defined by the Plan document, can enroll on the first day of the Plan month coinciding with or next following the date the employee satisfies the eligibility requirements. The Company’s safe harbor match and profit sharing will begin once the employee has completed one year of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Assets of the Plan are allocated to participant accounts based on specific contributions made by each participant and respective match made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

The plan was originally effective on January 1, 1996. Effective January 5, 2024 the plan was amended and restated to change the loan policy from a “hardship” definition to a “traditional” definition.

Contributions

Upon meeting the eligibility requirements, participants may contribute a percentage of their compensation, as defined by the Plan, by means of payroll deductions on a pre-tax or Roth basis. Contributions are subject to certain discrimination tests prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. These catch-up contributions are subject to certain statutory limitations. The Company makes a safe harbor matching contribution equal to 100 percent of the amount deferred up to 4 percent. The Company may make discretionary non-elective contributions to the Plan. During the years ended December 31, 2024 and 2023, the company did not make any non-elective contributions. Contributions are subject to certain statutory limitations.

NOTE 1 – DESCRIPTION OF THE PLAN – CONTINUED

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the company's matching contributions, Plan gains or losses, and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and a guaranteed investment account as investment options for participants.

Vesting

The participant is 100% vested in elective deferrals including catch-up contributions, rollover contributions and safe harbor contributions, non-elective contributions and any additional discretionary matching contributions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reason, the vested portion of the participant's benefit is distributed, as requested, by the participant (or participant's beneficiary in the event of death). For those vested account balances less than \$5,000, only lump-sum cash payments are available. Participant's vested account balances, which are greater than \$5,000, have various options as described in the Plan. In addition, hardship distributions are permitted if certain criteria are met.

Notes Receivable from Participant

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their non-forfeitable account balance or \$50,000, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 3.85 – 9.50% as of December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Loans are stated at the unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, the Plan had loans receivable from participants with principal balances totaling \$350,662 and \$53,907, respectively.

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

NOTE 1 – DESCRIPTION OF THE PLAN – CONTINUED

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,358 and \$1,958, respectively. These accounts will be used, at the discretion of the Plan administrator, to reduce future plan expenses and the Company's matching contributions. For the years ended December 31, 2024 and 2023, \$0 and \$20,239, respectively, were used to reduce employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the plan have been prepared on the accrual basis of accounting.

Investment held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Accordingly, the actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expense charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected in administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from employees are recorded as they are withheld from the participant's wages.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as accounts payable, with a corresponding reduction to contributions. Excess contributions for the years ended December 31, 2024 and 2023 were \$1,611 and \$9,867, respectively.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in administrative expenses. Fees related to the administration of notes receivable from participants are included in administrative expenses and charge directly to the participant's account.

NOTE 3 – INVESTMENTS (UNAUDITED)

The Plan's investments were held in trust and administered by the trustee, Voya Retirement Insurance and Annuity Company for the years ended December 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held and net appreciation/depreciation in fair value of investments and interest and dividends, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

NOTE 4 - EMPLOYER CONTRIBUTION RECEIVABLE

The Plan provides a Safe Harbor Matching Contribution equal to 100% of the participant's salary deferral, up to 4% of their eligible compensation, based on the Plan year. At the end of each Plan year, a review is conducted to ensure that each participant has received the full Safe Harbor Match to which they are entitled—calculated as 100% of their annual compensation deferrals, up to 4% of their total eligible compensation. If the actual match contributions made during the year are less than the amount due, the shortfall is made up with a “true-up” contribution. This true-up amount is recorded as a receivable at year-end. For the years ended December 31, 2024 and 2023, the total true-up contributions were \$61,123 and \$34,571, respectively.

Our audit procedures identified that the December 31, 2023 true-up contribution was not remitted in a timely manner. Consequently, a lost investment earnings calculation was performed, and the company has agreed to make an interest payment of \$1,427 to the Plan to restore the lost earnings associated with the late contribution.

NOTE 5 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5 - FAIR VALUE MEASUREMENTS – CONTINUED

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the plan at year end and are classified in Level 2 of the fair value hierarchy.

These funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, NAV's are received daily from fund managers, and the managers stand ready to transact at these quoted amounts.

The insurance company custodian (Voya Retirement Insurance and Annuity Company) transacts in these funds on a daily basis as part of the separate account trading activity.

The calculation of the NAV for funds composed of other funds (e.g., retirement target date funds) is essentially the same as the calculation of the NAV for any other fund: the total market value of assets across all underlying funds less any liabilities is divided by the outstanding shares. Again, this resulting NAV is published and/or the fund managers are ready to transact at the quoted prices.

NOTE 5 - FAIR VALUE MEASUREMENTS – CONTINUED

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

NOTE 6 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

During the years ended December 31, 2024 and 2023, the Plan held a guaranteed interest account, which is a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The guaranteed interest account is valued at contract value which represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants are able to ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. The guaranteed interest account is presented on the face of the Statements of Net Assets Available for Benefits at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity was provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that no events are probable of occurring that would limit the Plan's ability to transact at contract value with participants.

Voya is contractually obligated to pay principal and a specified interest that is guaranteed by the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.0%. Such interest rates are reviewed on a quarterly basis for resetting.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 9 – INCOME TAX STATUS

The Company has adopted a prototype non-standardized plan pre-approved by the IRS. The IRS issued an opinion letter dated June 1, 2021, that the prototype non-standardized plan is acceptable with the applicable section of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of American require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 10 – RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 11 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no reconciliations of net assets available for benefits or reconciliations of the change in net assets available for benefits per the financial statements to Form 5500 at December 31, 2024 and 2023.

NOTE 12 – SUBSEQUENT EVENTS

The Plan did not have any subsequent events through October 8, 2025, which is the date the financial statements were available to be issued, requiring recording or disclosure in the financial statements for the year ended December 31, 2024.
