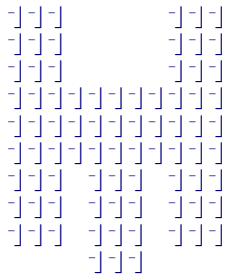

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, and Participants of the
Boca West Country Club 401(k) Retirement Plan
Boca Raton, Florida

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Boca West Country Club 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Boca West Country Club 401(k) Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to the bank or similar institution or insurance carrier in accordance with 26 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referenced above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statement section of our report. We are required to be independent of Boca West Country Club 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Boca West Country Club 401(k) Retirement Plan's ability to continue as a going concern for one year after the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. 1. Description of Plan

The following description of the Boca West Country Club 401(k) Retirement Plan, (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan that covers substantially all employees of the Boca West Country Club, Inc. (the "Club") who have completed one year of service, and attained the age of twenty-one. International employees are excluded from participating in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective May 1, 2002. The Plan was most recently restated effective November 15, 2021, as required by the Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – The Club's management serves as Plan Administrator. The Club's Audit Committee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Audit Committee. Ascensus Trust Company (Ascensus), serves as the Plan's trustee, third-party administrator, and servicer as of December 31, 2024 and 2023. Vanguard Platinum (Vanguard), a partner of Ascensus Trust Company, serves as the plan's custodian as of December 31, 2024 and 2023.
- c) *Contributions* – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to the maximum dollar limitations established by the Internal Revenue Code. The Plan provides for automatic enrollment of all newly eligible participants at a deferral of 3% of eligible wages unless the participant specifically elects to defer a different percentage, or not contribute at all. The Plan has an automatic annual 1% increase to participant's pre-tax salary deferral percentage up to a maximum of 6% of pay. Participants may also contribute amounts representing distributions from other qualified plans. The Club makes a matching contribution of 50% of each participant's salary deferrals that do not exceed 6% of the participant's compensation. In addition, the Club may also make discretionary contributions. There were no discretionary contributions made by the Club during the year ended December 31, 2024.
- d) *Participant Accounts* – Each participant's account is credited with participant's contributions, allocations of the Club's contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e) *Vesting* – Participants are immediately vested in their salary deferral contributions, and rollovers, plus actual earnings thereon. Participants' vesting in the Club's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant becomes 100% vested after 5 years of credited service, or immediately upon death or disability.
- f) *Investment Options* – Upon enrollment in the Plan, a participant may direct their contributions to any of the investment options offered by Vanguard, and periodically determined by the Investment Committee. Participants may change their investment options via phone or Internet access to Vanguard.

1. **Description of Plan, continued**

- g) *Payment of Benefits* – Upon attaining age 59½, termination, retirement, death, or disability a participant may elect to receive a lump-sum amount, or partial payments, equal to the value of the participant's vested interest in his or her account. In-service distributions are available for a qualifying financial hardship from participant deferral accounts only. In-service distributions are allowed anytime from rollover contributions.
- h) *Forfeitures* – Upon termination of employment, the non-vested portion of a participant's account is forfeited. Amounts forfeited may be used by the Company to reduce employer contributions or pay plan administrative fees. During the year ended December 31, 2024, \$9,788 was forfeited by participants and \$10,619 was used to pay administrative fees and \$32 was applied to employer contributions. As of December 31, 2024 and 2023, there were \$123 and \$920, respectively, of forfeitures available at year-end to apply to future employer contributions or plan administrative fees.
- i) *Administrative Expenses* – Individual participants pay for loan and distribution fees, and investment management expenses. The Plan sponsor pays for certain other costs of plan administration.
- j) *Participant Notes Receivable* – Participants may borrow from their funds a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their individual vested account balance. Loan terms range from 5 months to 5 years or up to 25 years for the purchase of a primary residence. The loans bear interest at a reasonable rate as determined by the Plan administrator at the time the loan was taken. The interest rates on participant notes receivable as December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are scheduled to be paid ratably through payroll deductions. Loans to participants are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participant notes receivable are presented as part of the investments for the Form 5500 and are referred to as participant loans.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

- c) *Valuation of Investments and Income Recognition* – The Plan’s investments (Mutual funds) are valued at fair value as determined from quoted market prices, if available, of a national securities exchange on the last business day of the year. Investment options that do not have readily available market quotations are valued according to quotations from the custodian. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- d) *Payment of Benefits* – Benefits are recorded when paid.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Certain Plan investments are units of mutual funds managed by the custodian. Change in the custodian’s management may affect operating results of the fund adversely. Additionally, the financial position of the Plan Sponsor, Boca West Country Club, Inc., may have a significant impact on the Plan. Specifically, the ability of the Plan Sponsor to continue to make contributions under the program and/or the stability of the Plan Sponsor’s operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the Internal Revenue Service, Employee Retirement Income Security Act of 1974, and/or Department of Labor (DOL).

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

3. Fair Value Measurements, continued

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions indicate the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- a) *Interest-bearing cash* – Valued at \$1 per share of shares held by the Plan at year end reflected as a money market fund.
- b) *Mutual funds* – Valued at quoted market prices of a national securities exchange on the last business day of the year, of units held by the Plan at year end.

5. Related Party Transactions

Certain plan investments are held by Vanguard Platinum. Vanguard is the custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. However, they are not considered prohibited transactions in accordance with appropriate ERISA exceptions.

6. Tax Status

The Plan is utilizing a Non-Standardized Pre-Approved Profit Sharing Plan document provided by its Plan administrator, Ascensus. The Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS’s Cycle 3 restatement. The restated Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Club has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accrued benefits, to the extent funded, or required to be funded, must be distributed to the participants.

8. Subsequent Events

Plan management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued, and determined there were no events to disclose in these financial statements.
