INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants
 Friends of Children with Special Needs 401(k) Plan
 Fremont, California

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Friends of Children with Special Needs (FCSN) 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Friends of Children with Special Needs 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for

the Audit of the Financial Statements section of our report. We are required to be independent of FCSN 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about FCSN 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of FCSN 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about FCSN 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of H- Schedule of Assets held for Investment Purposes as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

A. Description of the Plan

The following description of the Friends of Children with Special Needs (FCSN) (The Organization) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. **General.** The Plan is a defined contribution plan amended as of July 26, 2023, and is retroactively effective as of January 1, 2022, covering all employees of FCSN who have completed 3 consecutive months period from the Eligible Employment commencement date and during which at least 250 hours of service are completed; if an employee does not complete the stated hours of service during the specified the employee will become eligible on the date on which 250 hours of service is completed. The Plan is a 401(k) plan, and its plan number is 001. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Any union or leased employees or nonresident aliens who have no earned income sources within the United States are excluded from the Plan.
2. **Contributions.** Each year, a participant may elect to contribute and thereby reduce taxable compensation by a specific percentage (from 1% minimum to 90% maximum) or dollar amount and have that amount contributed to the Plan on a pre-tax basis as an elective deferral. A participant’s elective deferral to the Plan is made from his or her eligible earnings before being taken out. The limit for year ended December 31, 2024, is \$23,000 for pretax annual compensation, as defined in the Plan. Participants may also be permitted to deposit into the Plan for any distributions received from other qualified defined benefit or defined contribution plans and certain IRAs; such a deposit is called a “rollover”. Participants can direct their contributions into various investment options offered by the Plan. The investment options are comprised of various money funds, mutual funds and various public stock funds. The Employer can also make additional contributions to the Plan, only if it is in compliance with statutory requirements.

Catch-up contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. They are contributions that exceed a statutory limit (\$23,000 for 2024). For 2024, the limit on catch-up contributions is \$7,500. This limit will be adjusted for inflation after 2024.

Matching contributions. The Organization is required to make a matching contribution equal to 50% of a participant’s elective deferral each payroll period. However, the Organization will not match a participant’s elective deferrals in excess of 6% of the participant’s compensation each payroll period. The matching contribution is invested directly into various investment options

offered by the Plan as directed by participants. In order to receive the matching contribution, a participant's contribution must be made and is calculated based on the participant's eligible earnings for each pay period. Once a participant's elective deferrals stop, the matching contribution also stops.

3. **Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of (a) the employer's contribution and (b) earning from the investments, (c) no forfeitures and charged with an allocation of administrative expenses. Allocations are based on participant's account balances or may be charged equally to each participant. All contributions and allocations are held in a trust created under the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting.** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's matching portion is 100% of a participant's account. A participant is 100% vested for the participant's rollover contributions, basic matching and contributions. Because of that, any contributions to each participant's total account balance will never be forfeited.
5. **Note Receivable from Participants (Loans).** Loans are made on a uniform and non-discriminatory basis. Participants may borrow from their non-forfeitable accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. The loans are secured by 50 percent of the participant's vested interest in the Plan. The interest rate for a loan will be the rate in effect in the month the loan is effective. The interest rate information can be obtained by logging into the participant's account. The maximum number of Plan loans that participants may have outstanding at any one time is one. A Participant loan must be payable within a period not exceeding 5 years from the date the Participant receives the loan from the Plan. Principal and interest are paid ratably through monthly payroll deductions. Loans are treated as participant-directed investments.
6. **Payment of Benefits.** On termination of service due to health, disability, death, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or have the payment paid as "direct rollover" to an individual retirement account or to another employer's tax-qualified plan.
7. **Forfeited Accounts.** An employee will become a participant on the first day of the month after a three-month period of employment and he or she completes 250 hours of service. There are no forfeitures. On December 31, 2024, and 2023, no forfeitures are recorded.

8. **Administrative Expenses.** Certain expenses incurred in the administration of the Plan are paid directly by the Organization.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the plan were prepared using the accrual method of accounting. This method, which recognizes receivables and payables, results in the recognition of income when earned and expenses when incurred.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in marketable securities are stated at fair market value, based on the quoted market prices of the underlying securities within each fund on December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable (loans) from Participants

Notes Receivable (loans) from Participants are measured at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan

balance is reduced, and a benefit payment is recorded. As of December 31, 2024, notes receivable (loans) from participants is \$2,644.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by FCSN and are excluded from these financial statements. Fees related to the administration of notes receivable and distribution from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments.

Subsequent Events

For the year ended December 31, 2024, the Plan has evaluated subsequent events for potential recognition and disclosures through September 12, 2025, the date the financial statements were available to be issued.

Income Taxes

The Plan has adopted a prototype plan which obtained a favorable opinion letter on January 31, 2006, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The administrative committee will make any changes deemed necessary to ensure that the Plan is granted tax-exempt status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions. The Plan's tax returns are subject to examination by federal taxing authority for a period of three years from the date they are filed. However, there are no current audits in progress from any federal agencies.

C. Investment Information Certified by Reliance Trust Company (Unaudited)

On December 31, 2024, the Plan's investments were held by Reliance Trust Company (the Custodian). The Supplemental Schedule H is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Custodian as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

D. Related-Party Transactions and Party-in-Interest Transactions

The Plan allows transactions with certain parties who perform advisory and book-keeping services to the Plan, including the organization. Fees charged for any investment advisories are paid by the organization, whereas fees charged for record-keeping are paid by the Plan. These transactions are qualified as parties in interest. As of December 31, 2024, the Plan had paid \$56,037 in fees to the third party.

E. Plan Termination

Although it has not expressed any intent to do so, FCSN has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their contributions.

F. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.

G. Fair Value Measurements

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value of Financial Instruments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted

quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024, and 2023.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The attached Note K sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024, and 2023.

Through various kinds of investments offered by the Plan, the management believes that risks of loss may be mitigated and reduced through diversification.
