Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Country Fair, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial



statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Plan Description

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code ("Code") covering Country Fair, Inc. (the "Company") store managers, assistant managers and those employed at corporate headquarters. To be eligible to participate in the Plan, an employee must have attained the age of 21, have completed at least one year of service and work 500 hours during such plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Participants may elect to contribute up to 100% of their base pre-tax annual compensation subject to certain IRS limits. Eligible employees will automatically have 3% of eligible wages deferred and remitted to the Plan unless the employee changes the deferral percentage or elects not to participate in the Plan. Participants may rollover amounts representing distributions from other qualified defined benefit or contribution plans. The Plan permits the employer to make a discretionary match to each eligible participant's account as a percentage of the participant's elective deferral. For the years ended December 31, 2024 and 2023, the Company matched 1.5% for 1% of yearly wages contributed, 2.5% for 2% of yearly wages contributed, and 3.5% for 3% or more of yearly wages contributed. The Company may also contribute an additional amount determined in its sole judgment. For the years ended December 31, 2024 and 2023, the profit-sharing amount was 0% of eligible participant's wages. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the plan year while a participant in the Plan. Additional allocations may be contributed if the Plan becomes top heavy and the participants have not already received the minimum allocation. Effective January 1, 2024, the Plan was amended to allow participants to elect after-tax Roth contributions at their discretion. Any participant who is eligible to make participant deferral contributions and who has attained age 50 before year end, may elect to make catch-up contributions in accordance with and subject to certain limitations.

Employee contributions from the participant's base wages are excluded from the participant's current Federal taxable income, in accordance with Section 401(k) of the Internal Revenue Code.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's and the Company's contributions and an allocation of net Plan earnings thereon and charged with an allocation of certain administrative expenses. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account. Participants may direct the investment of their account balances

1. Plan Description (Continued)

Participant Accounts (Continued)

into various investment options offered by the Plan. Currently, the Plan offers various mutual funds and one common collective trust fund as investment options for participants.

Vesting

Participants are always vested 100% with respect to the current value of their contributions and any earnings thereon. Vesting in the Company's discretionary contribution portion of their account plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

Notes Receivable From Participants

Participants are not permitted to borrow against their account balances.

Payment of Benefits

Retirement age is 65 with early retirement permitted at age 59-1/2 with 3 years of service. Benefits may be paid upon participants' termination of service, retirement, death, disability, attainment of 59-1/2 years of age, or hardship. Any benefit payments are made through lump sum distributions or periodic payments in accordance with the Plan's provisions.

Forfeitures

Forfeitures from nonvested participant accounts may be used to offset plan administrator costs or to reduce the Company's contributions required under the Plan. As of December 31, 2024 and 2023, \$23,676 and \$9,247, respectively, had been forfeited by participants but not yet applied to reduce the company's cash contributions, or pay plan expenses. In both 2024 and 2023, employer contributions were reduced by \$-0-, from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value in accordance with *ASC 820, Fair Value Measurements and Disclosures*, as determined by the trustee, Bank of America, N.A. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 8 for discussion of fair value measurements.

2. Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. In accordance with the policy of stating Investments at fair value, net appreciation or depreciation for the year, including both realized and unrealized gains and losses, is reflected in the statements of changes in net assets available for benefits.

Contributions

Participant contributions are made through payroll deductions and are recorded as additions to net assets available for benefits. Employer contributions are recorded as additions to net assets available for benefits when the company accrues such contribution as a liability. Employer discretionary and participant payroll deferral contributions not yet deposited are recorded as contributions receivable.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in the net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. The Plan's financial statements include amounts that are based on the Plan Administrator's best estimates and judgments. Actual results could differ from those estimates.

3. Income Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the Plan’s third-party administrator by a letter dated June 30, 2020, that the third-party administrator’s non-Standardized Pre-Approved plan on which the Plan is based, is designed in accordance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has had subsequent amendments, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

4. Information Certified by the Plan’s Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following information summarized in the financial statements and supplemental schedule relating to investment income for the Plan for the years ended December 31, 2024 and 2023, and investments held as of December 31, 2024 and 2023, was certified by Bank of America, N.A. as trustee, as being complete and accurate.

5. Party-In-Interest Transactions

Bank of America, N.A. collected fees as the trustee of the Plan and these transactions qualify as party-in-interest. Fees paid by the Plan for Plan administrative services amounted to \$2,319 and \$1,775 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment administration services are netted against net appreciation (depreciation) in fair value of investments.

6. Plan Termination

The Plan sponsor has not expressed any intent to terminate the Plan, but is free to do so at any time, subject to the provisions of ERISA. In the event of Plan termination, each participant automatically becomes fully vested to the extent of the balances in his or her individual account.

7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Fair Value Measurements

Financial Accounting Standards Board ("FASB") ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

8. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust - CCTs represent investments with various investment managers. Units held in CCTs are valued at the net asset value as reported by the investment managers. CCT - Federated Capital Preservation Trust Fund is a collective investment fund for which Federated Investors Trust Company ("Federated"), a wholly-owned subsidiary of Federated Investors, Inc., serves as trustee under a Declaration of Trust dated October 25, 2007, as amended and restated on August 30, 2011, August 23, 2016, June 26, 2020, and July 16, 2021. The Trust Agreement is the governing instrument of the Fund. The trustee is organized as a Pennsylvania state-chartered trust company. The trustee and the Fund operate in conformity with the rules and regulations of the Pennsylvania Department of Banking as they apply to collective investment of fiduciary funds. The Fund is exempt from income taxes under Sections 401 and 501 of the Internal Revenue Code. The investment objective of the Fund is stability of principal and high current income. The Fund files its own 5500 giving it the status of a Direct Filing Entity. The CCT generally provides for daily redemption by the Plan at reported net asset value, with a 12-month redemption notice period.

In certain circumstances, the amount withdrawn from the Fund would be payable at fair value rather than at contract value. These circumstances may include, but are not limited to, the following: mergers, mass layoffs, plan terminations, implementation of early retirement incentive programs or other events within the control of the Fund or the Plan sponsor resulting in a material and adverse financial impact on the issuer's obligations. The CCT generally provides for daily redemptions by the Plan at reported net asset value, with a 12-month redemption notice period.

Based on prior experience, Federated believes that it is not probable that such circumstances would be of sufficient magnitude to limit the ability of the Fund to transact at contract value with participants. Of course, there can be no guarantee that this will be the case.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
