We have performed audits of the financial statements of MOBIS-ALABAMA 401(K) PLAN (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### (1) Description of Plan

The following description of MOBIS-ALABAMA 401(K) PLAN (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### (a) *General*

The Plan is a defined contribution plan covering substantially all employees of MOBIS-ALABAMA, LLC (the "Company" or the "Plan Sponsor") and its affiliate, who have reached at age of 18 and completed at least 3 months of service. Part-time, temporary, seasonal employees, reclassified employees, and leased employees are not eligible to participate in the Plan. An employee may elect to participate in the Plan on the first day of the month following completion of eligibility requirements.

The administration of the Plan is the responsibility of the Plan administrator appointed by the board of directors of the Company. The Plan's trustee is Empower Trust Company and the record-keeper is Empower Retirement. The Plan began on January 15, 2005, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) *Contributions*

Every pay period, participants may make pre-tax contributions and/or Roth contributions up to 100% of his or her eligible compensation, as defined in the Plan. Eligible employees who do not make an affirmative election to participate or not to participate, were automatically enrolled in the Plan at 2% ("Default Percentage") of eligible compensation, which increase 1% per year until the total deferral is 5% of eligible compensation. Participants may opt out of contributing at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollover"). The total contributions in any taxable year may not exceed the dollar limit set by the Internal Revenue Service ("IRS"), which is \$23,000 for 2024.

The Company makes a discretionary matching contribution. Each year, the Company will determine the formula for the discretionary matching contribution equal to a uniform percentage or dollar amount of employee elective deferrals. Until the end of the first quarter of 2024, the Company contributed 60% of the first 5% of the employee contribution. Effective April 1, 2024, the matching contribution formula was revised to provide 100% of the first 4% of eligible compensation.

The Company may also decide to make non-elective (discretionary) contribution to the Plan, which will be allocated to all participants eligible in the Plan. In order to share in the non-elective contribution, participants must be actively employed on the last day of the Plan year. Participants' share of non-elective contribution is determined by a participant's compensation divided by total compensation of all participants eligible to share times total non-elective contribution for the Plan year. No employer non-elective contributions were made by the Company for the year ended December 31, 2024.

#### (c) *Participant Accounts*

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for participants.

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(d) Vesting**

Participants are always 100% fully vested in their elective deferrals and rollover contributions, plus actual earnings thereon. Each participant whose employment terminates for any reason other than death, disability, attainment of normal retirement age, is entitled to a non-forfeitable right to his or her employer contribution accounts based on the following schedule:

Years of Service	Vesting Percentage
Less than 1	0%
1	20%
2	40%
3	60%
4	80%
5	100%

Participants become vested in employer matching contributions and non-elective contributions based on years of service as determined under the elapsed time method. Under this method, a participant's service is measured by the period of time that elapses while the participant is employed by the employer, rather than by counting actual hours of service.

Certain events, such as death, disability, or normal retirement results in immediate full vesting if such event occurs while the participant is employed by the Company.

**(e) Notes Receivable from Participants**

Participants may borrow funds from their accounts a minimum of \$1,000 up to lesser of 50% of their vested account balance or \$50,000. Loans along with interest must be fully repaid ratably through biweekly payroll deductions for from one to five years. Participants may not have more than two outstanding loans at a time and repayment of the loan is secured by participants' account balances. The interest rate is the prime rate as published in the Wall Street Journal plus 1.00% per annum.

**(f) Distribution of Benefits**

On termination of service due to death, all amounts credited to participant's account become fully vested and distribution will be made to the designated beneficiary in a single lump-sum payment. If death benefit exceeds \$5,000, however, beneficiary may elect to have the benefit paid in a single lump-sum payment in cash or annual installments at least equal to the required minimum distribution amount.

On termination of service due to other reasons, including attainment of normal retirement age of 65, a participant may receive the value of the vested interest pursuant to the election of the participant or beneficiary. Participants will become 100% vested in all of the accounts under the Plan if employed on or after your normal retirement age. If the vested account balance exceeds \$5,000, participant consent is required to distribute account balance before reaching normal retirement age. If the vested

account balance does not exceed \$5,000, however, a distribution of your account balance will be made to participants, regardless of whether to consent, as soon as administratively feasible following termination of employment.

For termination of service due to disability, all amounts credited to participant's account become fully vested and distribution will be made to the participant or beneficiary. The Plan will distribute account balance in the same manner as for any other non-death related termination.

If a participant is a more than 5% owner, distributions are required to begin by the April 1st following the year in which a participant reaches age 73, even if he or she is still employed at the time. If a participant is not a 5% owner, he or she must begin to receive benefits no later than the April 1st following the later of the year in which a participant reaches age 73 or terminate employment.

Participants may withdraw all or part of their vested account balance once an age of 59 ½ is reached. Participants may also withdraw any or part of their rollover contribution account that may be held in their account in the Plan at any time and at any age.

**(g) Forfeitures**

If a participant terminates employment before becoming 100% vested in his or her account balance, the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. As of December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$82,652 and \$81,718, respectively. Forfeitures of non-vested account balances are used first to pay the Plan expenses and then to reduce future employer contributions to the Plan. The amount of forfeitures applied for the year ended December 31, 2024 totaled \$219,033.

**(h) ERISA Budget Account**

Annually, the investment custodians through their revenue sharing arrangements ("Shared Revenue") with investment companies, share a portion of the shared revenue it receives with the retirement plans which they service (referred to as an "ERISA Budget Account"). For the year ended December 31, 2024, the Plan received \$80,924 of Shared Revenue from the investment custodians. Such revenues have been recorded as a reduction of administrative expenses on the statement of changes in net assets available for benefits. The ERISA Budget Account can be used to either reduce Plan expenses or be reallocated to participant accounts. At December 31, 2024 and 2023, the balance in the ERISA Budget Account was \$33,007 and \$5,646, respectively, and is included in the investment balance on the statements of net assets available for benefits.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Accounting**

The accompanying statements of net assets available for benefits and changes in net assets available for benefits have been prepared on the accrual basis of accounting.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of the Plan assets and liabilities at the financial statement date. Accordingly, actual results may differ from those estimates.

**(c) *Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Shares of mutual funds are valued using quoted prices. Investments in the stable value fund are reported at fair value as determined by the fund manager based on the net asset value ("NAV") of the fund, which is based on the fair value of the underlying assets of the funds divided by units outstanding at the valuation date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation (depreciation) in fair value of investments consists of realized gains and losses and the change in unrealized gains and losses in the Plan's investments. Realized gains and losses from the sales of investments are computed using the participant's cost basis in the investments aggregated at the Plan level. Net changes in unrealized appreciation (depreciation) in investments represents the difference between the fair values of investments held at year-end and the cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year.

**(d) *Notes Receivable from Participants***

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**(e) *Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions in the amount of \$2,425 and \$1,049 to the applicable participants before March 15, 2025 and March 15, 2024, respectively.

**(f) *Contributions***

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from compensation. The Plan recorded no employer contributions receivable and participant contributions receivable related to payroll withholdings in the statements of net assets available for benefits as of December 31, 2024 and 2023.

**(g) *Payments of Benefits***

Benefit payments to participants and beneficiaries are recorded when paid.

**(h) *Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses paid by the Plan include investment management fees, recordkeeping fees, and other costs not paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### *(i) Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan may indirectly invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

### *(j) Recently Issued Accounting Standards*

All applicable accounting standards have been adopted by the Plan. There are no issued accounting standards that will require adoption in future periods.

### **(3) Certified Investments**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management, and agreed to or was derived from information certified as complete and accurate by Empower Trust Company (the trustee of the Plan).

### **(4) Investments**

For the year ended December 31, 2024, the Plan's investments in mutual funds and stable value fund (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,496,439.

### **(5) Fair Value Measurements**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to those valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and to minimize the use of unobservable inputs. U.S. GAAP describes three levels of inputs that may be used to measure fair value.

Fair value estimates are made at a specific point in time, based on available market information and other observable inputs. In some cases, the fair value estimates cannot be substantiated by comparison to independent markets. In addition, the disclosed fair value may not be realized in the ultimate settlement of the financial asset as these values do not represent any premium or discount that could result from selling an entire holding of a particular financial asset at one time. Other expense that would be incurred in an actual sale or settlement are not included in the amounts disclosed.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in methodologies to determine the fair value of investments at December 31, 2024 and 2023.

- \* This investment generally invests all or a portion of its assets in one or more commingled funds and its primary objective is to achieve broader diversification and more competitive rates than if beneficial owners were to attempt to purchase general account guaranteed investment contracts on an individual basis. Units of the fund can be redeemed daily with no restriction.

The Plan does not have any liabilities that are measured at fair value on a recurring basis as of December 31, 2024 and 2023.

#### **(6) Notes Receivable from Participants**

The notes receivable from participants bear interest at a rate between 4.25% and 9.50% as of December 31, 2024 and 2023, and have original maturities that range from one to five years. For the year ended December 31, 2024, interest income on notes receivable from participants amounted to \$384,169.

#### **(7) Related Party Transactions**

Certain Plan investments are managed by Empower Trust Company. Empower Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### **(8) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### **(9) Tax Status**

The Plan document is a prototype document that the Company adopted with specific provisions customized to meet the needs of the Plan Sponsor and the participants. The prototype document has received a favorable opinion letter from the IRS that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the original opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The IRS is one of the primary tax oversight bodies of the Plan and generally has the ability to examine the Plan's income tax returns for the years 2021 through 2024; however, there are no audits for any tax years in progress.

During 2025 and 2024, the Plan Sponsor discovered an operational errors related to participant and matching contributions. The Plan Sponsor corrected the 2023 operational error in accordance with the Self Correction Program ("SCP") allowed by the IRS, by depositing the total correction amounts, plus earnings, into the participant account in 2024. The Plan Sponsor is in the process of correcting the 2024 operational error under the same program. As of December 31, 2024 and 2023, the Plan recorded the employer contributions receivable amounted to \$1,367 and \$2,856, respectively. The operational errors do not have a

#### (11) Subsequent Events

Effective January 1, 2025, the Plan was amended to (i) adopt safe harbor contributions equal to 100% of the 4% of eligible compensation that a participant contributes to the Plan, (ii) increase the default percentage and maximum percentage of automatic enrollment from 2% and 5% to 3% and 6% of eligible compensation, respectively, and (iii) exclude expatriates from Korea from participation in the Plan.

The Plan Sponsor has evaluated subsequent events from the balance sheet date through September 30, 2025, the date at which the financial statements were available to be issued and has determined that there are no other items to disclose.
