Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Synergy Services, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Synergy Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions, which is available from the Plan Administrator.

General – The Plan is a defined contribution plan sponsored by Synergy Services, Inc. (the “Organization”) covering all eligible employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Alerus Financial N.A. serves as the Plan’s recordkeeper, custodian and trustee.

Eligibility Conditions – An employee will be eligible to participate in the Plan after attaining the age of 21 and may enter the Plan immediately. An employee is eligible for the employer contribution after completing one year of service and has attained age 21. An eligible participant enters the Plan for the employer contribution on the first day of the month that coincides with or next follows the date on which the requirements are satisfied.

Years of Service – An employee will have completed a year of service if, at the end of their first twelve months of employment with the Employer, the employee has been credited with at least 1,000 hours of service. If the employee has not been credited with 1,000 Hours of Service by the end of their first twelve months of employment, they will have completed a year of service at the end of any following Plan year during which they were credited with 1,000 hours of service.

Contributions – The Plan permits eligible employees to make annual contributions up to 100% of eligible compensation, subject to certain limitations in the Internal Revenue Code (“IRC”). Matching contributions are discretionary as determined by the Organization’s Board of Directors. The Organization’s matching contribution in 2024 was 50% of employees’ salary deferral amounts on the first 4% of the employees’ compensation.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Organization’s contribution and Plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions. Vesting in the Organization’s contribution portion of their accounts plus earnings thereon is based on continuous service. A participant is 25% vested after 1 year of service, 50% vested after 2 years of service and fully vested after 3 years of continuous service.

Forfeitures – The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce the Organization’s matching contribution. During 2024, no forfeitures were used. There are \$9,218 and \$4,848 forfeitures remaining at December 31, 2024 and 2023, respectively.

Payment of Benefits – Distributions from the Plan are made upon death, retirement, or termination pursuant to the Plan provisions and as permitted by law. A participant’s account balance under \$5,000 will be subject to automatic distribution. A participant with a vested

account balance of \$5,000 or greater may elect a lump-sum payment or elect to leave their investment in the Plan.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferrals, matching contributions, rollover contributions and non-elective contributions.

Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years (or 15 years for the purchase of a primary residence). Participants may only have one loan outstanding at any time. The loan is secured by the balance in the participant's account. The bear interest rate is set at the Prime rate as published in the *Wall Street Journal*, plus 2%. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses – Certain expenses of the Plan are paid by the Organization and are not included in the statement of changes in net assets available for benefits. The Plan paid expenses related to recordkeeping expenses and other miscellaneous expenses, which totaled \$19,130.

Termination of the Plan – Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Contributions – Company and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends and interest income are recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, a portion of management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant

loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Date of Management's Review – Subsequent events have been evaluated through August 25, 2025, which is the date the financial statements were available to be issued, and there were no events or transactions identified requiring additional disclosure or recognition.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the published net asset value (NAV) of shares held by the Plan at year end.

Common/collective trust funds – The investment advisors calculate a unit value (similar to a net asset value “NAV”) of a separate account daily. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any. They are valued daily, may be redeemed daily without restrictions, and with no notice requirements. Additionally, there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Alerus Financial, N.A., the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments, at fair value
- Net appreciation in fair value of investments
- Notes receivable from participants and related interest
- Interest and dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. TAX STATUS

The Organization adopted a Prototype Non-Standardized Profit-Sharing Plan with a deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Organization believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Synergy Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions, which is available from the Plan Administrator.

General – The Plan is a defined contribution plan sponsored by Synergy Services, Inc. (the “Organization”) covering all eligible employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Alerus Financial N.A. serves as the Plan’s recordkeeper, custodian and trustee.

Eligibility Conditions – An employee will be eligible to participate in the Plan after attaining the age of 21 and may enter the Plan immediately. An employee is eligible for the employer contribution after completing one year of service and has attained age 21. An eligible participant enters the Plan for the employer contribution on the first day of the month that coincides with or next follows the date on which the requirements are satisfied.

Years of Service – An employee will have completed a year of service if, at the end of their first twelve months of employment with the Employer, the employee has been credited with at least 1,000 hours of service. If the employee has not been credited with 1,000 Hours of Service by the end of their first twelve months of employment, they will have completed a year of service at the end of any following Plan year during which they were credited with 1,000 hours of service.

Contributions – The Plan permits eligible employees to make annual contributions up to 100% of eligible compensation, subject to certain limitations in the Internal Revenue Code (“IRC”). Matching contributions are discretionary as determined by the Organization’s Board of Directors. The Organization’s matching contribution in 2024 was 50% of employees’ salary deferral amounts on the first 4% of the employees’ compensation.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Organization’s contribution and Plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions. Vesting in the Organization’s contribution portion of their accounts plus earnings thereon is based on continuous service. A participant is 25% vested after 1 year of service, 50% vested after 2 years of service and fully vested after 3 years of continuous service.

Forfeitures – The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce the Organization’s matching contribution. During 2024, no forfeitures were used. There are \$9,218 and \$4,848 forfeitures remaining at December 31, 2024 and 2023, respectively.

Payment of Benefits – Distributions from the Plan are made upon death, retirement, or termination pursuant to the Plan provisions and as permitted by law. A participant’s account balance under \$5,000 will be subject to automatic distribution. A participant with a vested

account balance of \$5,000 or greater may elect a lump-sum payment or elect to leave their investment in the Plan.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferrals, matching contributions, rollover contributions and non-elective contributions.

Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years (or 15 years for the purchase of a primary residence). Participants may only have one loan outstanding at any time. The loan is secured by the balance in the participant's account. The bear interest rate is set at the Prime rate as published in the *Wall Street Journal*, plus 2%. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses – Certain expenses of the Plan are paid by the Organization and are not included in the statement of changes in net assets available for benefits. The Plan paid expenses related to recordkeeping expenses and other miscellaneous expenses, which totaled \$19,130.

Termination of the Plan – Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Contributions – Company and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends and interest income are recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, a portion of management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant

loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Date of Management's Review – Subsequent events have been evaluated through August 25, 2025, which is the date the financial statements were available to be issued, and there were no events or transactions identified requiring additional disclosure or recognition.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the published net asset value (NAV) of shares held by the Plan at year end.

Common/collective trust funds – The investment advisors calculate a unit value (similar to a net asset value “NAV”) of a separate account daily. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any. They are valued daily, may be redeemed daily without restrictions, and with no notice requirements. Additionally, there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Alerus Financial, N.A., the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. TAX STATUS

The Organization adopted a Prototype Non-Standardized Profit-Sharing Plan with a deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Organization believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.
