Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of *AdvisaCare Companies Retirement Plan*, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the *AdvisaCare Companies Retirement Plan* ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the following employers ("Company"):

AdvisaCare Health Solutions, Inc.
UNS Home Health Agency
Professional Rehabilitation Services, Inc. (d/b/a Rebound Physical and Occupational Therapy)
Diversified Hospice Care, Inc. (d/b/a AdvisaCare Hospice)
AdvisaCare Solutions of Nevada, Inc.
AdvisaCare Solutions of Arizona, LLC
AdvisaCare Hospice, LLC
AdvisaCare Solutions of Northern Michigan, LLC

To be eligible to participate in the Plan, participants were required to have completed 90 days of service and be age 18 or older. Effective November 18, 2024, the Plan was amended to change the service requirement to two consecutive months of employment along with being age 18 or older.

Effective January 1, 2022, the Plan was restated via a Newport Group, Inc. Non-Standardized Pre-Approved Plan. The Plan was restated to comply with the latest regulations of the Internal Revenue Code (IRC) and to comply with the provisions of the SECURE Act, CARES Act, and Consolidated Appropriations Act (CAA). The Plan is subject to the provisions of ERISA.

Contributions

Participants may contribute elective salary reductions up to 100 percent of their compensation as long as the total contribution does not exceed the legal dollar or percentage limits for the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Contributions - Continued

The Company has the right to make discretionary matching contributions to eligible employees each plan year. The Company's annual matching percentage is determined by the Company on a uniform basis for all participants and requires the participant to be employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Company's matching contribution were \$125,148 (14 percent) and \$118,598 (15 percent), respectively.

Participant Accounts

Each participant's account is credited with the participant's elective salary reduction contribution, the Company's matching contribution, and Plan earnings (losses) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that could be provided from the participant's account.

Vesting

Participants are immediately vested in their elective salary reduction contributions plus actual earnings allocated thereon. Participants are fully and immediately vested in the Company's matching contribution.

Participant Loans

The Plan does not permit participants to borrow funds from their accounts.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the value of the participant's vested interest in their account. In-service withdrawals are permitted upon attaining age 59½ or in cases of financial hardship.

Plan Forfeitures

The Plan had outstanding forfeited amounts received of \$- 0 - and \$43 at December 31, 2024 and 2023, respectively. The Plan uses forfeited amounts to either reduce employer contributions or to offset the Plan's administrative expenses. The Plan forfeiture balance has been included within the collective trust fund balance reported on the statements of net assets available for benefits at both December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Plan Expenses

Certain administrative expenses of the Plan are paid by the Plan in accordance with Plan provisions. All other administrative expenses, including compensation for officers and employees performing administrative functions, are paid by the Company and are excluded from these financial statements.

Subsequent Events

Management has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE AND RECORDKEEPER

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Ascensus Trust Company, recordkeeper, custodian, and trustee of the Plan, for the period November 14, 2024 through December 31, 2024, and Newport Trust Company, recordkeeper and trustee of the Plan, for the period January 1, 2024 through November 13, 2024, and for the year ended December 31, 2023.

NOTE 4 - INVESTMENT IN STABLE VALUE FUND

The Plan invests in the Stable Value Fund of T. Rowe Price ("Fund"). The Fund invests in a variety of investment contracts such as separate account contracts and synthetic investment contracts issued by insurance companies, banks, and other financial institutions and other short-term investments. The objectives of the Stable Value Fund are to maximize current income consistent with the maintenance of principal and to provide benefit-responsive participant withdrawals at contract value. Participants may redeem trust units on a daily basis for withdrawal or transfer of all or a portion of their investment at contract value without restriction. Units are issued and redeemed daily at the Fund's constant net asset value (NAV) of \$1 per unit.

Contract value is the relevant measurement attribute for that portion of the net assets of a fund attributable to fully benefit-responsive Wrap Contracts. The contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of their employer sponsored defined-contribution plans which invest in the Fund. The fair value of Wrap Contracts generally is reflected by market value at the close of business on the valuation date. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value and reported with the investments at fair value under the principles of ASU 2015-12. Participating plans may terminate their interest in the Fund at any time. Withdrawals shall be paid at the lesser of book or market value, as defined in the Fund's Declaration of Trust. The contract value of the investment contract at December 31, 2024 and 2023, was \$6,010 and \$7,409 respectively.

The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value. Events outside the normal operation of the Fund may result in a negative market value adjustment. Examples of such events include: partial or complete legal termination of the Fund; a failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; any transfer of assets from the Fund directly into a competing investment option; the establishment of a defined contribution plan that competes with the Plan for employee contributions; or complete or partial termination of the Plan or its merger with another plan. The occurrence of an event outside the normal operating of the Fund which would cause a negative market value adjustment is not considered to be probable.

NOTE 4 - INVESTMENT IN STABLE VALUE FUND - CONTINUED

The Fund invests in assets, typically fixed income securities or bond funds, and enters into Wrap Contracts issued by third parties. A Wrap Contract is an agreement by another party, such as a bank or insurance company to make payments to the Fund in certain circumstances. The existence of certain conditions can limit the Fund's ability to transact at contract value with the issuers of its Wrap Contracts. Specifically, any event outside of the normal operation of the Fund which causes a withdrawal from the Wrap Contracts may result in a negative market value adjustment with respect to such withdrawal. Example of such events include, but are not limited to, layoffs, bankruptcy, plan termination, mergers, early retirement incentives, and competing fund transfers or violations of equity wash or equivalent rules and changes of employer or plan qualification status. If the likelihood of such a non-book value withdrawal is imminent, it may be necessary to consider a revaluation of those particular fund contracts. The occurrence of an event outside the normal operating of the Fund which would cause withdrawals from Wrap Contracts is not considered to be probable.

In the event that Wrap Contracts fail to perform as intended, the Fund's NAV may decline if the market value of its assets declines. The Fund's ability to receive amounts due pursuant to these Wrap Contracts is dependent on the third-party issuer's ability to meet their financial obligations. The Wrap Contract issuer's ability to meet its contractual obligations under the Wrap Contracts may be affected by future economic and regulatory developments.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

NOTE 5 - FAIR VALUE MEASUREMENTS - CONTINUED

Level 1 Fair Value Measurements

The fair value of interests in registered investment companies is based on quoted NAVs of the shares held by the Plan at year-end.

For the years ended December 31, 2024 and 2023, the Plan's investment in the Fund (see Note 4) was valued using the NAV as a practical expedient which represents the price at which the Plan is able to initiate a transaction. This investment is excluded from the fair value hierarchy. The inputs or methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities. The Plan's investments calculated at the NAV, per share, may be redeemed on a daily basis at the NAV as of the measurement date. There are no unfunded commitments.

NOTE 6 - EXCESS CONTRIBUTIONS

To satisfy the relevant nondiscrimination provisions of the plan for the year ended December 31, 2024, distributions of \$28,844, were made to certain active participants in June 2025.

The relevant nondiscrimination provisions of the Plan were satisfied without the return of any excess deferral contributions to active Plan participants for the year ended December 31, 2023.

NOTE 7 - TAX STATUS

Effective January 1, 2022, the Plan was restated via a Newport Group, Inc. Non-Standardized Pre-Approved Plan which has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan was designed in accordance with applicable sections of the IRC and, therefore, the Plan is qualified and the related trust is tax exempt. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies and collective trust funds managed by Ascensus Trust Company, recordkeeper, custodian, and trustee of the Plan for the period November 14, 2024 through December 31, 2024, and Newport Trust Company, recordkeeper, custodian and trustee of the Plan for the period January 1, 2024 through November 13, 2024, and for the year ended December 31, 2023. Therefore, these transactions qualify as party-in-interest transactions. The party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9 - NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024, it was discovered that certain participants' amounts withheld were not timely remitted to the Plan. The total amount of late remittances contributed to the Plan for the year ended December 31, 2024, was \$214,807. The Plan sponsor will be remitting lost earnings to the Plan for these late remittances.

NOTE 10 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to provisions of ERISA.

NOTE 11 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 12 - RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

There were no reconciling items between the financial statements and Schedule H of the Form 5500 for the years ended December 31, 2024 and 2023.
