### NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Vandor Corporation Employee Benefit Retirement Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - On January 1, 1993, Vandor Corporation (Michigan) adopted a Section 401(k) profit-sharing plan. On July 1, 1994, Vandor Corporation (an Indiana Corporation) (the "Sponsor") purchased assets from Vandor Corporation (Michigan) and thus began participating in the Plan. At that time, the Vandor Corporation (Michigan) changed its name to Elder Group, Inc. and continued participating in the Plan. On January 1, 1995, Elder Group, Inc. created its own plan and transferred assets from the existing plan to a new plan named Elder Group, Inc. Employee Benefit Retirement Plan. Since Elder Group, Inc. transferred funds from the Plan to their own plan, Vandor Corporation (Indiana) took over the Plan which includes all fully owned subsidiaries in its Plan. In 2016, Elder Group, Inc. began participating in Vandor Corporation (Indiana) Plan again and no amounts were transferred into the Plan. During 2024 and 2023, the participating companies ("Companies") in the Plan included Vandor Corporation (Indiana), Elder Group, Inc., and Starmark Local, LLC. Effective May 1, 2024, RPM Plastics started participating in the Plan. The Plan allows all employees of the Companies, who have six months of service and have attained age 18, to participate. Upon satisfaction of the eligibility requirements, employees may enter the Plan on the first day of the quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Transfer of Plan Assets** - On October 15, 2024, the Companies approved the transfer of assets from the Vandor Corporation Employee Benefit Retirement Plan into the Vandor Corporation, AE of Shepherd Pooled Employer Plan. As a result, all Plan assets were transferred from the Vandor Corporation Employee Benefit Retirement Plan into the Vandor Corporation, AE of Shepherd Pooled Employer Plan on December 27, 2024.

**Contributions** - The Plan provides for pre-tax employee salary deferrals within statutory limits, as defined in the Plan agreement, each year as an elective deferral. In addition, effective January 2020, participants may also make Roth contributions on after-tax compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catchup contributions.

Eligible employees are automatically enrolled into the Plan with a 3% deferral rate, unless they notify the Sponsor that they do not wish to participate. The automatic deferral percentage shall increase upon the first day of the Plan year by 1% in the second through fourth year to a maximum of 6%.

The employer match is discretionary. For the period from January 1, 2024 through December 27, 2024 and year ended December 31, 2023, the Companies contributed 100% of the first \$500 of employee contributions, then 50% on the dollar up to a maximum of \$3,000. The Companies contributed \$297,744 and \$249,259 during the period from January 1, 2024 through December 27, 2024 and year ended December 31, 2023. In addition, the employer contributions included \$582 of qualified non-elective contributions during the period from January 1, 2024 through December 27, 2024. There were no qualified non-elective contributions in 2023.

Employee deferrals and the related employer matches were made to the Plan through December 3, 2024. Subsequent employee deferrals and employer matches were contributed to the Vandor Corporation, AE of Shepherd Pooled Employer Plan.

### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

The Companies may, at their discretion, make a profit sharing contribution to the Plan to those eligible participants that meet the eligibility requirements above. Profit sharing contributions will be allocated to each participant eligible to share in the allocation and such contributions, should they be made, will be allocated in the ratio that each participant's compensation bears to the compensation of all eligible participants. No profit sharing contribution was made for the period from January 1, 2024 through December 27, 2024 and year ended December 31, 2023. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitation allowed by the Internal Revenue Service.

**Participant Accounts** - Ascensus Trust Company is the Trustee of Plan investments. Each participant's account is credited with the participant's contributions, Companies' contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Companies' contributions are allocated based on participants' compensation as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution and employer contributions are to be invested.

**Vesting** - Participants are immediately vested in their voluntary contributions, rollovers, and corresponding earnings. The following schedule will be used to determine vesting in the Plan match, profit sharing, and their earnings:

**Notes Receivable From Participants** - Participants may borrow from their fund account balance in any amount between \$1,000 and \$50,000, but not more than 50% of their vested account balance. Loans bear interest at the prime rate plus 1%. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participant's accounts. Principal and interest are paid ratably through payroll deductions.

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$5,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. In addition, participants may receive distributions from all vested amounts for qualified financial hardships.

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts are first used to pay Plan administrative expenses and then used to reduce Company contributions. Forfeitures of \$17,710 and \$15,073 were used during the period from January 1, 2024 through December 27, 2024 and year ended December 31, 2023. The forfeiture balance as of December 27, 2024 that was transferred to the Vandor Corporation, AE of Shepherd Pooled Employer Plan was \$16,223. Unallocated forfeitures at December 31, 2023 were \$18,141.

#### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Investment Options** - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options and deferral percentages at any time via paper form or the internet.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. All Plan investments were transferred to the Vandor Corporation, AE of Shepherd Pooled Employer Plan on December 27, 2024. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. There was no reserve recorded at December 31, 2023, for loans that might be uncollectible. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Companies pay certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses. Administrative fees for distributions and loans are paid by Plan participants. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.

### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 27, 2024, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants from January 1, 2024 through December 27, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the Trustee of the Plan). The Plan assets were transferred on December 27, 2024.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the Trustee of the Plan).

### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

#### NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value.

*Investments in registered investment companies:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Common collective trust:* Valued based on the valuation formula contained in the contract of the underlying guaranteed interest accounts; provides a daily mil-rate for income accretion.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - RELATED PARTY TRANSACTIONS

Certain Plan assets are invested with Ascensus Trust Company. The Ascensus Trust Company provides services in coordination with the Vanguard Group, Inc. Thus, Ascensus Trust Company, as Trustee defined by the Plan, and the Vanguard Group, Inc. qualify as parties-in-interest. Fees paid by the Plan to the Vanguard Group, Inc. in care of Ascensus Trust Company during the period from January 1, 2024 through December 27, 2024 and year ended December 31, 2023 were \$29,085 and \$24,309.

Shepherd Financial provides investment management services through Capital Analysts for the Plan. Fees paid by the Plan to Capital Analysts during the period from January 1, 2024 through December 27, 2024 and year ended December 31, 2023 totaled \$28,270 and \$17,853.

The Plan Sponsor provides certain accounting, recordkeeping, and administrative services to the Plan, for which it receives no compensation.

### NOTE 6 - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 7 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS

At December 31, 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

### NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
