## INDEPENDENT AUDITORS' REPORT

To the Trustees, Retirement Committee and Participants of the Conexon 401(k) Plan  
Kansas City, Missouri

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Conexon 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Responsibilities of Management for the Financial Statements**

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of Conexon 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was originally established January 1, 2017.

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of Conexon, LLC (the “Company”).

The Standard Insurance Company (“Standard”) serves as custodian and Standard Retirement Services serves as recordkeeper of the Plan. Owners of the Company serve as Trustees to the Plan.

**Eligibility** – An employee is eligible to participate in the Plan upon reaching the age of 18 and completing 3 months of service. Entry dates for employee and employer contributions are the first of the month following eligibility. The Plan excludes leased employees, union employees, residents of Puerto Rico and nonresident aliens.

**Contributions** – Participants may contribute amounts up to certain Internal Revenue Code (“IRC”) limitations. Participants may contribute pre-tax amounts (“401(k) contributions”) or after-tax amounts (“Roth contributions”). A participant who is at least 50 years old may also contribute catchup contributions to the Plan.

The Company may make a discretionary matching contribution to all eligible employees who have deferred to the Plan. The matching contribution is paid into the Plan each payroll. In 2024, matching contributions were 100% up to 7% of eligible compensation that a participant contributes to the Plan.

The Company may also make a discretionary profit-sharing contribution. A participant must be employed on the last day of the year in order to receive a profit-sharing contribution (if declared). No profit-sharing contribution was declared in 2024.

**Participant Accounts** – Each participant’s account is credited with the participant’s and Company’s contributions, investment earnings, and is charged with the participant’s withdrawals and distributions, and an allocation of expenses, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – The Plan offers a variety of pooled separate accounts and a guaranteed interest account as investment options for participants.

**Vesting** – Participants’ contributions and nonelective employer contributions are fully vested at all times. Vesting in the Company’s other contributions is based on a graded vesting schedule depending on the participant’s employment date and years of service as noted below. Participants have completed a year of service for vesting purposes if they worked at least 1,000 hours during a plan year or the twelve-month period beginning on their hire date.

In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

**Forfeitures** – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures may be applied to employer contributions and Plan expenses. As of December 31, 2024 and 2023, there were \$621 and \$51,747 in forfeitures, respectively. In 2024, the Plan Sponsor used approximately \$133,000 in forfeitures to reduce employer contributions and \$3,600 to offset Plan expenses.

**Payment of Benefits** – Distributions of a participant’s vested balance may occur upon normal retirement, termination of employment, death, or permanent and total disability in the form of a total lump sum or installment payments if the participant is subject to lifetime required minimum distributions. Participant balances under \$1,000 may be automatically distributed to the participant in a lump-sum. If a participant’s account balance is between \$1,000 and \$7,000, the balance will be automatically rolled over to an IRA, unless a different election is made.

**In-Service Withdrawals** – Participants may make withdrawals prior to termination of employment as follows:

- Hardship withdrawals are available to the plan participants for reasons as defined in the Plan Document and are limited to a participant’s vested balance.
- Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.
- Participants may withdraw amounts that are designated as rollover contributions at any time.

**Notes Receivable from Participants** – Participants are permitted to borrow against their individual account balances a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant’s vested account balance. Loans are secured by the participant’s vested account balance. Interest rates on the loans are set 2% plus the prime rate, as determined by the *Wall Street Journal*, or 1% plus the prime rate for a residential loan. Loan terms are in accordance with limitations set forth by the Internal Revenue Service, and may not exceed five years, unless the loan is to purchase a primary residence. Loan repayments are made ratably through payroll deductions or through automatic clearing house (“ACH”) payments.

**Administrative Expenses** – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. During 2024, the Plan paid administrative expenses of \$75,172.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants shall become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in the pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

**Date of Management's Review** – Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

## 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled Separate Accounts – Valued at the net asset value (“NAV”) provided by the administrator of the fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets (i.e., common stock, mutual funds, short term securities) owned by the fund, less its liabilities, and then divided by the number of shares outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

These investments are valued daily, can be redeemed daily with no restrictions, and without prior notice. There are no unfunded commitments.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

## **5. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan provides the Minnesota Life Guaranteed Return Account, a fully benefit-responsive investment contract issued by Minnesota Life, acquired by The Standard Insurance Company in October 2022, as an investment option for participants. The objective of this investment option is to guarantee principal and provide a stated interest crediting rate backed by Minnesota Life. The contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Minnesota Life is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is determined on a quarterly basis, as designated by Minnesota Life. The investment contract may be subject to a market value adjustment should the Plan discontinue the contract, as prescribed in the contract. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Minnesota Life may not terminate the contract at any amount less than contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

## **6. INFORMATION CERTIFIED BY CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Minnesota Life Insurance Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Investments, at contract value
- Notes receivable from participants and related interest income
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are units of pooled separate accounts, and a guaranteed return account managed by Minnesota Life, which was acquired by The Standard Insurance Company in October 2022. The Standard is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Certain fees are paid to the custodian and recordkeeper, and these are party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest.

## **8. TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit-sharing Plan with CODA, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. PROHIBITED TRANSACTIONS**

During 2024, employee deferrals of \$504,247 were not remitted to the trust on a timely basis (as defined by the Department of Labor) by the Plan Sponsor. The Plan Sponsor will subsequently remit all such deferrals to the trust, will calculate lost earnings on these untimely contributions and remit the related excise tax to the IRS. These transactions are prohibited according to the provisions of the DOL.

During 2023, employee deferrals of \$661 were not remitted to the trust on a timely basis (as defined by the Department of Labor) by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust, calculated lost earnings on these untimely contributions and remitted the related excise tax to the IRS. These transactions are prohibited according to the provisions of the DOL.


