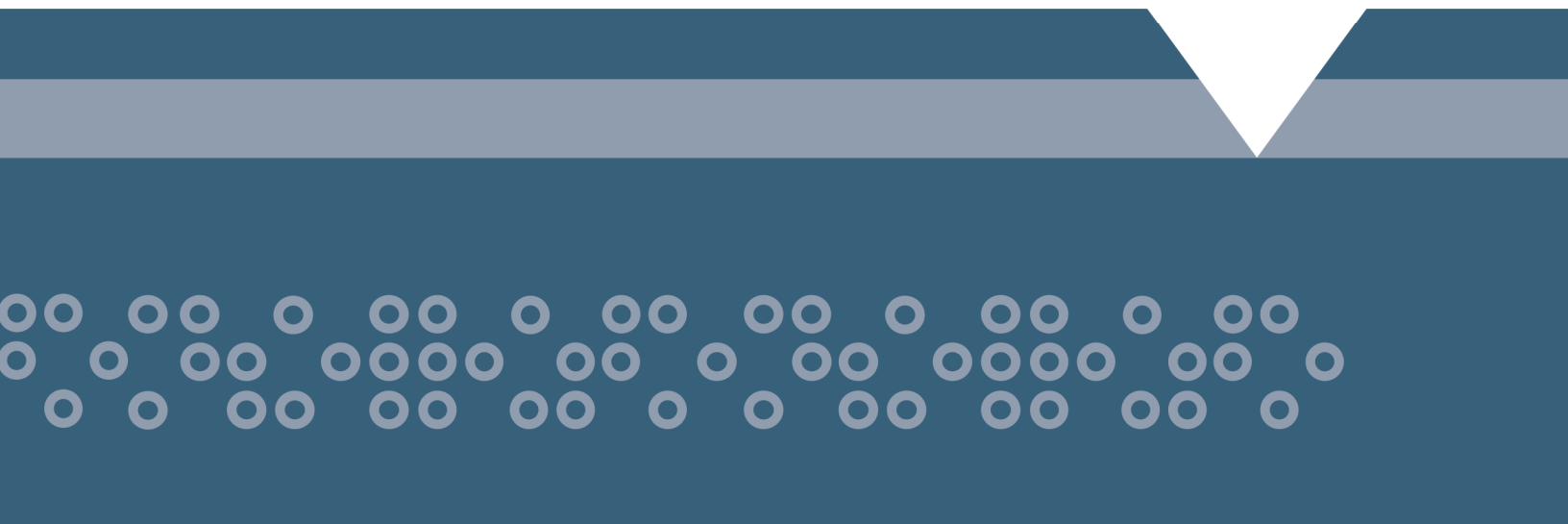

Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of McLawrence Foods, LLC Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan:

The following description of McLawrence Foods, LLC Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan (or We) is a defined contribution plan covering all eligible employees of McLawrence Foods, LLC and McDaniel Food Management Co., Inc., collectively operating as Mac's Fresh Market (the Company) that was established with an effective date of January 1, 2002. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Mid Atlantic Trust Company (Mid Atlantic) serves as the Plan asset custodian and Leon E. Werntz & Associates (Werntz) serves as the record keeper.

Eligibility

Participation in the Plan is limited to employees of Mac's Fresh Market who have attained the age of 19 and have completed 1 year of continuous service as defined by the Plan document. Employees may enter the Plan on the first day of the first or seventh month of the year, after they become eligible.

Contributions

The Plan allows employee deferral contributions, discretionary employer contributions, and employer discretionary profit-sharing contributions. The Plan has no required matching contribution feature. Each year, participants may elect to contribute up to 100 percent of pretax eligible compensation, as defined in the Plan. Participants who have met certain requirements are eligible to make "catch up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, once they have met the requirements to be a participant. Discretionary employer contributions for the years 2024 and 2023 were \$46,750 and \$93,500.

Participant Accounts

Each participant's account is credited with the participant and employer contributions and allocations of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of continuous service and generally begins at 20 percent after two years of credited service and increasing to 100 percent after six years of credited service.

Payment of Benefits

The Plan received excess contributions for certain participants. Excess contributions refundable to participants were \$0 and \$4,390 for 2024 and 2023 Plan years, respectively. Excess contributions are refunded to participants in the first two and a half months of the subsequent Plan year per Internal Revenue Service (IRS) regulation.

Upon death, disability, retirement, or termination, a participant shall be entitled to receive that participant's account balance in a lump-sum payment. A participant's benefits will be distributed no

later than April 1 of the calendar year following the later of: (1) the calendar year in which the participant attains the age of 72 or (2) the calendar year in which the participant retires.

Participants no longer active within the Plan who have a vested balance of less than \$5,000 are required to remove funds from the Plan. Failure to do so will result in required distributions into an individual retirement account on behalf of the former participant. In-service distributions are available to participants who have reached the age of 59.5 years old.

Forfeited Accounts

Forfeitures represent the portion of non-vested benefit payments remaining in the Plan for terminated employees. Forfeitures are used to reduce employer matching contributions. No significant forfeiture balances were available or applied toward the employer's contribution for the years ended December 31, 2024 and 2023.

Administrative Expenses

The Plan sponsor paid expenses of approximately \$29,504 and \$33,118 during 2024 and 2023, respectively, for the administration of the Plan. These expenses have not been included in the accompanying Statements of Changes in Net Assets Available for Benefits.

Note 2 – Summary of Significant Accounting Policies:

Basis of Accounting

The accompanying financial statements were prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from those estimates. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Note 3 – Federal Income Taxes:

The IRS, in its letter dated December 10, 2020 stated that the Plan documents as adopted by the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not been amended since receiving the determination letter. The Plan administrator believes that the Plan is

currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, believes the Plan is qualified and that the related trust is tax exempt. The Plan administrator asserts the Plan has no income subject to unrelated business income tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 4 – Information Prepared and Certified by Plan Custodian:

The Plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The assets of the Plan are held by the custodian.

The Plan has received certification from the custodian of the market value of all the Plan's investments to participants as of December 31, 2024 and 2023, and of interest income and net appreciation (depreciation) in fair value of investments for the years ended December 31, 2024 and 2023. The Plan's financial statements and supplemental schedule of assets have been prepared based upon this certified information and reflect the amounts certified by the custodian.

Note 5 – Concentration of Credit Risk:

The Plan contains certain investment options, whose balances represent a significant concentration of Plan investments. For the year ended December 31, 2024, American Funds American Mutual Funds, American Funds Growth Fund of America and Investment Company of America Funds represented 60 percent of total investments, and each individually represented in excess of 10 percent of total investments. For the year ended December 31, 2023, American Funds Growth Investment Company of America, and American Balanced Funds represented 45 percent of total investments, and each individually represented in excess of 10 percent of total investments.

Note 6 – Fair Value Measurements:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. Following is a description of the valuation methodologies used for investments measured at fair value.

Money Market/Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 – inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 – observable inputs, such as, quoted market prices of similar assets or liabilities in active markets or for identical assets or liabilities in markets that are not active; and Level 3 – inputs are unobservable and have the lowest priority. As discussed above, the Plan uses appropriate valuation

techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Note 8 – Amendment and Termination:

Although it has not expressed an interest to do so, the Company has the right to amend or terminate the Plan and the related trust at any time subject to the provisions set forth in ERISA. In the event of Plan termination, participants non-vested account balances will immediately vest.

Note 9 – Party-in-Interest and Related Party Transactions:

The Plan and its participants pay both direct and indirect fees to the custodian for investment management services and other service providers. The Plan sponsor may pay directly certain other fees related to Plan operations. Transactions such as these qualify as party-in-interest transactions.

Note 10 – Risks and Uncertainties:

The Plan holds various investment instruments via mutual funds and interest-bearing cash options. Each of the instruments is designed to offer participants various levels of risk tolerance. In general, all investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market volatility can be impacted by both domestic and global economic conditions. Due to the level of risk associated with certain investment options, it is reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported on the financial statements. However, it is difficult to forecast these conditions future impact on the Plans operations and assets with any certainty.

Note 11 – Subsequent Events:

We have evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.
