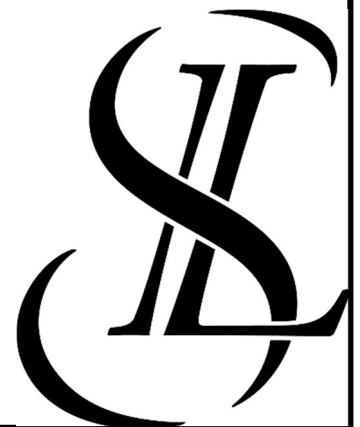

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Fairfield Chair 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

### 1. Description of the Plan

The following description of the Fairfield Chair 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan available to qualifying employees of Fairfield Chair Company (the “Company”) who are age 18 or older and have completed one month of service. Upon meeting the eligibility requirements, employees may begin participation as of the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Eligible employees are automatically enrolled at a 3% pre-tax deferral percentage, unless they elect an alternative deferral percentage or decline participation. Participants may otherwise contribute up to 100% of their pre-tax or after-tax compensation, as defined in the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company will make safe-harbor matching contributions equal to 100% of the first 3%, plus 50% of the next 2% of compensation contributed by participants into the Plan. The Company may also make a discretionary profit-sharing contribution to be determined annually by the Board of Directors. No discretionary profit-sharing contributions were made for 2024 or 2023.

Participants may direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant account is credited with the participant’s and Company’s matching contributions, an allocation of the Company’s profit sharing contribution, plan earnings, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their own voluntary contributions and the Company’s safe-harbor matching contributions, plus actual income or loss thereon. Vesting in the Company’s previous discretionary matching contributions, plus any income or loss thereon, is based on years of continuous service according to the following schedule.

Vesting in any Company discretionary profit-sharing contributions will be based upon a three-year cliff vesting schedule.

### 1. Description of the Plan (Concluded)

#### **Benefit Payments**

Upon termination of service due to death, disability, retirement, or separation, participants may receive a partial distribution, installment payments, or a lump-sum amount equal to the value of their vested account balance. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with plan provisions.

#### **Forfeitures**

Forfeitures from non-vested participant accounts may be used to offset administrative expenses or Company contributions. During 2024 and 2023, approximately \$136,000 and \$45,000 of forfeitures were utilized to offset Company contributions. Forfeitures of approximately \$11,000 and \$129,000 were available at December 31, 2024 and 2023.

#### **Notes Receivable from Participants**

Participants may borrow from their plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms are generally up to five years and only one note may be outstanding at a time. The notes are secured by the vested account balance in the participant's account and bear interest at the prime rate plus 1% at the date of the application. Principal and interest are paid ratably through payroll deductions.

#### **Administrative Expenses**

The Company absorbs substantially all expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including trustee fees and asset fees, are paid by the Plan. Loan and distribution fees are paid out of the affected participants' accounts.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### 2. Summary of Significant Accounting Policies (Concluded)

#### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Benefit Payments**

Benefit payments to participants are recorded when paid.

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through July 23, 2025, the date that the financial statements were available to be issued, determining no events require adjustment to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Tax Status

The Plan has adopted a prototype plan document sponsored by FMR LLC (d/b/a Fidelity Institutional Asset Management). The IRS has determined and informed FMR LLC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Certain investments of the Plan are managed by Fidelity Investments, an affiliate of the Plan's trustee. Fees paid by the Plan to Fidelity and affiliates for trustee and other administrative services were approximately \$42,000 and \$43,000 during 2024 and 2023.

Fees paid by the Plan to Kestra Investment Services LLC for investment advisory services were approximately \$28,000 and \$29,000 in 2024 and 2023.

Fees paid by the Plan to Strategic Advisors, Inc. for investment advisory services were approximately \$7,000 and \$6,000 in 2024 and 2023.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer using estimated fair value of the underlying assets, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
