Opinion

We have audited the accompanying financial statements of United Association of Plumbers and Pipefitters Local No. 160 Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of United Association of Plumbers and Pipefitters Local No. 160 Health and Welfare Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about United Association of Plumbers and Pipefitters Local No. 160 Health and Welfare Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among those matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets held at end of the year are presented for the purpose of additional analysis and are not a required part of the financial statements, but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of United Association of Plumbers and Pipefitters Local No. 160 Health and Welfare Plan (the “Plan”) provided only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General

The Plan and related trust were established January 1, 1968. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan provides health benefits and life insurance for eligible participants, spouses, and dependents. The Plan has been amended several times since its creation.

Contributions

The Plan receives contributions from employers who have signed the collective bargaining agreement with UA Local No. 160. In addition, the Plan receives reciprocal contributions from other UA Locals, self-payments from retirees and unemployed members. The Plan conducts payroll audits of participating employers.

Stop Loss and Reimbursements

The Plan purchases stop loss insurance to fund major claims in excess of the deductible specified in the policy.

Benefits

The Plan provides health and other benefits covering members and their eligible dependents. The eligibility requirements are discussed in detail in the Summary Plan Description which specifies when a member qualifies for initial coverage and the requirements for continued coverage.

Extended eligibility is based on the hour bank, which is credited with all hours worked. If the hour bank has at least 300 hours within last quarter or 1,200 hours in last four quarters, coverage continues for the next quarter. In periods of full employment, participants will have two quarters of coverage banked.

Retired or disabled members who wish to continue coverage for themselves (and their spouse) may do so by making self-payments at rates determined from time to time by the Trustees. Upon the death of a retired member who was continuing self-pay coverage under the Plan for themselves and their spouse, the surviving spouse may continue to self-pay for coverage indefinitely.

None of the benefits provided by this Plan, including retiree benefits, are vested. The Trustees retain the authority to amend, alter, modify, reduce, or terminate any of the benefits provided by this Plan when in their discretion, they deem such changes to be necessary.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported (IBNR), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefits

Benefits are recognized when paid by the Plan.

Postretirement Benefits

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for currently retired or terminated employees and their beneficiaries and dependents. The employers do not contribute for post-retirement benefits, they are funded solely by self-payments.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Assumptions used by Actuary

Changes in assumptions for the year ended December 31, 2024:

The discount rate was changed from 4.8% to 5.5% to reflect the current interest rate environment.

Per capita claim costs for non-Medicare participants, averaged over a three-year period, decreased 3.49%. Per capita claim costs for Medicare participants, based on the fully insured premium amount, increased 29.56%.

Self-pay premiums for non-Medicare participants increased 5.00%. Self-pay premiums for Medicare participants increased 2.5%. It is assumed self-pay rates will be increased in the future according to assumed medical inflation rates.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Accumulated Eligibility Credits

Plan obligations at December 31, 2024 and 2023 for health claims incurred by active participants but not reported at that date, for accumulated eligibility of participants, are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value, based on a 5.5% and 4.8% percent discount rate for December 31, 2024 and 2023, respectively. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (the Act)

The Plan does not participate in the Act.

Funding Policy for Deficit

The Plans benefit obligations exceed the net assets available for benefits. It is the policy of the trustees to fund the benefits as they are paid.

Subsequent Events

Subsequent events have been evaluated through the date of the independent accountant's audit report, which is the date the financial statements were available to be issued.

3. BENEFIT OBLIGATIONS

The weighted-average health care cost-trend rate assumption (see Note 2) has a significant effect on the amounts reported in the accompanying financial statements. If the trend rate were increased by 1.0%, the effect would increase to \$9,347,786 and \$8,677,132 for the years ended December 31, 2024 and 2023, respectively.

4. TAX STATUS

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the trust's net investment income is exempt from income taxes.

5. INVESTMENTS

The Plan does not have any investments other than cash and certificates of deposit which are not subject to fair value measurements. The Plan accounts are subject to the risk that balances more than the FDIC insurance limits may not be recovered in the event of a bank failure.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan receives reciprocity contributions and makes reciprocity payments to other UA Locals as disclosed in the financial statements.

The Plan contracts for services from third party providers. These services are considered party-in-interest transactions and are believed to be exempt.

7. TERMINATION OF THE PLAN

Although the trustees have no intention of terminating the Plan under certain conditions, the Plan may be terminated. Generally, this would be when the obligation of the employers to make contributions to the Plan ceases, merger or other events.

8. CONCENTRATIONS

Three employers each exceeded 10% of the contributions for the year ended December 31, 2024, and two employers each exceeded 10% of the contributions for the years ended December 31, 2023.

9. RISKS AND UNCERTAINTIES

In order to meet its future benefit obligation, the contributions from employers and participants will need to be maintained at levels sufficient to pay the benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties, inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
