NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Perseus House, Inc. Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering employees of Perseus House, Inc. ("the Company") who have completed one year of service, provided they have worked at least 1,000 hours of service during that twelve-month period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year participants may contribute up to the maximum percentage or dollar amount allowed by law. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The employer will match the elected deferrals up to 6% and 5% of compensation for the years ended December 31, 2024 and 2023, respectively. In addition to the match, the employer will contribute 2.5% and 3.5% of gross compensation for each eligible employee, regardless of elected deferrals as a discretionary contribution for the years ended December 31, 2024 and 2023, respectively. For the year ended December 31, 2024 the discretionary contribution, if applicable, is allocated as of the last day of the plan year using annual pay for the plan year for each employee who is an active participant on the last day of the plan year and who has at least 1,000 hours and 1 year of service during that period. For the year ended December 31, 2024 the discretionary contribution was \$114,563.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of the (a) employer contributions and, (b) Plan earnings. Each contribution is allocated at the time it is received by the custodian. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions and the employer match plus actual earnings thereon. The employer contribution is 100% vested after three years of credited service.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Notes receivable from participants - Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4% to 10%, which are 1% below the current prime rate. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant must receive a lump-sum amount distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may request a hardship withdrawal of the portion of their account attributable to elective deferrals and certain employer contributions.

Forfeited Accounts - Forfeitures will be used to reduce future employer contributions. See below for the forfeiture activity for the years ended December 31, 2024 and 2023.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared based on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net investment appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

C. Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

D. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

E. Payment of Benefits

Benefits are recorded when paid.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 – TAX STATUS

The IRS has determined and informed the Company by a letter dated August 20, 2014 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognized a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provision under ERISA. In the event of Plan termination, the participants' accounts would become fully vested.

NOTE 7 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The following information is a summary of the plan's investment information as of December 31, 2024, and 2023, and for the years then ended, included in the plan's financial statements and supplemental schedules, that was prepared by, or derived from, information prepared by Northwest Bank, the custodian of the plan, and furnished to plan management. The plan management has obtained certifications from the custodian that such information is complete and accurate.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – TRANSACTIONS WITH PARTIES IN INTEREST

Fees paid during the year for administrative services rendered by parties in interest were based on customary and reasonable rates for such services and are paid by the Plan Sponsor. The fees and corresponding other income are reported on the Statement of Changes in Net Assets Available for Benefits.

NOTE 11 – FORFEITURES

Benefit payments to terminated employees partially vested in the plan include their vested portion of employer contribution. Forfeitures may be used to reduce employer contributions or to pay administrative expense of the plan, as determined by the entity at its sole discretion. For the years ended December 31, 2024 forfeitures of \$10,310 were used to reduce employer contributions. At December 31, 2024 and 2023, there were \$0 and \$708, respectively, of forfeitures that had not yet been applied to employer contributions or used to pay administrative expenses.

NOTE 12 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 4, 2025, the date which the financial statements were available to be issued.
