### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Egg Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Egg Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of Plan**

***General***

The following description of The Egg Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a complete description of the Plan's provisions.

The Plan is a defined-contribution retirement plan and was established effective June 1, 1987 by Wabash Valley Produce, Inc. (Company) of Dubois, Indiana for the benefit of its employees who are 18 years or older and meet certain eligibility requirements. The eligibility requirements allow employees to make salary deferral elections after sixty days of service and require employees to provide one year of service before receiving the nonelective, discretionary employer contribution. The Plan is administered by an Administrative Committee consisting of three persons appointed by the Board of Directors of the Company. The Board of Directors serves as trustee of the Plan. Effective January 1, 2024, Fidelity Management Trust Company (Fidelity) serves as recordkeeper and custodian of the Plan. Prior to January 1, 2024, Findley, Inc. served as recordkeeper, and Matrix Trust Company served as custodian of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Layers, Inc. (together with Wabash Valley Produce, Inc. being the Companies) is a participating employer in the Plan. Previous service with the participating employer is to be considered for eligibility, vesting and contribution allocation in the Plan.

***Contributions***

The Plan allows participants to make salary reduction elective contributions up to or equal to the maximum allowed by law and participants may make Roth contributions to the Plan. Employee rollover contributions are also permitted. The Companies' profit-sharing contributions to the Plan are discretionary as determined by the Board of Directors. Contributions are subject to certain limitations.

The Company made \$838,322 and \$772,088 in discretionary profit-sharing contributions during 2024 and 2023, respectively.

***Participant Investment Account Options***

Investment account options available for employee contributions include various funds. Each participant has the option of directing his employee contributions into any of the separate investment accounts and may change the allocation quarterly. Employer contributions to the Plan are invested at the discretion of the Company.

The Nest Egg Fund was made up of various underlying investments, including mutual funds, common stocks, exchange traded funds, money market funds and a collective trust fund, directed by Plan management and includes all employer funds. Participants may also have elected this as an investment option for their elective contributions. In December 2023, the Plan sold all underlying investments in the Nest Egg Fund for noninterest-bearing cash. This cash was transferred from Matrix to Fidelity Investments in January 2024 in conjunction with the Plan's transition of custodians as mentioned above. The non-participant directed fund is no longer in use with the transfer to Fidelity.

***Participant Accounts***

Each participant's account is credited with the participant's contribution. The Companies' contribution to the Plan for any year is allocated to participant accounts based upon the participant's percentage share of total participant compensation paid for the year. Allocations are based on participant earnings or account balances, as defined. Forfeitures are allocated to participants in the same manner as the Companies' contributions.

***Vesting and Benefits***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service with a participant becoming 100% vested after six years of credited service. Participants also become 100% vested upon retirement at age 60, death or disability. The normal form of benefit is a lump-sum payment to participants or their beneficiaries equal to the value of their accounts. In-service withdrawals are also allowed for participants over age 59 ½ as permitted by the Plan.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Method of Accounting***

The accompanying financial statements are prepared on the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits. Actual results could differ from those estimates.

***Cash***

The cash account is valued at cost, which approximates market.

***Valuation of Investments and Income Recognition***

Quoted market prices, if available, are used to value investments. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds and exchange traded funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued at cost, which approximates fair value. The Plan's interest in the common collective trust fund is valued at NAV utilizing the practical expedient. The collective investment fund invests in investments that pursue multiple strategies to exceed the performance of certain industrial averages. The fund may invest in securities, guaranteed investment contracts, a combination of other collective funds, or swap and option contracts. The net asset value is determined by utilizing the values of the underlying assets. The fund can be redeemed daily.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan operates under a defined-contribution volume submitter plan document sponsored by Fidelity Management & Research Company. The volume submitter plan has been filed with the appropriate agency. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized plan document has received a favorable opinion letter from the IRS. The Plan has been amended since the prototype received its favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Administrative Expenses***

Administrative expenses may be paid by the Companies or the Plan, at the Companies' discretion.

***Payments of Benefits***

Benefits are recorded when paid.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statement of net assets available for benefits and related disclosures as of December 31, 2024
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Investments Measured Using the Net Asset Value per Share Practical Expedient**

Following is a description of the valuation methodologies used for assets measured at fair value.

*Common stocks:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds and exchange traded funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Money market funds:* Valued at cost, which approximates fair value.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$698 and \$3,140 of recordkeeping fees to the custodian during 2024 and 2023, respectively. During 2023, these administrative expenses were netted against revenue share reimbursements received by the Plan, in the amount \$22,775, on the statements of changes in net assets available for benefits. The Company provides certain administrative services at no cost to the Plan.

**Note 7. Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$71,097 and \$18,014, respectively. **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
