Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Network for Life 401(k) Plan (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

Related-Party Transactions

Certain Plan assets were investments in common collective trusts managed by Transamerica Financial Life Insurance Company. These Companies also provided certain record keeping and accounting services for the Plan and, therefore, these investments and all transactions with them qualify as party-in-interest transactions.

Several employees of Plan employers provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan employers for the services of the employees to the Plan.

Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan employers have evaluated subsequent events through October 13, 2025, which is the date these financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Network for Life 401(k) Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan as currently designed is a multiple employer defined contribution plan covering substantially all employees of Lifeline of Ohio Organ Procurement, Inc., LifeCenter Organ Donor Network and Network for Life. On October 1, 2024, LifeCenter Organ Donor Network merged with another organization, Kentucky Organ Donor Affiliates, and renamed itself Network for Hope. The Plan is a qualified trust under Sections 401(a) and 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute from 1% to 100% of eligible compensation, as defined by the Plan, through pre-tax or Roth elective deferrals. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 (IRC) as amended (\$23,000 at December 31, 2024). Participants that are 50 and older are eligible to make "catch-up" contributions in accordance with, and subject to limitations of IRC Section 414(v) (\$7,500 at December 31, 2024). These deferral contributions are fully vested and non-forfeitable. The Plan employers match a certain percentage of the participant's contribution as determined by the respective Board of Directors.

For the plan year ended December 31, 2024, the Plan employers elected to match 50% of participant deferrals up to 6% of the participant's eligible compensation not to exceed the maximum contribution allowed by law. The Plan employers made match contributions of \$636,433 for the year ended December 31, 2024. The Plan employers may also make annual discretionary contributions to the Plan. There is no requirement for minimum annual contributions, and it is possible that, in some years, no contribution would be made to the Plan. The Plan employers made discretionary contributions of \$318,231 for the year ended December 31, 2024.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Eligibility

Employees are automatically eligible to participate in the Plan upon hire. Employees are automatically enrolled into the Plan and have 3% of eligible compensation contributed into the participant's account, unless otherwise elected by the participant.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan employers' contribution and (b) plan earnings or losses and (c) administrative fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions and their allocated share of employer contributions into various investment options offered by the Plan.

Financial Hardship Withdrawals

In conditions of financial hardship, a participant may apply to the plan administrator for approval to withdrawal that portion of their vested balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan employers' matching and discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service or upon death.

Forfeited Accounts

At December 31, 2024 and 2023 forfeited accounts totaled \$25,165 and \$115,765, respectively. Non-vested portions of participant accounts that are forfeited upon payment of benefits are retained in the Plan and used to reduce future employer contributions or pay Plan administrative expenses. The Plan used \$203,810 of forfeitures to reduce employer contributions during 2024.

Payment of Benefits

Benefits are recorded when paid. The participant's entire account balance becomes payable upon death, disability, or retirement in the form of a lump sum distribution. Normal retirement is age 65; early retirement age is 55 with three years of service. In-service withdrawals are permitted for participants who have reached age 59 ½.

For termination of service due to other reasons, a participant may receive the value of the vested interest of his or her account as a lump sum distribution.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis

Notes Receivable from Participants

Participants may apply for a loan from their account under the Plan. Certain legal restrictions impose limits on the amount of the loan and repayment terms. The minimum loan amount is \$1,000 and up to a maximum loan amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at the prime rate on the last day of the previous quarter. Generally, the participant's loan must be repaid, ratably through monthly payroll deductions, within five years, unless the loan is for the purchase of a primary residence.

Investment Options

Upon enrollment in the Plan, a participant may direct all contributions into any of the investment options available to them at Transamerica Financial Life Insurance Company (Transamerica). Participants may change their investment options daily.

NOTE 3 INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The following information provided by Transamerica Financial Life Insurance Company was certified by them to be accurate and complete with respect to the following:

- (a) The assets held by Transamerica Financial Life Insurance Company, at December 31, 2024 and 2023, as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Common collective trusts: Valued based on the NAV of units of a collective trust published by the custodian.

Mutual funds: Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish the NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

Transamerica Stable Value Strategy Account

The Plan invested in a fully benefit-responsive investment contracts with the trustee as of December 31, 2023. The trustee maintains the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsors or other plan sponsor events (for example, divestitures or spin-offs of subsidiary) that causes a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator did not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 6 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan itself has not received a determination letter from the Internal Revenue Service. The Plan has been amended since adoption of the prototype plan. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan employers has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

NOTE 8 SUBSEQUENT EVENTS

On January 1, 2025, the Plan switched plan custodian from Transamerica Financial Life Insurance Company to Fidelity Management Trust Company. The Plan liquidated all investments held at December 31, 2024, and converted them to cash to enable the Plan to transfer funds to the new custodian. The balance transferred was \$21,322,408.

On January 1, 2025, the Plan admitted all former Kentucky Organ Donor Affiliates' employees who joined Network for Hope on October 1, 2024. The total transfer in was \$8,460,409.
