## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the  
Masonite Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Masonite Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

#### 1. Description of the Plan

The following description of the Masonite Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies which are available from the plan administrator, for a more complete description of the Plan's provisions. Masonite Corporation, the Plan Sponsor, is owned 100% by Masonite International, Inc. (collectively, the Company). In 2024, the Company was acquired by Owens Corning (Owens). In 2025, Owens became the new Plan Sponsor of the Plan and the Plan had a change in service provider from Charles Schwab Trust Bank (Charles Schwab) to Fidelity Management Trust Company.

#### Merger and Transfer of Plan Assets

Effective March 1, 2024, the Endura Products, Inc. 401(k) Profit Sharing Plan and Trust was merged into the Plan and assets of \$35,658,951 were transferred into the Plan.

#### General

The Plan is a defined contribution plan covering all eligible employees of the Plan Sponsor or an affiliated company who either work in the United States of America or who are United States citizens or residents working outside of the United States, provided a portion of the employee's compensation is United States source income. The following employees are excluded from participating in the Plan: an employee covered under a collective bargaining agreement, a leased employee, an independent contractor, or an employee who is accruing benefits under a retirement plan of an affiliated company incorporated outside the United States. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to participate in the Plan on the first day of the month following the completion of 90 days of service.

The Company also sponsors the Masonite Savings Plan for Collectively Bargained Employees (the Union Plan), which covers employees of the Company or its subsidiaries covered under a collective bargaining agreement between the Company (and/or an affiliated company) and a union, where the terms of the collective bargaining agreement provide for participation in the Union Plan. If an employee becomes eligible to participate in the Plan, their accounts under the Union Plan will be automatically transferred to the Plan. In 2024, there were transfers of \$90,976 into the Plan from the Union Plan.

#### Contributions

Each participant may make pre-tax contributions of up to 75% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus catch-up contributions of up to \$7,500 for participants who are at least 50 years of age. Employees are automatically enrolled in the Plan one year after meeting the eligibility requirements at a rate of 3% unless they elect otherwise. This automatic contribution rate will increase by 1% annually on the first

day of the Plan year, up to a maximum of 10% unless the employee elects otherwise. Effective April 1, 2019, former Bridgewater employees are excluded from the automatic enrollment and escalation features. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Effective July 1, 2022, the Plan was amended to permit after-tax contributions and in-plan Roth conversions.

The Company contributes an amount equal to 100% of the participant's contribution to the Plan, to the extent that the participant's contribution does not exceed 5% of their eligible compensation. The Company, at its discretion, may make supplemental contributions. There were no supplemental contributions made during 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and the earnings and losses on the investments in their account, and is charged with certain administration expenses and transaction expenses for services received by individual participants. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in all contributions plus actual earnings and losses thereon. Participants who previously participated in predecessor plans may be subject to different vesting schedules.

#### **Payment of Benefits**

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the balance of the participant's account in a lump-sum distribution. Participants are eligible to receive hardship withdrawals when certain conditions are met. After attaining age 59½, participants may also be eligible to make a withdrawal of all or any part of their vested account.

#### **Forfeitures**

As of December 31, 2024 and 2023, forfeited accounts totaled \$30,386 and \$10,199, respectively. These forfeitures related to prior non-vested accounts before the Plan was amended which provided for 100% vesting of Company contributions. Forfeitures may be used to reduce future employer contributions and to pay Plan expenses. During 2024, no forfeitures were used to reduce the Company contributions or to pay Plan expenses.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Participants may only have one note outstanding at a time. A note must be repaid within 5 years, unless used for the purchase of a primary residence which may be repaid over 20 years. The notes are secured by the balance in the participant's account and bear an interest rate of prime plus 2%. During 2024, interest rates ranged from 4.25% to 10.50%. Principal and interest are paid through payroll deductions.

#### **Administrative Expenses**

Participants pay administration fees on a pro rata basis through the participant accounts. In addition, certain participant transaction fees, such as loan fees and distribution fees, are charged directly to the participant. Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing, rather than a direct payment. Certain administrative expenses of the Plan are paid by the Plan in accordance with the Plan's provisions. These expenses are paid to service providers of the Plan and therefore qualify for party-in-interest transactions.

The Plan has an ERISA account where the qualified institution, Charles Schwab, deposits revenue sharing amounts to pay for administrative expenses. Deposits to this account are included in net change in fair value of investments on the accompanying statement of changes in net assets available for benefits. During 2024, amounts were received into this account from revenue sharing of \$102,225 and then were all reallocated into participant accounts. The account had investment earnings of \$1,190. Payments from this account were \$5,572 and are included in administrative expenses in the year paid. The account has an available balance of \$2,847 and \$7,230 as of December 31, 2024 and 2023, respectively, which are included in the stable value fund on the accompanying statements of net assets available for benefits.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld. Supplemental contributions are recognized upon authorization by the Plan Sponsor. Any unfunded participant or employer matching contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 326, *Financial Instruments – Credit Losses*, the Plan estimated the current credit risk associated with the employer contribution receivable. After giving consideration to the risk characteristics, historical payment experience, current conditions, and reasonable forecasts, the Plan determined that no allowance for credit losses was necessary and there was no current year activity in the allowance for credit losses.

#### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments. Interest income is recorded when received.

#### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

#### **Payment of Benefits**

Benefits paid to participants are recorded when paid.

#### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

#### **3. Information Certified by the Qualified Institution**

All information in the accompanying financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab, the Plan’s qualified institution.

#### **4. Investments**

Plan investments include a mutual fund managed by Charles Schwab. Charles Schwab is a service provider of the Plan; therefore, transactions in this investment qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to several risks, such as market, interest rate, currency and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, etc. It is at least reasonably possible that changes in their fair values will occur in the near term and that such changes could materially affect participants’ account balances.

The FASB established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan’s own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

Fair value of the common/collective trust funds (CCT) is determined by prices published daily by the trust manager, which is the net asset value (NAV) of the CCT (Level 1). NAV is determined by the fair value of the mutual funds, stocks, and other securities in the CCT. Participants can trade the CCT daily at the published NAV.

The stable value fund invests primarily in synthetic guaranteed investment contracts and guaranteed investment contracts. The stable value fund trades daily at the NAV of the fund, which is based on the contract value of the underlying investments (Level 1). There are no restrictions on withdrawal of these funds except that if the Company were to remove this investment option from the Plan, they would have to provide twelve months' notice prior to liquidating this investment.

#### 6. Income Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
