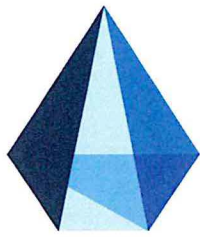

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

Note 1 - Description of the Plan

The following brief description of Price Brothers, Inc. Retirement Plan (the Plan) is provided for general information purposes only in order to assist the reader in reviewing the financial statements of the Plan. Participants should refer to the plan agreement for more complete description of the Plan's provisions.

General

The Plan is a prototype plan of Blue Sky 401(k) Specialists Inc. The Plan is a defined contribution pension plan covering substantially all employees of Price Brothers, Inc. – Plumbing Contractors (the Company) who have 90 days or more of service and are at least 20 and 1/2 years of age or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Assets of the Plan were held by Talcott Resolution Life Insurance Company, formerly named Hartford Life Insurance Company through December 2022, as custodian. Effective January 2023 all the assets held by Talcott Resolution Life Insurance Company were liquidated and transferred to John Hancock Life Insurance Company, as custodian. The custodians or the attorneys-in-fact of the custodians provide an annual accounting and certification relating to asset balances, asset transactions, and income and expense transactions resulting from cash receipts and disbursements of the Plan, as well as the schedule of investments as required by ERISA. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Contributions

The Plan allows participants to contribute up to maximum amounts set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company contributes to the Plan an amount determined by the Company's board of directors. The Company currently matches 100% of the first 3% of employees' compensation contributed to the Plan and thereafter an additional 50% match on employees' compensation that does not exceed 5% of employees' compensation. Participants direct the investment of the contributions into various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Safe Harbor Company matching contributions plus actual earnings thereon. Vesting in the Company's portion of their accounts, except the portion related to Safe Harbor matching, is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes receivable from participants

Participants may borrow from their fund accounts in accordance with the Plan. These loans may be made up to the lesser of \$50,000 or 1/2 of the vested fund account balance, with a minimum loan requirement of \$1,000, and are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest is paid ratably through weekly payroll deductions. The Plan was amended during 2020 increasing loan limits and allowing for the deferral of loan payments allowed under the CARES act.

Payment of benefits

On termination of service, participants with vested benefits in excess of \$5,000 may elect to receive a lump-sum amount equal to the vested value of his or her account or partial withdraws. Participants with vested benefits less than \$5,000 will receive payment of benefits in a single lump sum distribution. The Plan was amended during 2020 to incorporate Covid-related in-service distributions allowed under the CARES Act.

Forfeitures accounts

The undistributed, non-vested portion of a terminated participant's account balance will be used to reduce employer's contributions or can be allocated back to participants. During 2024 and 2023 employer contributions were reduced by approximately \$14,000 and \$5,000, respectively, from forfeited non-vested accounts. During 2024 and 2023 allocations to participants totaling approximately \$0 and \$38,000, respectively, were made from forfeited non-vested accounts. Forfeited nonvested accounts totaled approximately \$34,000 and \$19,000 at December 31, 2024 and 2023, respectively.

Funding

Employee contributions arising from salary reductions are funded as soon as practicable, but no later than the 15th day of the month following the month during which such contributions were withheld from the participant's compensation. Employer contributions are funded in a similar manner.

Note 2 - Summary of significant accounting policies

The Plan's significant accounting policies are as follows:

Accounting method

As permitted under the Department of Labor rules and regulations, the plan administrator maintains the accounting records on the basis of cash receipts and disbursements. The accompanying financial statements have been converted to the accrual basis of accounting, which recognizes revenues and related assets when earned and expenses and related liabilities when incurred.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase to corrective distributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Note 3 – Certified investments

Substantially all information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (custodian of the Plan) or Empower Annuity Insurance Company of America (the attorney-in-fact of the custodian of the Plan).

Note 4 – Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – Valued based upon published redemption prices of units held by the Plan, which is based on the current fair value of the pooled separate accounts underlying assets. Unit values are determined by the financial institution sponsoring such accounts by dividing the account's net assets at fair value by its units outstanding at the valuation dates. The Plan holds the right to liquidate its positions in these pooled separate accounts at any time, subject to a reasonable notification period. No unfunded commitments existed with respect to these pooled separate accounts at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5 – Investment contract with insurance company

The Plan entered into a fully benefit-responsive guaranteed investment contract with Talcott Resolution Life Insurance Company (TRLIC), formerly named Hartford Life Insurance Company, during 2008 totaling \$0 and \$0 at December 31, 2024 and 2023, respectively. TRLIC maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting interest rate was based on a formula agreed upon with the issuer, but may not be less than 3%. Such interest rates were reviewed at least quarterly for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The average yield and crediting interest rates were approximately 3% for 2022. The contract was terminated by the Plan in early January 2023.

This contract met the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the attorneys-in-fact of the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligation. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan's sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (4) premature termination of the contract. The contract was terminated in January 2023 resulting in a negative adjustment to contract value totaling approximately \$5,000.

Note 6 – Related party transactions and party in interest transactions

Talcott Resolution Life Insurance Company, formerly named Hartford Life Insurance Company, was the custodian as defined by the Plan and Empower Annuity Insurance Company of America was the attorney-in-fact of Talcott Resolution Life Insurance Company. John Hancock Life Insurance Company is currently the custodian defined by the Plan. In addition, Blue Sky 401(k) Specialists, Inc. provides various administrative services to the Plan. Therefore, transactions with Talcott Resolution Life Insurance Company, Empower Annuity Insurance Company of America, John Hancock Life Insurance Company, Blue Sky 401(k) Specialists, Inc. and their affiliates qualify as party-in-interest transactions. Fees paid by the Plan not covered by revenue sharing amounted to approximately \$81,000 and \$69,000 for the years ended December 31, 2024 and 2023, respectively.

Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 – Tax status

The Blue Sky 401(k) Specialists Inc Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA obtained its latest determination letter June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, believe the Plan is qualified as tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examination for the years prior to 2019.

Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
