## Basis for Opinion

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A--DESCRIPTION OF PLAN

The following description of Hagar Restaurant Equipment Service, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for more complete description of the Plan's provisions.

General: The Plan was established January 1, 1999. The latest Plan amendment was effective April 26, 2021. The Plan is a defined contribution plan covering all eligible employees, except non-resident aliens and union employees, of the Company who have completed one year of service and who have attained the age of 21. An employee is credited with one year of service after attaining 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may contribute a percentage of their eligible compensation as defined by the plan up to 15% of pretax compensation or the maximum limit determined annually by the Internal Revenue Service (IRS). Participants who meet age requirements as determined by the IRS are also eligible to make catch-up contributions. In addition, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the participants' elective deferrals each payroll period. This discretionary amount currently is a match up to 6% of the participant's elective deferral.

In addition, the Company may make a nonelective discretionary employer contribution on behalf of eligible participants for the plan year if the participant is employed on the last day of the contribution period and has earned at least 501 hours of service during the plan year. There were no nonelective discretionary employer contributions in 2024 or 2023.

Participants' Accounts: Each participant's account is credited with his or her salary deferral contribution; an allocation of the Company's discretionary matching contributions if any; an allocation of the Company's nonelective discretionary contributions, if any; the Plan's earnings and losses; and administrative expenses that are paid by the plan. Allocations are based on the participant's qualified compensation, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds for the participants. Participants may change the allocation of their account in the different investments at any time.

Notes Receivable from Participants: Participants may borrow from their vested account balances with interest rates, terms and minimum loan balances in accordance to the plan document. The loans are secured by the balance in the participants' account. Principal and interest are paid ratably through payroll deductions. A participant loan is considered to be in default and/or past due when payments have ceased prior to being repaid-in-full.

Excess Contributions Payable: Amounts payable to participants totaling \$-0- and \$1,082 for 2024 and 2023 respectively for contributions in excess of amounts allowed

by the IRS and plan document are recorded as a payable with a corresponding reduction in employers contributions for the year ending December 31, 2024. The Plan distributed the excess contribution in 2024.

Vesting: Participants are immediately vested in their elective contributions and rollover contributions plus or minus any earnings or losses thereon. Participants are vested in their non-elective contributions and Company matching contributions based on years of credited service. A participant vests 20% starting with the second year through the sixth year and is fully vested after six years of service.

Distributions: Upon retirement, disability, or death, a participant or beneficiary may receive the entire amount credited to the participant's account under various distribution options as defined by the plan. Required minimum distributions must begin within a prescribed period after the participant attains the age designated by the current U.S. Internal Revenue Code.

Upon termination of service, the participant's vested balance will be paid to the participant in any manner permitted by the Plan and agreed-upon by the participant and Plan administrator. If the participant's account balance is less than the designated amount defined in the plan that is subject to IRC limitations, the account may be distributed on behalf of the participant without participant agreement.

In service distributions are permitted for a participant who is 59 1/2 years or older, for hardship reasons.

Forfeitures: Forfeitures of Company contributions due to participants withdrawing prior to being 100% vested are first used to pay Plan administrative expenses, and then may be used to reduce employer contributions. The Plan had \$2,077 and \$31 in unallocated forfeitures available on December 31, 2024 and 2023 respectively. During 2024 and 2023, forfeitures were used to pay employer contributions and Plan expenses of \$24,395 and \$25,911, respectively.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's funds are invested in separate accounts with Fidelity Management Trust Company. Funds invested in separate accounts are subject to certain investment restrictions and standards set forth in the contract. Earnings of the assets invested in separate accounts are a function of the underlying assets of the separate account.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend

date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year and are net indirect compensation paid by the plan to Fidelity Investments Institutional for certain agency fees. These fees are based on a percentage of asset values by investment and range from 0.27% to 0.35%.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses is recorded as loans are fully secured by the participant accounts. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid either by the Plan or by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included with administrative expenses. Certain investment-related expenses may be included in net appreciation (depreciation) of fair value of investments. Third Party Administrator fees paid directly from plan assets are included as administration expenses.

NOTE C--INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, as custodian for the Plan Trustee.

NOTE D--FAIR VALUE MEASUREMENTS

Certain Plan investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. Next, Level 2 inputs are used when identical assets cannot be identified, but quoted prices for similar assets in active markets are available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds - Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E--PLAN STATUS

Although it has not expressed any intent to do so, Hagar Restaurant Equipment Service, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE F--TAX STATUS

The Plan is qualified under the appropriate section of the Internal Revenue Code (IRC) and, accordingly, the Plan's net investment income is exempt from income taxes. The Plan operates under the Defined Contribution Volume Submitter Plan of its third-party administrator. A determination letter has been obtained for the Volume Submitter Plan. The Plan sponsor believes that the Plan as designed is currently being operated in compliance with the applicable requirements of the IRC and continues to be tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded

that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently, no audits for any tax periods are in progress. The Plan is subject to income tax examinations for plan years ended December 31, 2022 through 2024.

NOTE G--TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan invests in mutual funds managed by the Plan's custodian, who is considered a party-in-interest. Notes receivable from Plan participants and the related interest income are also considered party-in-interest transactions. Administrative fees related to the administration of the Plan are paid by the Plan.

Other administrative expenses were paid by the Plan Sponsor. The Plan Sponsor has the option, but not the obligation, to pay any of the Plan's administrative expenses. In addition, certain administrative functions are performed by officers or employees of the Plan Sponsor for which the officer or employee receives no compensation from the Plan nor is the Plan charged by the Plan Sponsor for these services.

NOTE H--RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in Net Assets Available for Benefits.
