Note 1: Description of Plan

The Plan is a 401(k) savings plan covering all full-time employees of EXLService.com, Inc., Outsource Partners International, Inc., and EXL Technology Solutions, Inc. (collectively, the "Company" or the "Plan Sponsor"), except leased employees or those subject to collectively bargained agreements. The Plan was established on January 1, 2003 and was last restated as of April 25, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

Eligible employees include all regular full-time employees of the Company, who are not covered under a collective bargaining agreement. Employees are eligible to participate in the Plan after one month of service. In order to receive Company discretionary matching and non-elective contributions, employees must be employed as of the last day of the plan year.

Contributions

Eligible employees (the "Participants") are able to elect to contribute to the Plan an amount not less than one percent (1%) of their annual eligible compensation. Participants' contributions are limited to seventy-five percent (75%) of their annual eligible compensation, up to the maximum amount allowable under the limits set by the Internal Revenue Code ("IRC"). Participant contributions can be made to the Plan on a pre-tax or Roth basis. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, per IRC Regulations.

The Plan has an automatic enrollment feature. Participants subject to automatic enrollment have 3% of their annual eligible compensation deferred into the Plan on a pre-tax basis on the first day of the next month upon meeting the eligibility requirements. The Plan also permits participants to roll over distributions from other qualified retirement plans (rollover contributions). The Participants are responsible for directing the allocation of their contributions among the established funds.

The Company may provide an annual discretionary matching contribution based on a percentage of the participant's contributions to the Plan. For 2024, the Company made a discretionary matching contribution equal to the lesser of 50% of the employee contribution or 50% of employee eligible earnings times 6%. Rollover contributions are not matched. In addition, the Company may make a discretionary non-elective contribution as determined by the Board of Directors each plan year, which is allocated to participants based on each participant's annual eligible compensation as a percentage of total annual eligible compensation. No discretionary non-elective contributions were made in 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching and non-elective contributions (if any), and an allocation of investment earnings/losses and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings thereon

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a variety of mutual funds, common collective trusts, and investments through a self-directed brokerage program as investment options for participants. Investment options can be changed daily

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,083 and \$8,992, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, \$14,918 of forfeitures were used to pay administrative expenses.

Notes Receivable From Participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at prime rate plus 1 percent; notes are payable over a period up to 5 years, with extended terms if secured by a participant's principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, termination due to death, disability, retirement, or attainment of age 59-1/2, a participant (or a participant's beneficiary in the event of death) can elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum cash payment or a direct rollover to another qualified retirement plan. In addition, hardship withdrawals are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59-1/2

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net realized gains and losses and unrealized appreciation/depreciation in fair value of investments is reported in the statement of changes in net assets available for benefits as net appreciation/depreciation in the fair value of investments. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Certain fees incurred by the Plan for investment-related services are allocated proportionately to plan participants based on their respective account balances and are included in net investment income, as they are paid through revenue sharing rather than direct payment. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document

Subsequent Events

In January 2025, the Plan Sponsor approved the merger of Incandescent Technologies, Inc. 401(k) Profit Sharing Plan and Trust

The Plan has evaluated subsequent events through September 8, 2025, which is the date the financial statements were available to be issued

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund and Common collective trust funds. Valued at the NAV of units of the collective trust. The NAVs, as provided by the trustee, are used as a practical expedient to estimate fair value. The NAVs are based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no restrictions as to the redemption of these funds or unfunded commitments at December 31, 2024 and 2023. Were the Plan to initiate full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Common and preferred stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

U.S. Government securities: Valued using pricing models maximizing the use of observable inputs for similar securities.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the Trustee of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter which states the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Party-in-Interest Transactions

Certain plan investments are managed by Fidelity, the Plan's Trustee, and therefore these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Direct fees incurred and paid by the Plan for administrative expenses amounted to \$104,094 during the plan year ended December 31, 2024.

The Plan also participates in a revenue credit program with the Trustee, whereby participants may receive credit for excess recordkeeping revenue that the Trustee receives in connection with plan services when that revenue exceeds the agreed-upon compensation the Trustee is to receive. These revenue credits are allocated to eligible participants based on their respective account balances and are reflected in net investment income. Revenue credits received from Fidelity amounted to \$112,603 for the year ended December 31, 2024.

PNC Bank, NA ("PNC") is the investment advisor for the Plan and, therefore, fees paid to PNC also qualify as party-in-interest transactions. Fees paid directly by the Plan to PNC for investment management services amounted to \$10,000 for the year ended December 31, 2024. These fees are allocated to eligible participants based on their respective account balances and are reflected in net investment income.

Wipfli, LLP ("Wipfli") is the auditor for the Plan and, therefore, fees paid to Wipfli also qualify as party-in-interest transactions. Fees paid directly by the Plan to Wipfli for audit services amounted to \$14,200 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.
