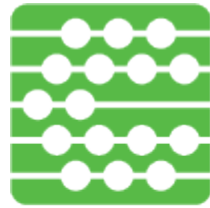

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the PHCM 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

PHCM 401(k) Savings Plan (the “Plan”) was established on January 1, 2017, was amended and restated most recently effective March 4, 2019, to among other provisions, include all eligible non-union employees that are employed at Providence Healthcare Management, Inc. (the “Company”). The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each year, participants may elect to defer a portion of their compensation to the Plan subject to an annual maximum amount pursuant to the applicable code section of the Internal Revenue Code limited to the maximum amount allowed by the law, which is \$23,000 for 2024. During 2024, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offer by the Plan.

The Company will make a matching contribution equal to 10% of an employee’s contributions up to the first 3%. The Company had a matching contribution of \$7,927 for the year ended December 31, 2024. The Company may also elect to make a discretionary profit-sharing contribution without regard to accumulated net profits of the employer. There were no profit-sharing contributions in 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Funding Policy – The Company’s funding policy is to make the contributions to the Plan as soon as administratively feasible.

Vesting – Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the employer matching and profit-sharing contribution is based on a five-year graded vesting schedule. Participants become vested in Employers’ matching contributions and profit-sharing contributions as follows:

Notes Receivable for Participants – Participants are not permitted to borrow from their fund accounts.

Hardship Withdrawals – A participant can take hardship withdrawals for Immediate and Heavy Financial Need, as defined in the Plan document. A participant's hardship withdrawal will preclude the participant from making additional employee before-tax contributions to the Plan for a six-month period after the hardship withdrawal. Participant before-tax contributions and matching contributions can be withdrawn after attainment of age 59 ½.

Payment of Benefits – Upon termination of employment, including disability, a participant (or the participant's beneficiary) will receive a lump-sum distribution (vested balance less than \$5,000) or have the option of installment payments (vested balance greater than \$5,000).

Administrative Expenses – Certain expenses to maintain the Plan are paid by the plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts total \$3,999 and \$4,231 respectively. These accounts will be used to reduce future discretionary employer contributions and administrative expenses of the Plan. Forfeitures used to pay administrative fees in 2024 were \$4,091 and \$3,067 to reduce employer contributions.

2. Summary of Accounting Policies

Basis of Accounting – The accompanying financial statements are prepared on the liquidation basis in conformity with accounting principles generally accepted in the United States of America as applied to defined contribution plans and in accordance with the terms of the trust agreement. This basis has been adopted because the Plan will be terminated in 2025, see note 7 for more details.

Under the liquidation basis of accounting, assets are stated at the estimated net realizable value, and liabilities are stated at their estimated settlement amounts. Net realizable value represents the estimated amount expected to be collected from the asset. No material changes in the fair value of the Plan's investments were identified between the reporting date and the date the financial statements were issued.

Contract value is the relevant measure for the portion of the net assets in liquidation available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted

transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contracts and their related activity on a contract value basis (see Note 5).

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments consists of the realized gains or losses and the unrealized appreciation or depreciation of those investments.

Payments of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. Information Prepared and Certified by Custodian

The Transamerica Life Insurance Company (“Transamerica”), custodian of the Plan, held the Plan’s investment assets and executed transactions therein as of and for the years ended December 31, 2024 and 2023. The following is a summary of the Plan’s financial information certified by Transamerica as complete and accurate in accordance with section 2520.103-8 of the Department of Labor’s rules and regulations for reporting and disclosure under ERISA. Also, the information included in the supplementary schedule, Schedule of Assets (Held at End of Year) was certified by Transamerica.

4. Investments and Fair Value Measurements

The Plan applies FASB ASC 820, *Fair Value Measurement* (“ASC 820”). FASB ASC 820 provides a framework for measuring fair value and the disclosures about fair value measurements of assets and liabilities. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the estimated daily fair value as reported by the fund based on the fair value of the underlying mutual funds adjusted for the expense factor disclosed. The pooled separate accounts are classified as Level 2.

5. Fully Benefit-Responsive Investment Contracts

The Plan has a traditional fully-benefit-responsive fund with Transamerica of \$22,564 at December 31, 2024. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest rate is based on a formula established by the contract issuer but may not be less than 0%. The interest rate is reset every quarter as determined by Transamerica. The fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This fund meets the fully benefit-responsive criteria and therefore is reported at contract value under ASU 2015-12. Contract value is the relevant measure for fully benefit-responsive funds because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024, the contract value is also the fair value. The average yield earned by the plan was 1.65% as of December 31, 2024.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. Party-In-Interest Transactions

Certain plan investments are pooled separate accounts or guaranteed accounts of Transamerica, which is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services amounted to \$31,180 for the year ended December 31, 2024, included in administrative expenses. The Plan Sponsor pays directly any other fees related to the plan's operations.

7. Plan Termination

The Company approved a plan of termination in February 2025. The decision was made due to the sale of many of the companies under Providence Healthcare Management, Inc. All plan assets will be liquidated and distributed to the participants. Participant accounts will be distributed as soon as administratively feasible following settlement of all Plan liabilities. All administrative expenses and other liabilities related to the Plan will be settled in accordance with the Plan document and applicable regulations. Participants will receive final distribution notices outlining their option for receiving benefits. The Company expects to have the liquidation completed by December 31, 2025. At December 31, 2024, the Company has accrued approximately \$15,000 in costs expected to be incurred in 2025.

8. Tax Status of the Plan

The Internal Revenue Service (IRS) has issued an opinion letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed to comply with the applicable requirements of the IRC and ERISA, and is intended to be operated in compliance with such requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets in liquidation available for benefits.

10. Subsequent Events

In February 2025, the Company approved a plan of termination. Subsequent events have been evaluated through September 21, 2025, the date which the financial statements were available to be issued.
