To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Communities in Schools of Brazoria County, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the Communities in Schools of Brazoria County, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the formal plan document for a more complete description of the Plan’s provisions.

General

The Plan, originally effective on April 1, 2002, and amended and restated on January 1, 2024, is a qualified retirement plan adopted to provide employees with the opportunity to save for retirement. The Plan covers generally all employees of Communities in Schools of Brazoria County and Southeast Harris County, Inc. (the “Company”) and subject to certain restrictions for participation eligibility as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

Voya Retirement Insurance and Annuity Company (“Voya”) is the custodian and recordkeeper for the Plan.

Participant and Employer Contributions

Participants may elect to make pre-tax salary deferrals and contribute up to 90% of compensation subject to the Internal Revenue Service (“IRS”) maximum annual limitations. Participants at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts at catch-up contributions. The Plan provides for discretionary employer matching contributions determined annually. For the year ended December 31, 2024, the Company matched participant contributions up to 100% of the first 3% of the participant’s eligible compensation contributed to the Plan. The Company may also make an additional discretionary profit sharing contribution. The Company did not make a discretionary profit sharing contribution during 2024.

A participant who receives a qualifying distribution from a former employer’s retirement savings plan may contribute the distribution to the Plan, provided that such contribution qualifies as a rollover contribution in accordance with Section 402 of the Internal Revenue Code (“IRC”) or is made by a direct trust-to-trust transfer.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative Plan expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Participants direct the investment of their account balances in any of several investment securities. Participants can change their investment allocation among the various investment securities either through direct transfers from one security to another or by changing the percentage allocation of future contributions.

Vesting

Participants are always 100% vested in their contributions, rollover contributions, and discretionary employer matching and profit sharing contributions.

Notes Receivable from Participants

The Plan permits participants to take a loan from the Plan. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. A participant may have only one note outstanding at any given time. All participant loans are adequately secured by the participant's vested account balance and charged a reasonable rate of interest. The loan repayment period generally may not extend beyond five years, unless the loan is used to acquire a principal residence, in which case, the loan repayment term may be longer. Upon the severance of employment, loans become due and payable in their entirety.

Payment of Benefits

Participants are eligible for lump-sum distributions of their vested account balances upon the event of death, disability, retirement, termination of employment, the attainment of age 72, or other reasons.

Distributions may be made in a lump-sum payment. If the vested account balance exceeds \$1,000, participants must elect how to receive their distribution. If the vested balance is \$1,000 or less and no election is made, the amount will be automatically rolled over into an individual retirement account established on behalf of the participant. De minimis balances are distributed as a lump-sum in accordance with Plan provisions. Any taxable distribution paid directly to the participant will be subject to mandatory federal income tax withholding of 20% of the requested distribution.

Plan Termination

Although the Company expects to maintain the Plan indefinitely, the Company has the ability to terminate the Plan at any time. In the event of termination of the Plan, the net assets of the Plan are to be distributed to participants in accordance with priorities established in the Plan.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued and has determined that there are no subsequent events to be reported.

3. CERTIFIED INVESTMENTS

Certain information related in the accompanying financial statements and ERISA-required supplemental schedules related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Voya.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board's Accounting Standard Codification Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets valued at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund. The money market is an open-end fund that is registered with the Securities and Exchange Commission. This fund is required to publish the daily net asset value ("NAV") and to transact at that price. The money market fund is deemed to be actively traded.

Pooled separate accounts: Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liability. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

5. GROUP ANNUITY CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya totaling \$77,504 and \$63,111 for 2024 and 2023, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Voya but may not be less than 1% and is reviewed for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Voya. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Voya and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow Voya to terminate the contract with the Plan and settle at an amount different from contract value. However, the Company is not aware of the occurrence or likely occurrence of such events in which Voya would terminate the contract.

6. TAX STATUS

The Company adopted a nonstandardized pre-approved profit-sharing plan which received a favorable opinion letter from the IRS on June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PARTY-IN-INTEREST TRANSACTIONS AND RELATED PARTY TRANSACTIONS

Plan investments and notes receivable from participants are managed by Voya. Voya is the custodian and recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan.
