## **Independent Auditors' Report**

To the Plan Administrator of  
Florida Pediatric Associates 401(k) Profit Sharing Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Florida Pediatric Associates 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of Plan

#### (a) Plan Description

The following description of Florida Pediatric Associates 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### (b) General

The Plan, established January 1, 2022, is a defined contribution plan covering substantially all employees of Florida Pediatric Associates, LLC and related employers (the “Company”) who become eligible for participation in the Plan at the age of eighteen on the first day of the month following one year of employment, as defined by the Plan document. Subject to certain limitations on annual additions, each participant's account is credited with employee elective deferrals, safe harbor employer contributions, discretionary employer contributions and an allocation of Plan earnings and charged with certain administrative expenses. Participants may modify investment elections, transfer existing account balances, and obtain information regarding the investments on a daily basis. Empower Trust Company, LLC and Empower Annuity Insurance Company of America, which are qualified institutions, hold the Plan's investment assets and execute investment transactions for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 1, 2023, a Participant may elect to convert all or any portion of his/her non-Roth vested account balance to an In-Plan Roth Conversion account. A participant may not make an In-Plan Roth conversion of any outstanding loan account.

#### (c) Contributions

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan also provides for a discretionary employer match as well as a safe harbor nonelective contribution by the Company. The safe harbor nonelective contribution is equal to 3% of compensation. Additional profit sharing amounts are made to the participants of the Plan. The Company made a 2% and 3% profit sharing contribution to plan for the years ending December 31, 2024 and 2023, respectively. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

#### (d) Participant Investment Account Options

The Plan currently offers various mutual funds and a guaranteed interest fund as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus (or other applicable disclosure) for the respective fund. Participants may change their investment options at any time.

#### (1) Description of Plan - Continued

##### (e) Participant Accounts

Each participant's account is credited with the participant's elective deferral contributions and allocations of (a) the Company's safe harbor nonelective contribution, (b) Company discretionary nonelective contributions and (c) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Effective April 1, 2024, the Plan's mandatory cash-out limit was increased from \$5,000 to \$7,000.

##### (f) Vesting

Participants are immediately vested in their contributions and safe harbor nonelective contributions plus actual earnings thereon. Participants are vested on a 6-year graded vesting schedule for discretionary employer nonelective contributions, with 20% vesting at the end of each year starting with year two. Participants are also vested upon death or termination of employment due to disability.

##### (g) Forfeitures

Forfeitures are used to reduce future employer contributions. Forfeitures available for reduction of future employer contributions were approximately \$286,000 and \$358,000 as of December 31, 2024 and 2023, respectively. Additionally, approximately \$216,000 and \$92,000 of forfeited nonvested accounts were used in 2025 and 2024, respectively to reduce employer contributions receivable as of December 31, 2024 and 2023, respectively.

##### (h) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's vested account. Notes receivable from participants, as of December 31, 2024, have rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions and are reinvested in the participant accounts according to individual investment elections.

##### (i) Payment of Benefits

Upon normal retirement age, death, disability, or termination, a participant's benefit is payable in a lump-sum amount equal to 100% of the participant's vested account balance. The participant also has the option of transferring his or her vested interest to another eligible retirement plan, including an IRA. A participant who has attained age 35 is permitted to withdraw from the participant's employer discretionary nonelective contribution account, but only if the participant is 100% vested in such account. The Plan also allows for withdrawals from employee elective deferral contribution accounts and safe harbor nonelective contribution accounts after attaining age 59½.

##### (i) Payment of Benefits - Continued

Hardship withdrawals are permitted by the Plan. Hardship withdrawals from the Plan are permitted only from the participant's elective deferral contribution account.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

##### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### (c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment trustee (or custodian). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### (d) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### (e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan.

##### (f) Payment of Benefits

Benefits are recorded when paid.

##### (g) Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### (3) Certified Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, which are qualified institutions with respect to the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value
- Fully benefit-responsive investment contract, at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of Assets (Held at End of Year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### (4) Fair Value Measurement

The financial statements are prepared in accordance with an accounting standard which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

*Mutual Funds:* Valued at the daily closing quoted market price as reported by the fund. Mutual funds held in the Plan are open-end mutual funds that are registered with the SEC. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Group Fixed Annuity Contract with Insurance Company**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America. The insurance company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than three percent. The crediting rate is reviewed quarterly for resetting. The contract may be terminated by the Plan or the contract issuer with 75 days notice. Upon contract termination, liquidation of the investment at contract value is subject to a holding period of either 12 months or 36 month as determined by the contract terms and is payable in 20 quarterly installments.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**(7) Income Tax Status**

The Plan is based on and has adopted the non-standardized pre-approved profit sharing plan, which received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service (the IRS), that the pre-approved plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for the Plan. The Company believes the Plan, as adopted and amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC.

#### (7) Income Tax Status - Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (8) Party-In-Interest Transactions

Certain plan investments are funds managed by Empower Annuity Insurance Company of America, the custodian of the Plan, therefore these transactions qualify as party-in-interest transactions. Notes receivable from participants are managed by Empower Trust Company, LLC. For the years ended December 31, 2024 and 2023, expenses paid by the Plan amounted to \$38,000 and \$44,000, respectively, for contract administration, investment management, and recordkeeping fees. These transactions qualify as party-in-interest transactions; however, they are expressly exempt from prohibited transaction rules.

#### (9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### (10) Delinquent Participant Contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. The Company failed to remit \$1,352 of employee contributions and loan repayments to the Plan for the year ended December 31, 2023. While the Company has remitted the principal amount of these delinquent employee contributions, the Company did not remit the lost earnings owed to the Plan until September 2025.

#### (11) Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Company modified its contributions to include an automatic contribution arrangement in which employees eligible to participate in the Plan will be automatically enrolled into salary deferral starting at 3% of plan compensation, increasing 1% each plan year not exceeding 10% of plan compensation. The automatic contribution arrangement has a 90 day opt-out period which includes a refund of all contributions withheld.
