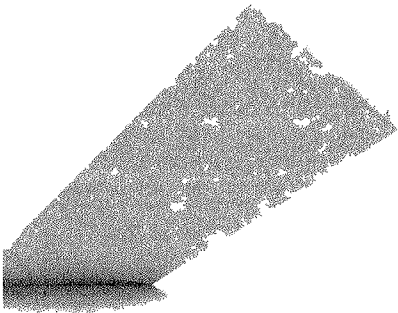

## Notes to Financial Statements

### Note 1: Description of Plan

The following description of the Overland Solutions, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan became effective on March 1, 2003, and is a defined contribution plan covering eligible employees, as defined in the Plan document of Overland Solutions, Inc. (the "Company") The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Eligibility

Employees who have three months of service and who have attained age 21 may enter the Plan on the first day of the following month. The Plan excludes leased employees, union employees, and nonresident aliens.

#### Contributions

Each year participants may contribute between 1% and 60% of their compensation as pre-tax contributions or Roth contributions, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. In addition, certain eligible employees, as defined by the Plan, are eligible to make catch-up contributions, in accordance with IRC Regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company's matching contribution is discretionary and is determined by the Company with respect to each Plan year. Eligible employees must be employed on the last day of the Plan year in order to receive the discretionary match, if any. The Company declared a matching contribution equal to 25% of the first 6% contributed for the 2024 Plan year. Rollover contributions are not eligible to be matched.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's discretionary matching contributions, and allocations of Plan earnings, and is charged with withdrawals and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Note 1: Description of Plan (Continued)**

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant vests 25% each year, and is 100% vested after four years of credited service. Participants who reach normal retirement age, die, or become totally or permanently disabled, as defined by the Plan, while employees of the Company are considered 100% vested in the Company contributions, regardless of their length of service.

#### **Investment Options**

Participants direct their contributions and Company contributions into various investment options offered by the Plan. The Plan offers mutual funds and a common collective trust fund as investment options for participants.

#### **Forfeitures**

Forfeited nonvested accounts at December 31, 2024 and 2023 totaled \$3,273 and \$2,913, respectively. These accounts may be used to reduce administrative expenses of the Plan and future employer matching contributions in accordance with the plan document. During 2024, forfeitures of \$7,359 were used to reduce administrative expenses and no forfeitures were used to off set employer contributions.

#### **Notes Receivable From Participants**

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with prevailing rates of interest charged on similar commercial loans by persons in the business of lending money and are determined by the Administrator. Principal and interest is paid ratably through payroll deductions, over a period of up to five years, with extended terms if secured by a participant's principal residence.

#### **Payment of Benefits**

Participants (or a participant's beneficiary in the event of death) who leave the Company as a result of termination due to death, retirement, permanent disability, or attainment of age 59 1/2 may receive the vested interest in their account in one lump-sum payment. Participants may also rollover their account to an individual retirement account or another qualified employer plan or elect to defer distribution until age 65. In addition, hardship withdrawals are permitted if certain criteria are met.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net realized gains and losses and unrealized appreciation or depreciation in fair value of investments is reported in the statement of changes in net assets available for benefits as net appreciation/depreciation in the fair value of investments. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses and Investment Management Fees**

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Certain fees incurred by the Plan for investment-related services are allocated proportionately to plan participants based on their respective account balances and are included in net investment income, as they are paid through revenue sharing rather than direct payment. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

#### **Notes Receivable From Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust fund and Common collective trust funds:* Valued at the NAV of units of the collective trust. The NAVs, as provided by the trustee, are used as a practical expedient to estimate fair value. The NAVs are based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no restrictions as to the redemption of these funds or unfunded commitments at December 31, 2024 and 2023. Were the Plan to initiate full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### **Note 4: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the Trustee of the Plan.

### **Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 6: Tax Status**

The Company adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8: Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity, the Plan's Trustee, and therefore these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Direct fees incurred and paid by the Plan for administrative expenses amounted to \$12,633 during the plan year ended December 31, 2024.

The Plan also participates in a revenue credit program with the Trustee, whereby participants may receive credit for excess recordkeeping revenue that the Trustee receives in connection with plan services when that revenue exceeds the agreed-upon compensation the Trustee is to receive. These revenue credits are allocated to eligible participants based on their respective account balances and are reflected in net investment income. Revenue credits received from Fidelity amounted to \$20,566 for the year ended December 31, 2024.

PNC Bank, NA ("PNC") is the investment advisor for the Plan and, therefore, fees paid to PNC also qualify as party-in-interest transactions. Fees paid directly by the Plan to PNC for investment management services amounted to \$13,750 for the year ended December 31, 2024. These fees are allocated to eligible participants based on their respective account balances and are reflected in net investment income.

Wipfli LLP ("Wipfli") is the auditor for the Plan and, therefore, fees paid to Wipfli also qualify as party-in-interest transactions. Fees paid directly by the Plan to Wipfli for audit services amounted to \$13,950 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA
