Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of plan

The following description of the Reliable Medical Supply, LLC 401k Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Reliable Medical Supply, LLC (the "Plan Sponsor") and all members of the controlled group (collectively, the "Employer"). The Plan covers substantially all employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective March 17, 2023, participant balances in the aggregate amount of \$645,424 of the employees of Hometown Medical Supplies, LLC, a Company acquired by the Plan Sponsor during 2022, were transferred into the Plan. The net assets transferred were recognized in the participants' accounts of the Plan as previously carried in the accounts of the ADP TotalSource Retirement Savings Plan, a multi-employer plan in which the participants previously participated as managed by a professional employer organization.

Effective April 11, 2023, participant balances in the aggregate amount of \$5,750,086, including notes receivable from participants, of the employees of Orbit Medical, LLC, a wholly-owned subsidiary of the Plan Sponsor, were transferred into the Plan. The net assets transferred were recognized in the participants' accounts of the Plan as previously carried in the accounts of the G&A Partners, Inc. Multiple Employer 401(k) Plan, a multi-employer plan in which the participants previously participated as managed by a professional employer organization.

Effective February 26, 2024, participant balances in the aggregate amount of \$113,335, including notes receivable from participants, of the employees of Capstone Medical, LLC, a wholly-owned subsidiary of the Plan Sponsor, were transferred into the Plan. The net assets transferred were recognized in the participants' accounts of the Plan as previously carried in the accounts of the Capstone Medical 401(k) Plan.

(b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employer makes a safe-harbor matching contribution equal to 100% of participant contributions up to 3% of compensation plus 50% of participant contributions between 3% and 5% of compensation. The Employer may also make discretionary nonelective contributions each year. No nonelective contributions were made for 2024 or 2023.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions, Employer safe-harbor matching, nonelective contributions, and allocations of investment earnings (losses) and administrative expenses. Allocations are based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective salary deferrals plus actual earnings (losses) thereon and safe-harbor matching contributions.

(e) Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants are secured by the balance in the participant's account and bear interest at fixed rates ranging from 4.50% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service a participant is entitled to receive payment for the vested interest in his or her account in the form of a lump-sum payment, direct rollover or installments. On termination of service due to death or permanent disability, a participant is automatically fully vested in his or her account. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document and to those participants that have attained age 59½.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Employer nonelective contributions. Such forfeitures may be used to reduce the Employer future contributions to the Plan.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Transaction expenses are charged directly to the participants' accounts and are included in administrative expenses. Fees incurred by the Plan for recordkeeping and investment management services are included in net appreciation in fair value of investments. Revenue sharing is included in administrative expenses.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by Reliance Trust Company, Transamerica Financial Life Insurance Company Inc. and Transamerica Trust Company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after the reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and October 7, 2025 which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Information related to investments and notes receivable from participants presented and disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, Transamerica Financial Life Insurance Company Inc. and Transamerica Trust Company.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Money market fund and mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end based on quoted prices in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a non-standardized profit-sharing plan, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

(6) Untimely remittance of participant contributions

The Plan Sponsor is required by Department of Labor regulation to remit participant contributions as soon as practicable, but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. Certain contributions withheld during 2023 were not remitted timely. Imputed lost earnings applicable to these untimely remittances will be calculated and contributed to the Plan.

(7) Party-in-interest transactions

The Plan's investments consist of a money market account and mutual fund which are managed by Transamerica Financial Life Insurance Company Inc., and therefore related transactions qualify as party-in-interest transactions. As described in Note 1, the Plan paid expenses to various service providers and holds notes receivable from participants which also qualify as party-in-interest transactions.

The Plan has a revenue-sharing agreement, as described in Note 1, whereby Transamerica returns certain revenue sharing amounts to offset the Plan's administrative expenses or allocate to eligible Plan participants. Future Plan expenses can be paid from any excess remaining revenue sharing amounts. The revenue sharing transactions are considered exempt party-in-interest transactions.

(9) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(10) Subsequent events

Effective January 1, 2025, the Plan was amended to replace the Employer safe harbor matching contribution with an Employer matching contribution under which the Employer will contribute an amount equal to 100% of eligible participant contributions up to 3% of eligible compensation plus 50% of participant contributions between 3% and 5% of eligible compensation up to a maximum matching contribution of \$3,000 per participant per year. Participants become eligible for the Employer matching contribution after one year of eligible service and are 100% vested in the Employer matching contribution.
